

2. It shall be lawful for any authorised person to cause persons infected with cholera in any house or place hereunder described to be removed to some public hospital or other place provided by Government:—

- (1) In any house or place in which goods are exposed for sale.
- (2) In any house or place of public resort.
- (3) In any building in which there are no means of isolating the patients from the other inmates, or in any building where the retention of the patient is likely to prove a source of danger to others.

Provided that it shall be competent for any such authorised person as aforesaid, in case the removal of any person so infected in any house or place in which goods are exposed for sale is objected to, and the house or place is not otherwise open to objection, to allow the patient to be retained, on condition, however, that the sale of goods shall not be carried on in such house or place during such time as any person shall remain so infected in such house or place.

Provided further, that it shall be lawful for any such authorised person as aforesaid to allow any patient to be removed to any locality which such patient or his or her friends may choose, and to which the Medical authorities of the town or place, if any, do not object, instead of to the public hospital or place provided by Government.

3. Except as provided by these regulations, and except as provided by the said Ordinance No. 8 of 1866, it shall not be lawful for any person to remove or assist in removing any person suffering from cholera from the house or place in which such person shall be to any other house or place, without the sanction in writing of some duly authorised person.

4. These regulations shall come into operation from the date hereof, and shall continue in force until December 31, 1892, or to such other time as the Governor, with the advice of the Executive Council, shall extend the same.

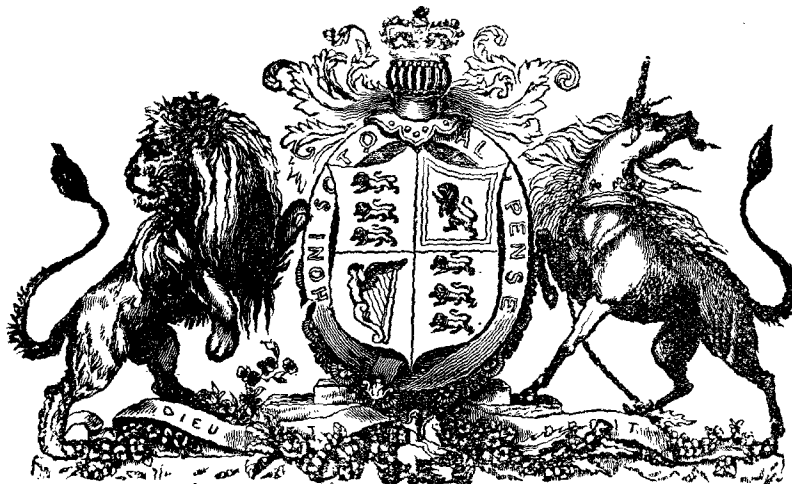

## GOVERNMENT NOTIFICATIONS.

**T**HE following rules for the investment of the surplus funds of the Public Service Mutual Provident Association have been approved by the Governor in Executive Council, and are published for general information.

Rules for the investment of the Surplus Funds of the Public Service Mutual Provident Association, to the extent of one-third, among the Members.

1. It shall be competent to the Committee of Management to make loans to Members of the Association on the security of landed property situated within the Municipal limits of Colombo.
2. Any Member desirous of obtaining a loan from the Association must apply by letter to the Secretary of the Association stating the amount required and the nature of the security which he proposes to offer. He must at the same time forward the title deeds of the property to be mortgaged, the fee for legal opinion as to validity of the deeds, and appraisers' fees.
3. The Secretary shall submit the application to the Committee of Management together with the opinion of the legal adviser and the report of the appraisers, for the decision of the Committee as to the propriety of granting the loan.
4. No loans shall in any case exceed one-half of the appraised value of the property or properties tendered as security.
5. The rate of interest to be charged on loans shall be 6 per cent. per annum.
6. One-sixth of the interest so recovered shall form a Reserve Fund to cover any losses; but it shall be lawful to the Corporation at any General Meeting, when the amount to the credit of the Reserve Fund shall exceed one-tenth of the amount outstanding on loans, to authorise the transfer of any portion of such excess to Profit and Loss Account.
7. Two appraisers shall be appointed by the Committee of Management from among the Members of the Association, one of whom shall not be serving on the Committee, to value the properties offered as security; and their valuation shall be affirmed or sworn to.

8. The fees to be paid for appraisement shall be half per centum on the amount lent.
9. The necessary mortgage bond shall be prepared and attested by the Notary appointed by the Committee of Management, and all expenses attending the legal completion of the loan shall be borne by the borrower.
10. Interest shall be payable monthly. No notice of the interest due will be given. In no case shall arrears of more than three months be allowed to accrue. The principal may be reduced by repayments of not less than Rs. 20.
11. At the commencement of every year all bonds will be reconsidered by the Committee of Management with reference to the then state and value of the property mortgaged, and if it be thought necessary the Committee shall depute one of its Members to inspect and report upon the state and value of properties mortgaged. The expense, if any, of such inspection shall form part of the working expenses, and be paid from the funds of the Association.

NOTICE is hereby given, in pursuance of the first clause of the Ordinance No. 9 of 1842, that all dogs not being led or carried, which shall be found in any thoroughfare or public place at Welimada, Dikwella, and Palugama, from the 6th to the 16th instant, both days inclusive (the intervening Sunday excepted), will be destroyed, and that a reward of twenty-five cents will be paid for each dog so destroyed. 

SIR,—I HAVE the honour to transmit to you, for the information of the Colony under your Government, the accompanying copy of an Order of Her Majesty the Queen in Council, providing for the exchange of light gold coins under the Coinage Act, 1891.

I have to request that you will take steps to publish this Order in the usual manner in the Colony under your Government.

PRESENT :

The **QUEEN'S** Most Excellent Majesty in Council.

**WHEREAS** by the Coinage Act, 1891, it is enacted as follows :—

“(1) It shall be lawful for Her Majesty, by Order in Council, to direct that gold coins of the realm which have not been called in by Proclamation and are below the least current weight as provided by the Coinage Act, 1870, shall, if they have not been illegally dealt with, and subject to such conditions as to time, manner, and order of presentation as may be mentioned in the Order, be exchanged or paid for by or on behalf of the mint at their nominal value :

“(2) For the purposes of this Act a gold coin shall be deemed to have been illegally dealt with where the coin has been impaired, diminished, or lightened otherwise than by fair wear and tear, or has been defaced by having any name, word, device, or number stamped thereon, whether the coin has or has not been thereby diminished or lightened :”

And whereas it is expedient to provide for the exchange of such gold coins :

Now therefore, Her Majesty, by and with the advice of Her Privy Council, in pursuance of the said Act, and of all other powers enabling Her Majesty in this behalf, is pleased to order, and it is hereby ordered as follows :

Any gold coins of the realm which have not been called in by Proclamation, and are below the least current weight as provided by the Coinage Act, 1870, shall at any time after the Seventeenth day of March, 1892, if they have not been illegally dealt with, be exchanged or paid for by or on behalf of the mint at their nominal value, subject to the condition that they must be tendered during business hours at the Bank of England in London, in parcels of a nominal value not less than one hundred pounds each, and must be left there for such time before the exchange or payment as may be reasonably necessary for examination and weighing, in order to ascertain whether any coin has been illegally dealt with within the meaning of the said Act.

And the Master of Her Majesty's Royal Mint is hereby directed to carry into effect the provisions of the said Act for exchanging or paying for at their nominal value all such coins as are so tendered, and have not been illegally dealt with.
