## ABSTRACTS OF SEASON REPORTS.

### SEASON REPORTS FOR THE MONTH OF FEBRUARY, 1914.

#### NORTH-WESTERN PROVINCE.

##### PUTTALAM AND CHILAW DISTRICTS.

Paddy : maha crop is being harvested. Some fields were damaged owing to want of water.

Dry grain : very unsatisfactory owing to drought.

Other products, including coconuts : flowering and prospects of coconuts are not satisfactory for want of rain.

The estimated crop in the two districts for the month is 18,337,276 nuts. Tobacco plants are in good condition. Fruits and vegetables scarce.

Prices of staple products : rice, Rs. 5 to Rs. 7.50 per bushel ; paddy, Rs. 2 to Rs. 2.25 per bushel ; kurakkan, Re. 1.25 to Rs. 2.25 per bushel ; salt, 4 cents to 5 cents per pound ; cassava, Re. 1.50 per cwt. ; coconuts, 6 cents to 8 cents per nut.

Rainfall of the month : Puttalam, .28 in. ; Chilaw, .15 in.

Harvest prospects generally : not satisfactory for want of sufficient rain.

Health of inhabitants : fever is prevailing to a great extent. Usual parangi in Demala hatpattu.

Health of cattle : rinderpest is on the decrease.
