Minute by the Governor.

His Excellency the Governor, being desirous of putting an end to the unsystematic deformity with which Sinhalese and Tamil words are generally represented by means of English letters in official correspondence and other public documents, has been pleased to direct that the following rules be observed in future by all Public Officers :—

- (1) When native names or terms are introduced into official correspondence, they should be expressed in Roman characters according to the accompanying scheme, which is based on the system originally recommended by Sir William Jones, and since adopted, with partial variations, by Professor Wilson in his *Glossary of Indian Official Terms*, and by most Oriental scholars.
- (2) No letters should be introduced into any native word which do not exist in the original; and those which do exist should be expressed strictly in accordance with the scheme, which is one of strict transliteration, and, consequently, only one Roman equivalent is provided for each of those Tamil letters which are liable to changes of sound with reference to their position: and for the same reason it is not necessary to adopt diacritical marks to distinguish the full and the half sounds of conjunct consonants in Sinhalese.
- (3) The only exception from this rule should be in the case of the names of particular *places* which have become stereotyped by long usage in a conventional form, such as Colombo, Jaffna, Negombo, Trincomalee, &c., but in all cases the common affixes should be accurately rendered: thus in Sinhalese names, gala, galla, gama, goda, tota, &c., should be adopted, instead of galle, galle, gamme, godde, totte, &c., and in Tamil, cheri, palli, úr, pur, &c., instead of cherry, poly, ore, pore.

The Governor desires that special attention be paid to these instructions by all Heads of Departments, and more particularly by the Revenue Officers in notices of sales of Crown lands, and in submitting applications for title deeds; by the Surveyor-General, in advertisements of sales of Crown lands, and in plans, maps, &c.; by the Public Works Department, in estimates, &c.; by the Registrar-General, in certificates, indices, &c.; and by all Judicial Officers in the proceedings and process of the courts.

Lists showing the correct spelling of the principal names, &c., in ordinary official use will be published as soon as the necessary type can be procured; in the meantime the following examples are given to illustrate the effect of the prescribed scheme :—

Bay of Bengal—Burma Coast.—Alteration in the Colouring of Buoys, Port of Rangoon.

The Port Officer of Rangoon, through the Director of the Royal Indian Marine, has given notice that in accordance with the system agreed upon by the Washington Buoyage Conference, the Deputy Conservator of the Port of Rangoon has intimated that the alteration in the colouring of the buoys under his charge, that is, from the Fairway buoy off the China Buckeer lighthouse to Rangoon town, is being effected.

Indian Ocean—Seychelles Bank.—Shallow Water on the Western edge.

The British Admiralty has given notice (No. 157 of 1892) that a recent examination of the western edge of the Seychelles bank, conducted by Lieutenant and Commander Sayth, H. M. surveying vessel Stork, shows that a nearly continuous rim, of more or less shallow water, extends from Bird Island to beyond the western point of the bank.

As it is evident that dangerously shoal spots may exist in many parts of this rim, besides those already known, ships should avoid crossing it north of the fifth parallel of south latitude. Southward of this parallel there is, according to the scanty information existing, apparently a break in the rim.

The Ceylon Savings Bank.

THE Trustees and Managers of the Ceylon Savings Bank, under authority of the Savings Bank Ordinance, No. 12 of 1859, hereby summon a Special General Meeting of Depositors in the Ceylon Savings Bank, at the Council Chamber on Saturday, June 25, 1892, at 2 P.M., for consideration of the suggestions conveyed to them by Government, as set forth in the following letter from the Hon. the Colonial Secretary.

Colonial Secretary's Office, Colombo, March 17, 1892.

SIR,—IN connection with my letter of the 20th January last, on the subject of the investment of the funds of the Ceylon Savings Bank, and with your reply thereto No. 1 of the 28th of the same month, forwarding a copy of the resolutions passed at a meeting of the Trustees of the Bank specially convened to consider it, I am directed by the Governor, after taking the advice of the Executive Council, to state for the information of the Trustees of the Ceylon Savings Bank, that the subject of the proper mode of investing the Bank funds, which constitutes so material and fundamental a part of the management of a bank, has been again under the consideration of the Government.

2. It will be within the knowledge of the Trustees and Managers that it was contemplated in 1883 to amend the 23rd section of Ordinance No. 12 of 1859, in order to extend the scope of investment in some directions and to restrict it in others, and probably to make other substantial amendments in the law. Action was then deferred owing to personal circumstances in the changes of office. The Government, however, from time to time, in excess of their strict powers and outside of their legal responsibility, but with the desire to promote and assist the good management of the Bank, have interfered with their advice as to the investment of funds. This advice, it is readily acknowledged, has been accepted and acted on by the Trustees and Managers, though not always altogether in agreement with their own views, which were disposed towards other investments giving a higher rate of interest and avoiding the risk of reduction of the rate to Depositors.

3. The connection of the Government with the Bank in the constitution of its officers has probably induced persons to deposit their savings, and has thrown on the Government a moral responsibility as well as a consequent liability from which it can hardly escape. This responsibility and liability, which must fall on the general taxpayer in the event of its being invoked or enforced, naturally compels the Government to be more cautious in the influence and control which it exercises as to the mode of investment of funds, and to restrict itself to such investments as are customarily permitted to banks under purely Government management. The anomaly of liability without actual control calls for an amendment of the law, which must to a considerable extent have the effect of transferring the management to the Government. At the same time, it is readily admitted that the Ceylon Savings Bank has been conducted with signal success; and that with its greater freedom of mode of investment, it has been able to pay to Depositors a higher rate of interest than the caution in investment enjoined on a Government Bank would allow to be continued.

4. There therefore, arises the question which calls for settlement, whether the connection of the Government with the Bank, with the inevitably consequent liability and control on the part of Government, should in any way be continued, or whether the Trustees and Managers should receive their powers and authority, as well as their appointment or election, from the Depositors, and should be at uncontrolled liberty to invest their funds without those restrictions which are placed on a Government. But before arriving at a decision on the question I am to say that it is desired to consult those interested in the Bank; and for this purpose I am to request you to suggest to the Managing Body to summon a Special Meeting of Depositors to consider the question under section 12 of the Ordinance No. 12 of 1859.

5. The alternative should be clearly put before the Depositors. On the one hand there would be the continuance of Government responsibility with greater security of investment, which is considered only fair to the general taxpayer who may be called upon to make good any loss arising from more independent investment, with the greater control on the part of Government, which may practically amount to an entire assumption of management and with a consequent reduction of interest on their deposits. On the other hand, there would be an entire severance from Government control, as well as responsibility and liability, leaving them to have their deposits invested by their own elected Managers and Trustees.

6. The views of the Depositors at or after such a meeting should be ascertained according to number of Depositors, as well as to amount deposited. If the majority of depositors should elect the latter alternative, any dissentients can join the Post Office Savings Bank.

7. In making this proposal the Government desires it to be distinctly understood that there is no want of confidence in the past management of the Bank, and that the suggestion proceeds solely on the resolution to adopt a precautionary principle.

2. It shall be lawful for any authorised person to cause persons infected with smallpox in any building where the detention of the patient is in the opinion of the Municipal Sanitary Officer or of any Government Medical Officer likely to prove a source of danger to others, to be removed to some public hospital or other place provided by Government.

Provided that it shall be competent for any such authorised person as aforesaid, in case the removal of any person so infected in any house or place in which goods are exposed for sale is objected to, and the house or place is not otherwise open to objection, to allow the patient to be retained, on condition, however, that the sale of goods shall not be carried on in such house or place during such time as any person shall remain so infected in such house or place.

Provided further, that it shall be lawful for any such authorised person as aforesaid to allow any patient to be removed to any locality which such patient or his or her friends may choose, and to which the Medical authorities of the town or place, if any, do not object, instead of the public hospital or place provided by Government.

3. An authorised person shall have power, in the event of the patient remaining in the infected house, to require the inmates of the said house (with the exception of not more than two who may elect to remain in attendance upon the patient) forthwith to take up their residence in a house of isolation, and remain there for such period (not exceeding fourteen days) as the Municipal Sanitary Officer or any Government Medical Officer may direct.

4. Any person having once taken up his residence in a house of isolation shall not quit the premises even momentarily until the expiration of the time prescribed, except with the permission in writing of the Municipal Sanitary Officer or any Government Medical Officer.

5. Except as provided by these regulations, and except as provided by the said Ordinance No. 8 of 1866, it shall not be lawful for any person to remove or assist in removing any person suffering from smallpox from the house or place in which such person shall be to any other house or place, without the sanction in writing of some duly authorised person.

6. It shall be lawful for any authorised person to prohibit the removal for interment of the corpses of persons who have died of any contagious disease along any particular thoroughfare, and to prescribe the thoroughfares leading to the place of interment along which such corpses shall be carried. Information of such prohibition shall be given by notice in writing under the hand of some authorised person, which shall be posted in two or more conspicuous places in the prohibited thoroughfare, and by publication in such other way as may be deemed necessary by such authorised person.

7. These regulations shall come into operation from the 1st day of July, 1892, and shall continue in force until the 31st day of December, 1892, or to such other time as the Governor, with the advice of the Executive Council, shall extend the same.

WHEREAS by the 10th section of the Ordinance No. 8 of 1866, intituled "An Ordinance to provide against the spread of Contagious Diseases in this Island," it is enacted amongst other things that it shall be lawful for the Governor, with the advice of the Executive Council, from time to time to make such regulations or orders as may seem necessary or expedient to provide for the steps to be taken in reference to certain cases, and for the following objects amongst other things :—

In case of any infectious or contagious disease of a malignant nature, whether in man or beast, breaking out or spreading in any town or district of this Colony, under circumstances which render it advisable that measures should promptly be taken for securing the public health :

And whereas the disease of cholera has broken out and is spreading in the Province of Uva, under circumstances which render it advisable that measures should promptly be taken for securing the public health :

It is hereby notified that the following regulations have been made on the 15th July, 1891, by His Excellency the Governor, with the advice of the Executive Council, in pursuance of the power and authority vested in him under and by virtue of the said Ordinance No. 8 of 1866, and as applicable to the said Province: and the same are published for general information.

1. The following officers shall be deemed "authorised persons" under and for the purposes of carrying out these regulations in their respective towns, places, or districts as hereinafter specified:—

The Government Agent of the Province.
The Police Magistrate.
The Senior Officer of Police.
The Chairman of the Board of Health, or, in his absence, the Secretary of the Board of Health.
The Senior Medical Officer of the District.
Any Government Medical Officer of the District.

2. It shall be lawful for any authorised person to cause persons infected with cholera or other infectious or contagious disease in any house or place hereunder described to be removed to some public hospital or other place provided by Government:—

- (1) In any house or place in which goods are exposed for sale.
- (2) In any house or place of public resort.
- (3) In any building in which there are no means of isolating the patients from the other inmates, or in any building where the retention of the patient is likely to prove a source of danger to others.

Provided that it shall be competent for any such authorised person as aforesaid, in case the removal of any person so infected in any house or place in which goods are exposed for sale is objected to, and the house or place is not otherwise open to objection, to allow the patient to be retained, on condition, however, that the sale of goods shall not be carried on in such house or place during such time as any person shall remain so infected in such house or place.

Provided further, that it shall be lawful for any such authorised person as aforesaid to allow any patient to be removed to any locality which such patient or his or her friends may choose, and to which the Medical authorities of the town or place, if any, do not object, instead of the public hospital or place provided by Government.

3. Except as provided by these regulations, and except as provided by the said Ordinance No. 8 of 1866, it shall not be lawful for any person to remove or assist in removing any person suffering from cholera or other infectious or contagious disease from the house or place in which such person shall be to any other house or place, without the sanction in writing of some duly authorised person.


