- (iv) Should not be less than 18 years or not more than 45 years of age on the date of closure of applications. (this age limit will not be applicable for the permanent employees employed in the public service or provincial public service)
- (v) The maximum age limits will not be personnel applicable only for the employees who have been already recruited for a post in preliminary Technical, Semi Technical and Non Technical service on the basis of casual /substitute/contract.
