Paddy: the maha harvest was reaped during the month.

Dry grain: nil.

Other products—Coconuts: crop estimated at 2,500,000 nuts; flowering fair. Vegetables and fruits scarce, except in the Totamunes, where there was a fair supply.

Prices of staple products: rice, Rs. 5 to Rs. 6.50 per bushel; coconuts, Rs. 60 to Rs. 80 per 1,000 nuts.

Arrack: in wholesale warehouses, Rs. 550 per leaguer.

Remarks on harvest prospects generally: if the present dry weather continues, the yala harvest will be badly affected.

Health of people: good, except for a few cases of chickenpox. A case of plague was imported from Colombo to Maggona. The patient died. The sickness did not spread.

Health of cattle: good, except for a few cases of rinderpest in the Totamunes and Rayigam korale.
