NOTICE is hereby given that on Tuesday, June 2, 1914, at 1 P.M., the Government Agent, Southern Province, will put up to auction, at his office at the Galle Kachcheri, the right to dig for plumbago in the under-mentioned Crown lands in the Galle District, and supposed to contain plumbago, for a period of five years on the following conditions:—

(a) The lease will include the right of mining for plumbago only, and will be for a period of five years only at the yearly ground rent of Rs. 10 per acre per annum, and subject to the covenants and conditions as sanctioned by Government, copy of which can be obtained at the Kachcheri. The highest bidder for the lease of the above-mentioned allotment shall be the purchaser, provided that the price offered by him amounts at least to the upset price as stated against each lot in column 4.

(c) The purchaser shall pay to the Government Agent within one month of the date of sale the balance of the purchase money, and in failure thereof the purchase shall be considered void, and deposit of 10 per cent., together with any other sum paid on account of the land, shall be forfeited.

(d) On payment to the Government Agent within the time specified of the whole of the purchase money the Government Agent will grant to the purchaser a lease in the approved form, and the purchaser shall at the same time execute and deliver to the Government Agent a duplicate of such lease.

(e) Should any error or mistake hereafter appear in the description and admeasurement of the said land, the purchaser will not be entitled to claim any compensation or abatement of the price in respect thereof.

Conditions of the Sale of Ebony.

1. Ebony will be put up for sale at a rate per ton, and bids not less than Rs. 5 at a time will be accepted.
2. Any person to whom a lot is knocked down must pay at once 25 per cent. of the value of the timber if required, and the balance within twenty days from date of sale. On failure of payment within the time prescribed, the timber will be re-sold at the risk of the original purchasers, and if the price realized at the second sale is less than what was originally offered, the purchaser will be liable for the difference.

THE right to collect from May 1 to December 31, 1914, all dead and fallen ebony trees and branch wood lying in the Pankulam proposed reserve, in the Trincomalee District of the Batticaloa Division, will be sold by public auction by the Subdivisional Forest Officer, Trincomalee, at the Trincomalee Forest Office, at 2.30 P.M., on April 27, 1914.

2. Ebony will be sold by the cubic foot, and bids of less than 10 cents per cubic foot will not be accepted.

3. The highest bid will be subject to the approval of the Conservator of Forests, and the purchaser shall, immediately on his being declared the highest bidder, deposit a sum of Rs. 250 as security, and sign his name in the register of sale in admission of such bid by him.

4. Should the purchaser decline or fail to enter into an agreement within 10 days of receiving notice, in writing,

from the Subdivisional Forest Officer, Trincomalee, that his bid has been accepted by the Conservator of Forests, the deposit made by him as security shall be forfeited.

5. All the ebony collected must be brought to Pankulam and stacked there to enable it to be measured by a Forest Officer. No ebony will be allowed to be removed from this place before payment of the full amount due.

6. The right shall not be re-sold or sublet by the purchaser without the permission of the Assistant Conservator of Forests, Batticaloa Division, Batticaloa, obtained in writing.
