Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1908," declaring Lands to be Crown Property.

In the matter of the lands commonly called or known as Katuimbulemandiya, Liangahakoratuwa (reservation for road), situate in the village of Kadigamuwa, in the West Giruwa pattu of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."
