ABSTRACTS OF SEASON REPORTS.

SEASON REPORT FOR THE MONTH OF JUNE, 1914.

WESTERN PROVINCE.

COLOMBO DISTRICT.

Yala: paddy plants are thriving. Maha: preparations are been made for maha cultivation.

Dry grain: in Hapitigam and Hewagam korales a few chenas have been sown with kurakkan and el-wi.

Other products: (a) flowering and prospects of coconuts good; (b) vegetables and fruits at moderate prices; (c) coconuts from Rs. 45 to Rs. 70 per thousand.

Prices of staple products: imported rice, from Rs. 4.50 to Rs. 6.50 per bushel.

Rainfall: heavy showers during the month.

Remarks on harvest products: a good harvest is expected.

Health of inhabitants: generally good, excepting a few cases of chickenpox in Siyane Korale East and Salpiti korale, and a few cases of plague among Colombo people at Boralesgomuwa in the Colombo Mudaliyar's division.

Health of cattle: rinderpest and hoof-and-mouth disease in all the korales during the month.

KALUTARA DISTRICT.

Paddy : the paddy plants of the yala cultivation are thriving well.

Dry grain : nothing worth reporting.

Other products : (a) the supply of vegetables and fruits during the month was fair ; (b) the flowering of coconuts was satisfactory ; (c) the crop of coconuts for the month is estimated at 3,165,500 nuts.

Prices of staple products : rice, Rs. 5 to Rs. 6 per bushel ; coconuts, Rs. 60 to Rs. 80 per thousand nuts.

Remarks on harvest prospects generally : there is no harvest in the near future.

Rainfall at Kalutara : total, 11·34 in. ; average, ·37 in.

Health of people : generally satisfactory. Four cases of smallpox in Kalutara town.

Health of cattle : rinderpest and hoof-and-mouth disease existed in some villages.

CENTRAL PROVINCE.

KANDY DISTRICT.

Paddy, yala : transplanting in progress. Maha : ploughing.

Dry grains, yala : in plants. Maha : sowing completed (only in Tumpane).

Rainfall : sufficient.

Prospect of coconut crop : flowering fair. Estimated produce for the month of June, 1914 : Yatinuwara, 30,000 nuts ; Tumpane, 16,000 nuts ; Harispattu, 35,000 nuts ; Pata Hewaheta, 39,550 nuts. In other divisions the crop not ascertainable.

Prices of staple articles : paddy, Re. 1·75 to Rs. 2·25 per bushel ; kurakkan, Re. 1·50 to Rs. 2 per bushel ; rice, Rs. 5·75 to Rs. 6 per bushel ; salt, Rs. 3 per bushel ; coconuts, Rs. 6 to Rs. 10 per 100.

Health of people : health of the people is good, except in Yatinuwara, Pata Dumbara, Uda Dumbara, and Uda-palata divisions. There were a few cases of sore-eyes and fever in Yatinuwara, fever and chickenpox in Uda Dumbara, smallpox on Galhiriya and Hunnasgiriya estates in Pata Dumbara, and dysentery and fever in a few villages in Udapalata division.

Health of cattle : good, except in Uda Dumbara and Udapalata, where there was hoof-and-mouth disease, and Pata Hewaheta and Pata Dumbara, where there was rinderpest.

NUWARA ELIYA DISTRICT.

Rainfall : 10·91 in.

Paddy : maha cultivation fields in Uda Hewaheta and Walapane were harvested ; and yala cultivation fields in both these divisions and Kotmale are being ploughed.

Dry grains : no chena work. Applications for Crown chenas are being received.

Health of population : cholera broke out at Brookside and Kumbalgamuwa in the Walapane division. There were 21 cases, out of which 7 proved fatal and the rest recovered.
