WHEREAS the following by-law has been made by the Municipal Council of Kandy, under the provisions of section 109 (1) of the Municipal Councils Ordinance, No. 6 of 1910, and has been confirmed by the Governor of Ceylon in Executive Council, as provided by section 109 (3) of the said Ordinance:

Now know Ye that We, the said Governor of the Island of Ceylon, in exercise of the power in Us vested by section 109 (3) of the said Ordinance, do hereby proclaim the said by law.

CHAPTER XIII.

Public seats reserved for women not to be used by males.

221 BB. No male above the age of 12 years shall sit upon or make any use of any seat in any public place or recreation ground which is labelled "For women and children only." The burden of proving that he is under 12 years shall be on any person charged under this by-law.

Know Ye that We, the Governor of Ceylon, do hereby proclaim and publish the said amendments and additions to the said Rules, and do hereby declare that the said amendments and additions are in force in the Colony of Ceylon as and from the date of this Proclamation.

AMENDMENTS AND ADDITIONS REFERRED TO.

(1) Rule 3 of Order 28 is repealed as from the date of the coming into operation of the Order.

(2) In Order 29 following words are omitted:—

(a) In rules 1 and 3 the words "on motion."

(b) In rule 1 the words "form of notice of motion will be found in Appendix A, number 54."

(c) In rule 4 the words "by motion."

(3) The following new rules are added to Order 29:—

4 A. Notwithstanding anything contained in this order, the Court shall, on the request of the proper officer of the Crown, accept in lieu of payment into Court an undertaking in writing signed by the proper officer of the Crown for payment into Court on behalf of the Crown of the appraised value of the ship, or of the amount fixed under rule 4 of this order, as the case may be, at such time or times as the Court shall declare by order that the same or any part thereof is required for the purposes of payment out of Court.

4 B. Where in any case of requisition under this order it is made to appear to the Judge on behalf of the Crown that the Lords of the Admiralty desire to requisition the ship temporarily, the Court may, in lieu of an order of release, make an order for the temporary delivery of the ship to the Lords of the Admiralty, and subject as aforesaid the provisions of this order shall apply to such a requisition; provided that, in the event of the return of the ship to the custody of the Court, the Court may make such order as it thinks fit for the return to the Crown of the money paid into Court, or some or any part thereof, or the release of the undertaking given on behalf of the Crown or the reduction of the amount undertaken to be paid thereby, as the case may be; and provided also that, where the ship so requisitioned is subject to the provisions of Order 28, Rule 1, relating to detention, the amount for which the Crown shall be considered liable in respect of such requisition shall be the amount of the damage, if any, which the ship has suffered during such temporary delivery as aforesaid.

(4) Form No. 54 in Appendix A is repealed.

Order of His Majesty the King in Council.

Whereas by an Order of Her late Majesty Queen Victoria in Council, dated the 26th day of October, 1896, hereinafter called the Principal Order, it was provided that the said Order should apply and have effect in any of the Colonies specified in the schedule thereto in which it should be proclaimed by the Governor of the Colony, and should come into operation in each such Colony on being so proclaimed therein:

And whereas by an Order of His Majesty in Council dated the 20th day of August, 1914, the Principal Order was amended as therein mentioned:

And whereas it is expedient that the Principal Order should be further amended in manner hereinafter appearing:

Now, therefore, it is hereby ordered by His Majesty, by and with the advice of His Privy Council, as follows:—

I. The Principal Order is hereby amended by the insertion after the words "The Governor" at the beginning of Article III. (9) thereof of the words "may prohibit the export of from the Colony of any article or," and the said Order shall henceforth be read and construed accordingly.

II. This Order shall come into operation immediately, and shall apply to and have effect in any Colony in which the Principal Order has been proclaimed before the date hereof, as from the date of such Proclamation.

BY-LAWS REFERRED TO.

1. Every dairyman supplying milk within Local Board limits shall register his name and address and the names and addresses of his servants at the office of the Local Board. Every person selling or exposing for sale milk without such registration shall be guilty of an offence.
2. No dairy shall be allowed within 50 feet of any cesspit or latrine, nor in a position where bad odours wafted from any cesspit or latrine shall reach it.
3. Every dairy compound shall be provided with drainage to the satisfaction of the Chairman, and the drains shall be regularly flushed and kept clean; no foul water shall be allowed in a dairy compound.
4. All refuse and dirt in and about the premises of a dairy shall be removed without delay. Cowdung shall be removed daily from the cowshed and the dairy compound.
5. There must be a pure water supply at a convenient distance. No bathing or washing of clothes at a well in the dairy compound shall be allowed.
6. No building used as a dairy shall be used as a dwelling place or for any other purpose whatsoever; such building shall be kept clean at all times.
7. The milk cows must be free from any disease, and all dairymen must be free from any cutaneous, contagious, or infectious disease.
8. All utensils, furniture, and other requisites used in or belonging to a dairy shall be kept clean.
9. All vessels sent out containing milk shall be properly stoppered or covered with non-absorbing material, and shall not be carried under the armpit.
10. It shall not be lawful for any person to sell, hawk about, or expose for sale any milk which has been adulterated with water or any foreign substance whatever.
11. No person shall sell or offer for sale any milk from which the cream has been removed, unless he previously informs the person to whom he sells or offers it that the cream has been removed.
12. The Chairman, the Government Medical Officer of the station or his Assistant, or any Local Board Inspector may at any time demand and take for the purpose of analysis samples of any milk which is in possession of any person who is found selling, hawking, or exposing milk for sale, or from any premises registered as a dairy, and any person who refuses to permit samples to be taken shall be guilty of an offence.
13. Should any samples of milk taken for analysis prove to be adulterated, any dairyman or dairyman's servant from whose possession such sample was taken shall be deemed guilty of an offence.
14. The Chairman of the Local Board shall be at liberty to cancel the registration of any dairy in case of breach of any provision of these by-laws.

"THE MOTOR CAR ORDINANCE, No. 25 OF 1908."

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended October 3, 1914.

Births.—The total births registered in the city of Colombo in the week were 108 (1 European, 6 Burghers, 67 Sinhalese, 10 Tamils, 18 Moors, 2 Malays, and 4 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1914, viz., 243,089) was 23·2, as against 22·9 in the preceding week, 29·4 in the corresponding week of last year, and 24·4 the weekly average for last year.

Deaths.—The total deaths registered were 91 (12 Burghers, 39 Sinhalese, 25 Tamils, 9 Moors, and 6 Others). The death-rate per 1,000 per annum was 19·5, as against 24·2 in the previous week, 25·6 in the corresponding week of last year, and 28·0 the weekly average of last year.

Infantile Deaths.—Of the 91 total deaths, 20 were of infants under one year of age, as against 33 in the preceding week, 23 in the corresponding week of the previous year, and 31 the average of last year.

Stillbirths.—The number of stillbirths registered during the week was 4.

Principal Causes of Death.—Twenty deaths from *Phthisis* were registered, as against 18 in the previous week and 13 the weekly average for last year. Of these, 4 were in Maradana (including 2 deaths of non-residents in hospitals), 4 in New Bazaar, 3 in St. Paul's, 2 in Pettah, 2 in San Sebastian, 2 in Kotahena, 2 in Slave Island, and 1 in Wellawatta.

2. Seven deaths from *Pneumonia* were registered, as against 14 in the previous week and 15 the weekly average for last year. Of these, 2 were in Maradana (including 1 death of a non-resident in hospital), 2 in Slave Island, 1 in Fort, 1 in Kotahena, and 1 in Wellawatta. Five deaths from *Bronchitis* were registered.

3. Nine deaths from *Enteritis* were registered, 8 from *Debility*, 7 from *Infantile Convulsions*, 1 from *Dysentery*, 1 from *Worms*, and 33 from *Other Causes*.

4. No deaths from *Enteric Fever* were registered. There were 3 in the previous week.

5. No deaths from *Plague* were registered. There were 2 in the previous week. Two cases were reported, as against 8 in the previous week.

6. No deaths from *Smallpox* were registered. There were 2 in the previous week. Seven cases were reported, as against 25 in the previous week.

7. Sixteen cases of *Chickenpox* were reported, as against 5 in the previous week. No cases of *Measles* were reported.

State of the Weather.—The mean temperature of air was 80·4°, against 81·0° in the preceding week and 80·9° in the corresponding week of the previous year. The mean atmospheric pressure was 29·854 in., against 29·868 in. in the preceding week and 29·867 in. in the corresponding week of the previous year. The total rainfall in the week was 3·63 in., against 0·59 in. in the preceding week and 2·51 in. in the corresponding week of the previous year.
