41. (g) The liability of Government with regard to parcels and the conditions for the insurance of the same are shown in clauses 55 and 56.

The responsibility of Government for parcels terminates when 24 hours have expired after their arrival at the station to which they are consigned, and parcels not taken away within one month after their arrival will be sold by public auction to defray charges. If the parcels arrive at the station of delivery between 5 p.m. and 7 a.m., the latter hour will for the alculation of 24 hours be considered the hour of arrival.

For the disposal of undelivered perishable articles see clause 52.

## At the Court at Buckingham Palace, the 5th day of November, 1914.

#### . Present:

### The King's Most Excellent Majesty in Council.

Whereas, by virtue of the Convention of Defensive Alliance between Her Majesty Queen Victoria and His Imperial Majesty the Sultan signed on June 4, 1878, the Annex to the said Convention signed on July 1, 1878, and the Agreement signed on behalf of Her Majesty and His Imperial Majesty the Sultan on August 14, 1878, His Imperial Majesty the Sultan assigned the Island of Cyprus to be occupied and administered by England upon the terms and conditions specified in the said Convention, Annex, and Agreement:

And whereas by reason of the outbreak of war between His Majesty and His Imperial Majesty the Sultan the said Convention, Annex, and Agreement have become annulled, and are no longer of any force or effect:

And whereas it has, for the reasons hereinbefore appearing, seemed expedient to His Majesty that the said Island should be annexed to and should form part of His Majesty's Dominions, in order that proper provision may be made for the Government and protection of the said Island:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1. From and after the date hereof the said Island shall be annexed to and form part of His Majesty's Dominions, and the said Island is annexed accordingly.
- 2. Nothing in this Order shall affect the validity of any Instructions issued by His Majesty under the Royal Sign Manual and Signet to the High Commissioner and Commander-in-Chief of Cyprus, or of any Order in Council affecting Cyprus, or of any Law or Proclamation passed or issued under any such Instructions or Order, or of any act or thing done under any such Instructions, Order, Law, or Proclamation, save in so far as any provision of any such Order in Council, Law, or Proclamation may be repugnant to the provisions of any Act of Parliament which may, by reason of the annexation hereby declared, become extended to Cyprus, or to any Order or Regulation made under the authority of any such Act or having in Cyprus the force and effect of any such Act.
  - 3. His Majesty may from time to time revoke, alter, add to, or amend this Order.
  - 4. This Order may be cited as the Cyprus (Annexation) Order in Council, 1914.

#### VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended December 12, 1914.

Births.—The total births registered in the city of Colombo in the week were 125 (5 Europeans, 6 Burghers, 64 Sinhalese, 20 Tamils, 20 Moors, 8 Malays, and 2 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1914, viz., 243,089) was 26 8, as against 25 3 in the preceding week, 30 1 in the corresponding week of last year, and 24.4 the weekly average for last year.

Deaths.-The total deaths registered were 154\* (1 European, 4 Burghers, 87 Sinhalese, 28 Tamils, 25 Moors, 4 Malays, and 5 Others). The death-rate per 1,000 per annum was 32.4, as against 25.9 in the previous week, 32.5 in the corresponding week of last year, and 28.0 the weekly average of last year.

Infantile Deaths.—Of the 154 total deaths, 44 were of infants under one year of age, as against 21 in the preceding week, 47 in the corresponding week of the previous year, and 31 the average of last year.

Stillbirths.—The number of stillbirths registered during the week was 8.

Principal Causes of Death. - Seventeen deaths from Phthisis were registered, as against 23 in the previous week and 13 the weekly average for last year. Of these, 6 were in Maradana (including 2 deaths of non-residents in hospitals), 3 in Kollupitiya, 2 in San Sebastian, 2 in Kotahena, 2 in Wellawatta, 1 in St. Paul's, and 1 in Slave Island.

- Seventeen deaths from Pneumonia were registered, as against 8 in the previous week and 15 the weekly average for last year. Of these, 5 were in Maradana (including 1 death of a non-resident in hospital), 5 in Kotahena, 2 in New Bazaar, 2 in Wellawatta, 1 in San Sebastian, 1 in Slave Island, and 1 in Kollupitiya. Five deaths from Bronchitis were registered.
- 3. Six deaths from Smallpox were registered, as against 2 in the previous week. Of these, 2 were in Maradana, 2 (of non-residents) in the Infectious Diseases Hospital, Wellawatta, 1 in Slave Island, and 1 in Kollupitiya. Thirteen cases of Smallpox were reported, as against 4 in the previous week.
- 4. Five deaths from *Enteric Fever* were registered, as against 1 in the previous week and 3 the weekly average for last year. Of these, 3 were in Kotahena and 2 in Wellawatta.
- 5. Three deaths from Cholera, which occurred at the Lunatic Asylum in December, 1913, and escaped registration then, were registered this week.
- One death from Plague was registered, as against 2 in the previous week. Three cases of Plague were reported, as against 5 in the previous week.
- Fourteen deaths from Infantile Convulsions were registered, 13 from Debility, 10 from Enteritis, 5 from Worms, 3 from Dysentery, and 55 from Other Causes.
- 8. Eleven cases of Chickenpox were reported, as against 23 in the previous week. No cases of Measles were betrequer

State of the Weather.—The mean temperature of air was 79.8°, against 80.0° in the preceding week and 78.5° in the corresponding week of the previous year. The mean atmospheric pressure was 29.867 in., against 29.806 in. in the preceding week and 29.549 in. in the corresponding week of the previous year. The total rainfall in the week was 0.85 in., against 3.05 in. in the preceding week and 2.33 in. in the corresponding week of the previous year.
