### DRAFT ORDINANCES.

#### MINUTE.

The following Draft of a proposed Ordinance is published for general information:—

An Ordinance to amend "The Road Ordinance, 1861."

Preamble.

WHEREAS it is expedient to amend "The Road Ordinance, 1861": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Short title.

1 This Ordinance may be cited as "The Road (Amendment) Ordinance, No. . . . of 1915."

2 The following new paragraph shall be inserted in section 94 of the principal Ordinance immediately after the paragraph No. (2):

Interference with cattle seizers.

(2) A Whosoever shall remove any animal from the lawful custody of any person authorized to seize the same under paragraphs (1) and (2) hereof, or shall in any way molest or obstruct such person in the discharge of his duties.

*Statement of Objects and Reasons.*

THE object of this Ordinance is to give to cattle seizers who discharge their duty on public roads, the same protection as that which is enjoyed by other cattle seizers under "The Cattle Trespass Ordinance, 1876."

2. Cattle seizers have been held not to be public servants within the meaning of the Penal Code, and there is no provision under "The Road Ordinance, No. 10 of 1861," to protect them.

3. It is proposed shortly to deal with the question of cattle seizers in a consolidating Ordinance, but pending the introduction of that Ordinance it is proposed to amend the Road Ordinance for this special purpose.

4. The new provision goes slightly beyond that contained in section 12 of "The Cattle Trespass Ordinance, 1876," inasmuch as it protects cattle seizers against persons obstructing them in the discharge of their duties, as well as against persons seeking to take from them cattle lawfully seized.

**COUNCIL OF LEGAL EDUCATION.****The Incorporated Council of Legal Education.**

AT a Meeting of the Council of Legal Education held on Monday, October 19, 1914, rule 35 was amended by deleting the words—
