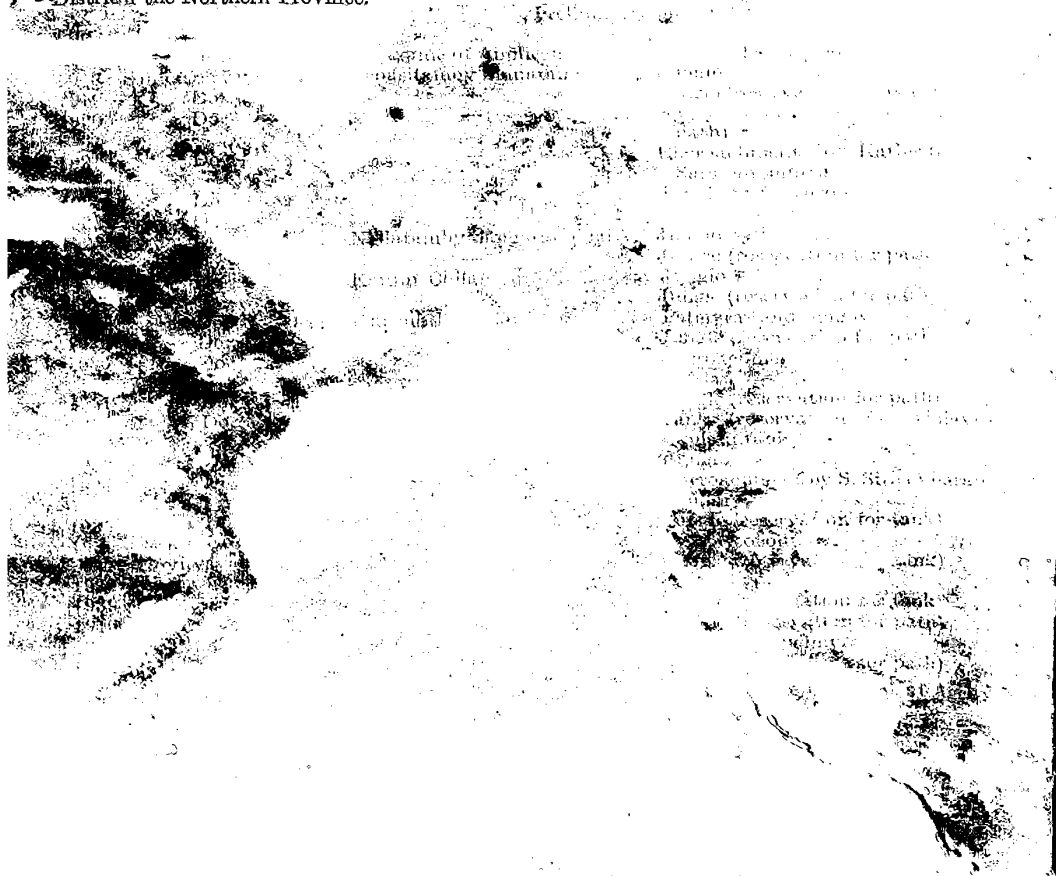

## ABSTRACTS OF SEASON REPORTS.

### SEASON REPORTS FOR THE MONTH OF OCTOBER, 1914.

#### WESTERN PROVINCE.

##### COLOMBO DISTRICT.

Maha: the paddy plants are thriving well. In some parts of Alutkuru Korale North the growth is rather backward owing to the drought. Yala: the crop has been reaped and threshed.

Dry grain: nil, excepting in Siyane Korale East, where amu have been sown in some parts of the district.

Other products: (a) fruits, such as oranges, pineapples, jak fruits, and breadfruits, are scarce; (b) vegetables are to be had in moderate quantities; (c) flowering and prospects of coconuts are generally satisfactory.

Price of staple products: (a) imported rice is sold at from Rs. 5 to Rs. 9 per bushel; (b) coconuts are sold at from Rs. 25 to Rs. 40 per thousand.

Rainfall: there was sufficient rain during the month.

Harvest prospects: generally fair.

Health of inhabitants: satisfactory, excepting a few cases of chickenpox in Siyane Korale East, Salpiti korale, Hewagam korale, and Colombo Mudaliyar's division, and a few cases of smallpox in Hewagam korale and Colombo Mudaliyar's division.
