GOVERNMENT NOTIFICATIONS.

NOTICE is hereby given that a Board appointed by His Excellency the Governor will sit on the 1st June, 1903, at the Council Chamber, for the purpose of opening and considering tenders for the purchase of the following Arrack Rents for the periods as stated:—

(1) *Southern Province*.—The Four Gravets of Galle and Akmimana; Talpe pattu, Wellaboda Gangaboda, and Hinidum pattus; Bentota-Walallawiti korale. For a period of one or two years from the 1st January, 1904.

(2) *North-Western Province*.—The Seven Korales (Kurunegala District). For a period of one or two years from the 1st January, 1904.

Tenderers who cannot speak English and wish to communicate with the Board must bring their own interpreters.

No tender will be considered unless the tenderer is present in person or by his authorized agent at the Council Chamber, and is prepared to deposit forthwith the amount of one month's rent as tendered by him.

In the event of two or more tenders being for an equal amount, the Board shall have the option of forthwith offering the rent for sale by public auction—the bidding to be restricted to the tenderers in question—or of calling for fresh tenders.

Purchasers of these rents will be allowed to sell arrack at any price not below Rs. 4.50 per gallon.

Rule referred to.

The person in immediate charge of a mine, whether owner, superintendent, or manager, shall make arrangements for information to be forthwith given to him whenever a charge of explosive has missed fire, and on such information being given to him he shall immediately (after four hours have elapsed) personally see that another hole is made not less than six inches from that in which the charge has missed fire, and that the second hole is thereafter immediately fired.

Transport of Liquefied Compressed Carbonic Acid Gas.

ON and after May 18, 1903, liquefied carbonic acid gas will be accepted at Colombo Terminus and Wharf Stations for conveyance by goods train at 3rd class rate, subject to the following conditions:—

- The liquefied compressed carbonic acid gas must be screwed in wrought iron cylinders or solid drawn steel flasks which have been tested under a pressure of 3,750 lb. per square inch without deformation, and must be re-annealed and re-tested after annealing every two years. By deformation it is to be understood that no sudden stretch occurs under testing in a water-jacket furnished with a gauge glass, and that the total external bulk of the cylinder or flask is not increased after test by more than 1 per cent.
- The valve should be protected by an outer metal cap screwed on to the head of the cylinder or flask.
- The cylinders or flasks should either be packed in separate boxes or be completely cased in a fibrous covering not less than half an inch thick.
- A cylinder or flask shall not contain more than two-thirds of a pound of carbonic acid for each pound of water capacity.
- The date, the letters "A and R, T 3,750 lb.," and a mark indicating the firm and individual responsible for such annealing and re-testing are to be stamped on the neck or shoulder of each cylinder or flask in order to indicate the date of re-testing and re-annealing. The weight of the cylinders when empty and when filled with gas to the extent prescribed must also be shown.
- All cases and packages containing carbonic acid gas must be clearly marked as such.
- No consignment of compressed gas in cylinders or flasks will be accepted for carriage by rail unless the consignor has signed a certificate (*vide* specimen form), which must accompany the consignment note.
- The returned empty cylinders and flasks will be conveyed at 4th class rate in accordance with the conditions stated in rule 38 of the Railway Goods Regulations.
- Every precaution must be taken against exposing the cylinders or flasks when charged with gas to excessive heat, either in wagons or by exposure to the direct rays of the sun, and they should be very carefully handled by the Railway staff.
