Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Four (4) allotments of lands in total extent of about 0.9525 Hectare, shown as Lot Nos. 1 to 4 in Advance Tracing No. CO/KDW/2015/298 of 10th July 2015 prepared by the Surveyor General, situated in the Village of Hewagama within the Divisional Secretary's Division of Kaduwela in Colombo District, Western Province and bounded as follows:

01. Lot No. 1 – Rukattanagaha Owita – Extent: 0.0464 Hectare

North: Avissawella Road; East: Rukattanagaha Owita claimant not known; South: Ela; West: Road.

02. Lot No. 2 – Land name not known – Extent: 0.0288 Hectare

North and East: Claimant and name of the land not known, land used for public Bus Stand; South: Claimant and name of the land not known, land used for public Bus Stand and cement drain; West: Lot No. 3, Ela and land called Malabadagahawatta claimed by Pilip Samarathunga and Nisha Perera.

03. Lot No. 3 – Hakuruge Kumbura and Owita – Extent: 0.4614 Hectare

North: Ela and Lot No. 02; East: Claimant and name of the land not known, land used for public Bus Stand and cement drain, name of the land not known claimed by Senarath Perera, Yasawathi and others; South: Name of the land not known, claimed by Senarath Perera, Yasawathi and others, Road and name of the land not known claimed by Senarath Perera; West: Road, Name of the land not known, claimed by Senarath Perera and Lot No. 4.

04. Lot No. 4 – Hakuruge Kumbura and Owita – Extent: 0.4159 Hectare

North: Bataketiya claimant not known and Ela; East: Ela and Lot No. 03; South: Lot No. 03, Name of the land not known, claimed by Senarath Perera; West: Name of the land not known, claimed by Senarath Perera, Bataketiya claimant not known and Ela.
