SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Malik Samarawickrama, Minister of Development Strategies and International Trade with the concurrence of the Minister of Finance, do by this Order declare that, the Cess shall be charged, levied and paid on import of every article specified in Column II and III of the Schedule hereto, corresponding to the import of every article specified under the following H. S. Headings mentioned in the Column I of the Schedule of the *Extraordinary Gazette* Notification No. 1941/33 dated 20.11.2015 issued under the Section 14(1) of this Act, shall be payable at the rate specified in the corresponding entry in Column IV of the Schedule hereto, with effect from 15th June 2016.
