THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below mentioned lands in total extent of about 2.1172 Hectares, depicted in Advance Tracing No. GAM/MIRI/2015/625 and dated 11.02.2016, prepared by the Gampaha District Surveyor-Superintendent on behalf of the Surveyor General situated in village of Hiripitiya in the Grama Niladhari Division No. 329 B Hiripitiya East in the Minor Division of Udugaha Pattuwa of Divisional Secretary's Division of Aththanagalla in the Gampaha District in Western Province and bounded as follows:
