In the matter of the land commonly called or known as Halpandeniyehena akas Gelkandehena, situate in the village of Udagama, in the Kinigoda korale of the Kegalla District, in the Province of Sabaragamuwa, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHENEAS in pursuance of soction 1 of the said Ordinances it was duly declared and notified on November 21, 1913, that if no claim to the land commonly called or known as Halpandeniyehena alice Galkandehena, situate in the villege of Udagama, in the Kinigoda korale of the Kegalla District, in the Province of Sabaragamuwa, containing in extent 3 rocds and 6 perches, and shown as lot 89 in preliminary plan 151, and in the annexed diagram, was made to Ralph Marcus Meeburn Worsley, Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown, and dealt with on account of the Crown (vide Notice No. 5,073): And whereas Ganarachchige Danasekers on behalf of minor Gangoda Mudiyanselage Punchi Appuhamy made claim thereto, and Ralph Marcus Meaburn Worsley, Special Officer appointed under section 28 of the said Ordinances, made due inquiry into such claim, and whereas the said claimant and the said Ralph Marcus Meaburn Worsley, Special Officer, came to an agreement in writing dated June 25, 1914, concerning the said land, under section 4, sub-section (1), of the said Ordinances, whereby it was agreed that the said minor Gangoda Mudiyanselage Punchi Appuhamy should be declared the purchaser of the said land upon payment on or before September 25, 1914, to the Assistant Government Agent at Kegalla or to the Settlement Officer, of a sum of Rupees Thirteen only (Rs. 13), as the purchase amount of the said land, and whereas the said amount has been duly paid by the said claiment, the said Gangoda Mudiyanselage Punchi Appuhamy is hereby, in pursuance of the agreement afore-mentioned, declared to be the purchase of the said land, as more fully described herein below.
