"N pursuance of the provisions of section 12 of the Ordinance No. 19 of 1907, intituled "An Ordinance to consolidate and amend the Laws relating to the Registration of Marriages, other than the Marriages of Kandyans or of Muhammadans," I, W. L. VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended May 22, 1915.

Births.—The total births registered in the city of Colombo in the week were 95 (1 European, 9 Burghers, 47 Sinhalese, 18 Tamils, 13 Moors, and 7 Malays). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1915, viz., 247,397) was 20·0, as against 23·6 in the preceding week, 26·6 in the corresponding week of last year, and 22·2 the weekly average for last year.

Deaths.—The total deaths registered were 104 (5 Burghers, 52 Sinhalese, 22 Tamils, 18 Moors, 2 Malays, and 5 Others). The death-rate per 1,000 per annum was 21 9, as against 21 3 in the previous week, 24 8 in the corresponding week of last year, and 26 7 the weekly average for last year.

Infantile Deaths.—Of the 104 total deaths, 29 were of infants under one year of age, as against 24 in the preceding week, 37 in the corresponding week of the previous year, and 27 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 3.

Principal Causes of Death.—Fifteen deaths from Phthisis were registered, as against 8 in the previous week and 14 the weekly average for last year. Of these, 4 were in St. Paul's, 3 in Kotahena, 2 in New Bazaar, 2 in Maradana, 2 in Slave Island, 1 in can Sebastian, and 1 in Wellawatta.

- 2. Eight deaths from *Pneumonia* were registered, as against 9 in the previous week and 11 the weekly average for last year. Of these, 5 were in Maradana (including 2 deaths of non-residents in hospitals), 1 in Pettah, 1 in Kotahena, and 1 in Slave Island. Five death from *Bronchitis* were registered.
- 3. One death of a non-resident in Maradana hospital was registered from *Enteric Fever*, as against 3 in the previous week and 2 the weekly average for last year.
- 4. Two deaths from Smallpox were registered (in Wellawatta), the same number as in previous week. Of these, 1 was of a vagrant in the Infectious Diseases Hospital, Wellawatta.
- 5. One death from *Plague* was registered in Slave Island.* There were none registered in the five preceding weeks. No cases were reported. There were 2 in the previous week.
- 6. Eleven deaths from Enteritis were registered, 11 from Infantile Convulsions, 9 from Debility, 2 from Worms, 2 from Tetanus, 1 from Dysentery, and 36 from Other Causes.
- 7. One case of Chickenpox was reported, as against 6 in the previous week. No cases of Measles were reported.

State of the Weather.—The mean temperature of air was 84.2°, against 85.7° in the preceding week and 83.3° in the corresponding week of the previous year. The mean atmospheric pressure was 29.847 in., against 29.760 in. in the preceding week and 29.890 in. in the corresponding week of the previous year. The total rainfall in the week was 0.05 in., against 0.73 in. in the preceding week and 1.03 in. in the corresponding week of the previous year.
