#### PASSED ORDINANCES.

Ordinance enacted by the Governor of Ceylon, with the advice and consent of the Legislative Council thereof.

#### No. 18 of 1915.

An Ordinance to amend "The Criminal Procedure Code, 1898."

ROBERT CHALMERS.

Preamble.

HEREAS it is expedient to amend "The Criminal Procedure Code, 1898": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Short title.

- 1 This Ordinance may be cited as "The Criminal Procedure Code (Amendment) Ordinance, No. 18 of 1915."
- Section added to the Criminal Procedure Code.
- 2 The following section shall be added to the Criminal Procedure Code, 1898—
  - 440A (1) In the following cases, that is to say—
  - (a) in the case of any offence under section 120 of the Penal Code (hereinafter, unless the context otherwise implies, referred to as "sedition"),

    (b) in the case of any other offence which by reason for the case of any other offence which by reason for the case of any other offence which by reason for the case of any other offence which by reason for the case of the case of
  - (b) in the case of any other offence which by reason for civil commotion, disturbance of public feeling, or any other similar cause, the Governor may consider to be appropriately triable in the manner in this section provided

(whether the offence was committed before or after the enactment of this section), the Governor may, by warrant under his hand, direct that the person charged shall be tried before the Supreme Court at Bar by three judges without a jury.

- (2) A trial under this section may be held either upon indictment or upon information exhibited by the Attorney-General and the limitations of section 385 shall not apply to an information so exhibited.
- (3) A trial under this section shall proceed as nearly as ossible in the manner provided for trials before the Supreme Court, subject to such modifications as may be ordered by the Court or as may be prescribed by Rules under this Code.
- (4) A person committed for trial under this section shall not be admitted to bail by the Police Magistrate except by the authority of the Attorney-General.
- (5) The Court, or the presiding judge thereof, may give directions for the summoning, arrest, custody, and bail of all persons charged before the Court by information.
- (6) In any trial for sedition under this section, notwithstanding anything contained in the Penal Code, the Court may impose any sentence which might be imposed on a conviction for sedition under the law for the time being in force in England:

Provided that in the case of any offence committed before the enactment of this section no greater sentence shall be imposed upon the person convicted than two years simple imprisonment or a fine.
