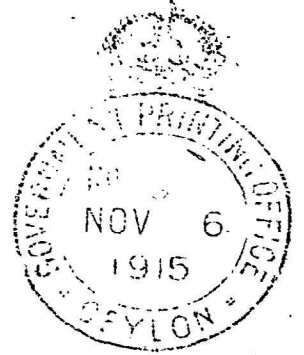
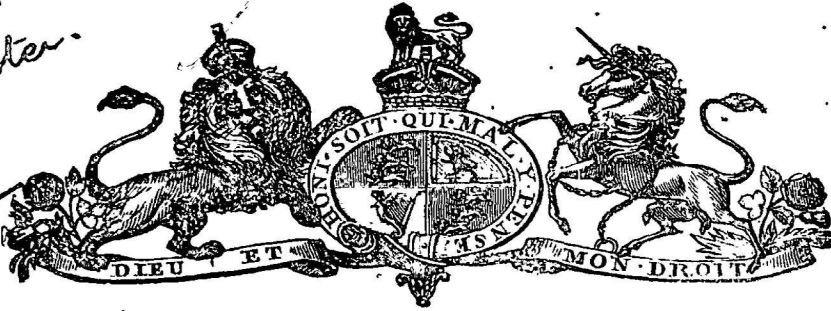

WHEREAS the following by-law made by the Municipal Council of Colombo, under provisions of section 109 (1) of "The Municipal Councils Ordinance, 1910," has been confirmed by the Governor in Executive Council, as provided by section 109 (3) of the said Ordinance:

Now know Ye that We, the said Governor of the Island of Ceylon, in exercise of the power in Us vested by section 109 (3) of the said Ordinance, do hereby proclaim the said by-law.

### BY-LAW REFERRED TO.

Every person proceeding on foot along a street shall keep to the pavement or footpath, if any, or where there is no pavement or footpath to the right hand side of the street. Any person who shall commit a breach of this by-law shall be guilty of an offence, and be liable on conviction to a fine not exceeding five rupees.

WHEREAS by section 1 of "The Dentists Registration Ordinance, No. 3 of 1915," it is enacted that the said Ordinance shall come into force at such date, not being less than six months after the passing of the said Ordinance, as the Governor, with the advice of the Executive Council, shall by Proclamation appoint:

And whereas the said Ordinance was passed in the Legislative Council on March 24, 1915, and was assented to by Us, the said Governor, on March 29, 1915:

Now know Ye that We, the said Governor, with the advice of the Executive Council, in exercise of the power in Us vested as aforesaid, do hereby appoint that "The Dentists Registration Ordinance, No. 3 of 1915," shall come into force as from and after January 1, 1916.

WHEREAS by section 4 (1) of Ordinance No. 3 of 1903, it is enacted that when it appears to the Governor, with the advice of the Executive Council, from time to time, that by reason of the existence or apprehension of crime and outrage in any district it is desirable to quarter police in such district, or should a Police Force have been already established there to increase the same, he may by Proclamation, which shall be published in the *Government Gazette*, declare that for the reason aforesaid such district requires police or additional police, and may order police to be quartered in such district or additional police be employed there:

And whereas it appears to the Governor, with the advice of the Executive Council, that by reason of the existence of crime and outrage in the district defined in the schedule hereunto annexed it is desirable to quarter police in the said district:

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby declare that by reason of the existence of crime and outrage therein the said district in the Western Province requires police, and do hereby order that a Police Force consisting of one sergeant and four constables be quartered in the said district in the said Western Province as from and after November 1, 1915.

And We do further hereby define the limits of the said district to be those set out in the schedule hereunto annexed.

Given at Colombo, in the said Island of Ceylon, this Thirtieth day of October, in the year of our Lord One thousand Nine hundred and Fifteen.

SCHEDULE.

The area within which the force should be quartered comprises the small town of Hanwella, in the Meda pattu of Hewagam korale, in the Colombo District. Bounded on the—

North by the Kelani-ganga.

East by a line drawn north and south through the culvert on the Colombo-Avissawella road over the Kupiawatte-ela from the Kelani-ganga to a point a quarter of a mile to the south of the Colombo-Avissawella road.

South by a line drawn westwards from the southern extremity of the eastern boundary to meet the southern extremity of the western boundary.

West by a line drawn north and south through the western boundary of the burial ground from the Kelani-ganga to a point a quarter of a mile to the south of the Colombo-Avissawella road.

WHEREAS it is desirable further to amend Our Proclamation issued in pursuance of "The Necessaries of War Exportation Ordinance, No. 19 of 1914," on the 24th day of September, published in the *Government Gazette* No. 6,745 of 8th October, 1915, and subsequently amended by Our Proclamation issued on the 26th day of October, in pursuance of the said Ordinance, published in the *Government Gazette* No. 6,751 of the 26th October, 1915:

Know Ye that We, the Governor of Ceylon, in pursuance of the said "The Necessaries of War Exportation Ordinance, No. 19 of 1914," do hereby amend the said Proclamation in the manner set out in the schedule hereto, and do call upon His Majesty's subjects and all other persons being in the said Island to govern themselves accordingly.

Chromium, compounds of, except bichromate of soda.
2. Item No. 16 shall be deleted, and the following item substituted therefor:—  
16. Coal, all kinds, and coke, excepting bunker coal.

40. Jute, raw; jute, yarns; and jute piece goods; jute webbing; and bags and sacks made of jute.

## VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended October 30, 1915.

*Births.*—The total births registered in the City of Colombo in the week were 81 (4 Burghers, 42 Sinhalese, 17 Tamils, 15 Moors, 2 Malays, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1915, viz., 251,338) was 18·8, as against 21·0 in the preceding week, 18·0 in the corresponding week of last year, and 22·2 the weekly average for last year.

*Deaths.*—The total deaths registered were 114 (5 Burghers, 66 Sinhalese, 27 Tamils, 9 Moors, 2 Malays, and 5 Others). The death-rate per 1,000 per annum was 23·7, as against 24·1 in the previous week, 27·2 in the corresponding week of last year, and 26·7 the weekly average for last year.

*Infantile Deaths.*—Of the 114 total deaths, 29 were of infants under one year of age, as against 33 in the preceding week, 30 in the corresponding week of the previous year, and 27 the average for last year.

*Stillbirths.*—The number of stillbirths registered during the week was 8.

*Principal Causes of Death.*—Eighteen deaths from *Phthisis* were registered, as against 15 in the previous week and 14 the weekly average for last year. Of these, 6 were in Maradana (including 4 deaths of non-residents in hospitals), 3 in San Sebastian, 3 in St. Paul's, 2 in New Bazaar, 2 in Slave Island, 1 in Pettah, and 1 in Wellawatta.

2. Nine deaths from *Pneumonia* were registered, as against 18 in the previous week and 11 the weekly average for last year. Of these, 3 were in Maradana (including 1 death of a non-resident in hospital), 2 in Pettah, 2 in Slave Island, 1 in Kotahena, and 1 in Wellawatta. 6 deaths from *Bronchitis* were registered.

3. Five deaths from *Plague* were registered, as against 3 in the previous week. Of these, 3 were in Pettah, 1 in St. Paul's, and 1 in New Bazaar. Five cases were reported, as against 8 in the previous week.

4. Four deaths from *Enteric Fever* were registered, as against 1 in the previous week and 2 the weekly average for last year. Of these, 1 was in St. Paul's, 1 in Maradana, 1 in Kollupitiya, and 1 in Wellawatta.

5. One death from *Smallpox* of a resident of New Bazaar was registered, as against 2 in the preceding week. Four cases were reported, as against 6 in the preceding week.

6. Fourteen deaths from *Infantile Convulsions* were registered, 11 from *Debility*, 4 from *Enteritis*, 4 from *Worms*, 2 from *Dysentery*, 2 from *Tetanus*, 1 from *Diarrhoea*, and 33 from *Other Causes*.

7. Fifteen cases of *Chickenpox* were reported, as against 9 in the previous week. No cases of *Measles* were reported.

*State of the Weather.*—The mean temperature of air was 79·2°, against 80·7° in the preceding week and 79·4° in the corresponding week of the previous year. The mean atmospheric pressure was 29·829 in., against 29·814 in. in the preceding week and 29·857 in. in the corresponding week of the previous year. The total rainfall in the week was 12·66 in., against 0·11 in. in the preceding week and 2·85 in. in the corresponding week of the previous year.
