LAND SALES IN THE SOUTHERN PROVINCE.

NOTICE is hereby given that on Tuesday, March 21, 1916, at 1 P.M., the Hon. the Government Agent, Southern Province, will put up to auction, at his office at the Galle Kachcheri, the right to dig for plumbago in the under-mentioned Crown lands in the Galle District, and supposed to contain plumbago, for a period of five years on the following conditions:—
