**NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899 AND 1900.**

**T**AKE notice, that unless within three months from the 18th day of May, 1903, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Assistant Government Agent of the Chilaw District, North-Western Province, and make claim to the said land or to some interest therein:

Such Assistant Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said land to which no claim has been made, is the property of the Crown.

*Description of the Land referred to.*

The land commonly called or known as Erumwalakele, situate in the village of Erumwala in Munnessaram patty in Pitigal korale north in the District of Chilaw, North-Western Province, containing in extent 158 acres 3 roods and 25 perches, shown as lot 7 in the annexed certified tracing; and bounded on the north by Sengal-oyn; east by Pallekelenukalana belonging to Crown shown as lot 8,842 in preliminary plan 1,750 of the village Mandalana; south by land called Wilpattuwamukalana owned by Mr. Peries on title plan 164,195, lot 8,420 called Erumwaliyaddu, land held on title plan 191,781. Erumwalawewa, the reservation for the wewa marked lot 10,588<sup>3</sup> in preliminary plan 2,149, lots 10,587 and 10,588 called Wilpattuwamukalana held by the villagers on title plans Nos. 191,369 and 191,370; west by lot 10,580 called Wilpattuwamukalana held by the villagers on title plan No. 191,369 and the village limit of Midellawatawana.
