The revenue divisions of Uda Bulatgema, Uda Hewaheta, Walapane, Kotmale, except those parts of Ambagamuwa and Pasbage korales of the revenue division of Uda Bulatgama and Pallepone korale of Kotmale, which are contained within the following boundaries :-

North.—From Helboda trigonometrical station, commonly known as Helboda-kanda, along the boundary between Udapalata and Kotmale and the northern boundary of Nugawela estate to the Kotmale-ganga up to where it falls into Mahaweli-ganga, thence along the Mahaweli-ganga to the 19th milepost, Nawalapitiya-Kandy@road, thence from Getahadeniya to Polgolla trigonometrical station, the boundary between Udapalata and Uda Bulatgama divisions.

-From Polgolla trigonometrical station to Stenshall's trigonometrical West.station (boundary between Udapalata and Uda Bulatgama), along the northern boundary of Galamuduna estate to Polepatiya-ela, thence along the eastern boundary of Sembawatta and Ing-oya estates to Urugala trigonometrical station. (boundary between Uda Bulatgama and Pata Bulatgama), thence in a straight line to Kalugala trigonometrical station, and from thence to Mudamanahela trigonometrical station, and thence to Kiripanagala trigonometrical station.

South.—From Kiripanagala trigonometrical station in a straight line to Kelweherakanda trigonometrical station.

Regulation of foot traffic.

268 FF. Every person proceeding on foot along a street shall keep to the pavement or footpath, if any, or where there is no pavement or footpath to the right hand side of the street. ## "THE LOCAL BOARDS ORDINANCE, 1898."

T is hereby notified that His Excellency the Governor, in exercise of the power vested in him by section 57 of the Local Boards Ordinance, No. 13 of 1898, and with the advice of the Executive Council, has been pleased to confirm the following by-laws made by the Local Board of Ratnapura, in pursuance of section 56 (21) of the said Ordinance.

#### By-LAWS re WELLS.

1. No person shall sink a well or cause a well to be sunk within the limits of the Local Board town, unless he shall have given to the Chairman one month's notice of such his intention.

2. No well shall be sunk less than 50 feet from any cesspit, cesspool, pigsty, gala, cattle shed, manure heap, leaking drain, neglected privy, heap of decaying vegetable or animal matter, or any manured land.

3. No cesspit, cesspool, privy, pigsty, gala, or cattle shed shall be constructed within a distance of 50 feet from any well used for drinking or domestic purposes, nor shall any manure or decaying animal or vegetable matter be deposited, nor any land be cultivated with manure, nor any drain suffered to remain in a leaking condition within such distance.

4. All wells shall be lined as far as water level either with bricks set in cement with a backing of puddled clay or with cylinders of iron cement or clay, or shall be otherwise so constructed as to prevent the entrance of water except from the bottom.

5. A platform upon which to stand and draw water may be constructed over the top of a portion of the mouth of the well. This platform shall be so constructed as to be absolutely water-tight, so that no water thereform can trickle back into the well but all flow on to the apron or pavement referred to in rule 6. The said platform shall have a slope downwards from the centre of the mouth of the well outwards so as to throw off water and a water-tight ledge at least 6 inches high along its inner edge connected at both ends with the parapet wall. The remainder of the well mouth shall be surrounded by a parapet wall at least 2 feet 6 inches high.

6. The well shall be surrounded for a distance of 5 feet by a cement apron or pavement of stone or brick set in cement sloping away from the well.

7. The outer edge of such apron or pavement shall be surrounded by a cement gutter emptying into a leadaway drain not less than 10 feet long, so as to prevent the stagnation of water in the vicinity of the well.

8. No plank shall be placed across the mouth of the well to stand on when drawing water or for any other purpose.

9. Water from wells shall be drawn in clean receptacles.

10. No one shall wash clothes within 20 feet of the mouth of a well used for drinking or domestic purposes.

11. Every owner or lessee of a well used as a public bathing place shall supply bathing tubs, and shall not allow persons who bathe to draw water, and no person shall draw water from such well while bathing.

12. Whenever any tree or branch of any tree overhangs a well, and is deemed after inspection by the Chairman or any Sanitary Officer of the Board to be injurious to the water owing to the dropping of the leaves or fruit into the water or by otherwise rendering the water unfit for use, it shall be lawful for the Chairman of the Local Board to cause notice in writing to be given to the owner, lessee, or occupier of the ground on which such tree stands to cut down or remove such tree or branch, and if such notice is not complied with within 14 days such person shall be guilty of an offence.

13. The Chairman may, whenever he deems such a course to be necessary, cause notice to be given in writing to the owner or lessee or occupant of any compound in which there is a well used for drinking or domestic purposes to bale out the water and clean the well and execute such repairs as the Chairman may consider to be necessary, and if such notice is not complied with within 14 days such person shall be guilty of an offence.

14. Whenever it shall be decided by a resolution of the Local Board that such a course is expedient in the interests of health, it may give notice to the owner, lessee, or occupant of any land to fill up or disinfect any well on such land, and the owner, lessee, or occupier shall thereupon be bound to comply with such order within 8 days' time. Should such owner, lessee, or occupier fail within such time to comply with such order such person shall be guilty of an offence.

15. It shall be lawful for the Supervisor or Inspector of the Board or other person empowered in writing by the Chairman of the Board to inspect wells or enter upon any land or premises for the purpose of inspecting proposed sites for wells or existing wells and their surroundings.

#### By-LAWS REFERRED TO.

1. No person shall commence the manufacture of aerated waters within the limits of the Sanitary Board for the purposes of sale without giving one month's previous notice in writing to the Chairman of the Board.

2. No aerated water factory shall be situated within less than 150 feet from any gala, stable, or other building used for keeping animals by day and night, or of any latrine or cesspit. No part of the factory shall be used as a dwelling house.

3. All premises used for manufacture of aerated waters must be well lighted and ventilated, must have cemented floors, must be provided with suitably built drains to carry off waste material, and must be kept clean and free from dirt and dust. The preparation of the syrups must be carried out in a separate fly-proof room. All chemicals and other materials used in the manufacture of the waters must be of good quality. All utensils and machinery employed in the manufacture must be kept scrupulously clean.

4. The water used in the manufacture shall be obtained from a source adequately protected from contamination and approved of by the Chairman of the Board. It shall be transported to the factory by means which shall ensure that no pollution occurs in transit. It shall be stored at the factory in properly constructed tanks or reservoirs connecting with the aerating apparatus. 5. All water used in the manufacture of aerated waters shall be passed through

5. All water used in the manufacture of aerated waters shall be passed through a Jewell or other filter approved by the Chairman and connected with the plant, provided that the Chairman shall have power to exempt from the operation of this rule water derived from an approved public supply.

6. Whenever the Supervisor or Inspector of the Board is satisfied that any aerated water, either manufactured within the limits of the Board or introduced into such limits from outside, is of such bad quality as to be unfit for human consumption, he may seize such waters and produce them before a Government Medical Officer, and if it appears to such officer that such waters are unfit for human consumption, he may order the same to be destroyed. Any person manufacturing any aerated water which shall be proved to the satisfaction of the court to be unfit for human consumption econsumption shall be guilty of an offence.

consumption shall be guilty of an offence.7. All bottles used in the manufacture of aerated waters shall be washed with filtered water and shall be kept scrupulously clean.

8. Every bottle containing aerated water shall bear a label setting out the description of the water and the place of manufacture, the name of the person or firm owning the factory, and the number assigned to the factory by the Chairman of the Board.

9. No person under 12 years of age shall be employed in any aerated water factory, nor any person suffering from any cutaneous or contagious disease.

10. All employés engaged in the filling of bottles with gas shall wear fine-meshed wire face- and neck-shields and leather gloves.

# "THE SMALL TOWNS SANITARY ORDINANCE, 1892."

#### SCHEDULE.

XII.—The guarantee of the Association shall be a guarantee that there shall be no breach of the bond of the Associate who is guaranteed so long as he continues to be an Associate, and so long as he is not transferred to an office which the Managers of the Association by notice in writing to the Colonial Secretary have refused to guarantee, and the obligation on the part of the Association shall be to pay on any breach, during such period of the bond of any Associate, where the bond is not first put in suit against such Associate by the Crown during such period, such sums of money as would have been legally recoverable by the Crown during such period on such bond in respect of such breach from a surety for such Associate who had, as surety, duly executed such bond ; provided that if in any such case a difference of opinion shall arise between the Government and the Managers as to the liability of the Association, or as to the sum of money that would have been legally recoverable, such difference shall be referred for decision to, and decided by, persons chosen as referees by the Managers and by the Crown, one person to be chosen by each, a third person to be chosen by these two ; the opinion given by the majority to have effect.

Any sums of money so due by the Association shall be paid into the Treasury by the Managers, out of the moneys at their disposal, within two months after the same shall have been demanded from them by the Colonial Secretary in the case of uncontested claims, and in contested claims within two months after the decision given as aforesaid; provided that the Managers shall not be bound to make such payment unless the Crown assigns the bond in respect of which the claim is made to the Managers or some person in trust for the Managers, as the Managers may require, and pledges itself to return to the Association the money paid to the Crown by the Association or any portion thereof that may have been paid under a mistake of law or of fact. Where such bond is first put in suit by the Crown against such Associate, the obligation shall be to pay at such time and in such manner as mentioned in Rule XIII.

## VITAL STATISTICS.

#### Registrar-General's Weekly Health Report of the City of Colombo for the Week ended May 6, 1916.

Births.—The total births registered in the city of Colombo in the week were 80 (1 European, 12 Burghers, 40 Sinhalese, 9 Tamils, 15 Moors, and 3 Malays). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1916, viz., 255,354) was 16.4, as against 22.3 in the preceding week, 24.9 in the corresponding week of last year, and 22.7 the weekly average for last year.

Deaths.—The total deaths registered were 127 (1 European, 10 Burghers, 64 Sinhalese, 19 Tamils, 22 Moors 1 Malay, and 10 Others). The death-rate per 1,000 per annum was 26.0, as against 22.7 in the previous week, 18.1 in the corresponding week of last year, and 25.8 the weekly average for last year.

Infantile Deaths.—Of the 127 total deaths, 18 were of infants under one year of age, as against 22 in the preceding week, 25 in the corresponding week of the previous year, and 29 the average for last year.

Stillbirths.-The number of stillbirths registered during the week was 8.

Principal Causes of Death.—Sixteen deaths from Phthisis were registered, as against 14 in the previous week and 15 the weekly average for last year. Of these, 4 were in St. Paul's, 4 in New Bazaar, 4 in Maradana (including 2 deaths of non-residents in hospitals), 2 in Kotahena, 1 in Pettah, and 1 in Slave Island.

2. Fifteen deaths from *Pneumonia* were registered, as against 17 in the previous week and 11 the weekly average for last year. Of these, 5 were in Maradana (including a death of a non-resident in hospital), 3 in Wellawatta, 2 in Fort and Galle Face, 2 in Slave Island, 1 in Pettah, 1 in San Sebastian, and 1 in St. Paul's. Two deaths from *Bronchitis* were registered.

3. Two deaths from *Enteric Fever* were registered, as against 9 in the previous week and 3 the weekly average for last year. Of these, 1 was in St. Paul's and the other in Maradana.

4. One death from *Plague* was registered in New Bazaar; there were none in the previous week. Three cases were reported, as against 2 in the previous week.

5. One death from Cholera was registered of a passenger on board ss. Pei-ho.

6. One death from *Measles* was registered (in Slave Island), as against 3 in the previous week. Ninety-two cases were reported, as against 45 in the previous week.

7. No deaths from *Chickenpox* were registered; there was 1 in the previous week. One hundred and sixty-one cases were reported, as against 75 in the previous week.

8. Ten deaths from Infantile Convulsions were registered, 8 from Debility, 7 from Worms, 6 from Dysentery, 4 from Enteritis, 1 from Diarrhæa, 1 from Tetanus, and 52 from Other Causes.

State of the Weather.—The mean temperature of air was  $81\cdot4^{\circ}$ , against  $83\cdot8^{\circ}$  in the preceding week and  $83\cdot3^{\circ}$  in the corresponding week of the previous year. The mean atmospheric pressure was  $29\cdot809$  in., against  $29\cdot777$  in. in the preceding week and  $29\cdot746$  in. in the corresponding week of the previous year. The total rainfall in the week was  $6\cdot30$  in., against  $0\cdot90$  in. in the preceding week and  $7\cdot43$  in. in the corresponding week of the previous year.
