

- 2. The Location of the Devalaya North by the jungle which situated in back side of the devalaya. South by Ranwala Ammaduwa Road East by Mr. Dewagiri Kapumahathaya's land (Home garden)
- 3. It is not responsibility to enter, deliver, help or produce the food items in the camp site, with venereal diseased or other serious diseased people. Specially food cabins, food restaurants, bakeries Dansala Etc....
- 4. It is prohibited to take a cattle or any kind of animals to the camp site with out a written permission by the district Secretary.
- 5. It is Prohibited to transport vehicles and walking in or out and near the camp site but the help of 07th regulation the bulls and bullock carts can enter the parking places. This regulation will not cause for parking bulls and bullock carts for their separate sections.
- 6. All bakeries, food cabins, food making places, food restaurants, Dansal and buildings for business activities are in the camp site. There should be wood dustbins activities are in the camp site. There should be wood dustbins with lids or metal dustbins with lids. They must be thickness of 1 1/2 meters of the capacity
- 7. All remaining drinks likes tea, coffee, milk etc and discarded cooking items should not throw here and there in the camp site. All rubbish or discarded things should put into the dustbins according to the 19th regulations. It somebody throws this dust on the ground or near the floor and it is seen by the owner, head resident or licensed owner can take legally

action to avoid that work. if they do not concern this warnings' they may be the unlawful persons.

- 8. On the view of the district secretary, someone who breaks the 15th, 16th, 17th, 18th or 19th regulations and carry out bakery, food cabin, food making hut, restaurant, dansal or threading please in the camp site, can prohibit such activities. Further these place can be close. If there are licenses, it also can be cancelled by the authority.
- 9. There are some persons who are suffering from venereal diseases or other serious diseases should not associate with people in the camp. If somebody has known it, they must be reported immediately to the police or physical health officer.
- 10. It is not permission to enter or help to the bakery, food cabin, food restaurant etc....with venereal diseases or other serious diseases people. They should not even make food or serve food to the people.
- 11. If an owner of food restaurant, food cabin, a dansal or a pilgrim rest should not give accommodation for some period to stay, to those diseased people if it reveal, the owner must inform immediately to a doctor, or P.H.I or a police officer.
- 12. Under the 7th regulations begging and donation should do the reserve places not in the camp site, with money or other ways. Anyone should not donate money or serving money or something in the camp site.
- 13. According to 7th and 10th regulations, someone should not remove a, notice name board unlawfully.
- 14. A district secretary, a doctor and P.H.I. or police officer.
  - (*a*) Can take legally action to enter to the land in the camp site.
  - (b) According to 7th regulation, a name board, a notice can display in the camp site. To struck a pole or make any building in the camp site has a legally authority.

# Report of the Auditor General on the Financial Statements of the University of Jaffna for the Year ended 31st December, 2013 in terms of Section 108 (1) of the Universities Act, No. 16 of 1978

THE audit of Financial Statements of the University of Jaffna for the year ended 31st December, 2013 comprising the statement of financial position as at 31st December, 2013 and the statement of financial performance, statement of changes in net assets and cash flow statement for the year then ended and a summary of significant accounting policies

and other explanatory information, was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 107 (5) of the Universities Act, No. 16 of 1978. My comments and observations which I consider should be published with the Annual Report of the University in terms of Sub-section 108 (1) of the Universities Act, appear in this report. This report also to be considered as a detailed report in terms of Sub-section 108 (2) of the Universities Act.

#### 1:2 Management's Responsibility for the Financial Statements :

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

#### 1:3 Auditor's Responsibility :

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent with International Standards of Supreme Audit Institutions (ISSAI 1000-1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

And audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatements of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the University's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the University's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of financial statements. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary power to the Auditor General to determine the scope and the extent of the audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

#### 1.4 Basis for Qualified Opinion :

My opinion is qualified based on the matters described in paragraph 2.2 of this report.

#### 2. Financial Statements :

#### 2:1 Opinion :

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the University of Jaffna as at 31st December, 2013 and its financial performance and cash flows for the year then ended in accordance with the Sri Lanka Public Sector Accounting Standards.

#### 2:2 Comments on Financial Statements :

#### 2:2:1 Sri Lanka Public Sector Accounting Standards (SLPSAS) :

Fixed assets such as cloaks and medals valued at Rs. 6,836,600, which had been fully depreciated and continued to be used in the year under review had not been revalued and brought to the accounts in terms of SLPSAS - 3. In this connection the Vice Chancellor had stated that "revaluation process is in progress and 80 percent of the work has been completed including mainly the valuation of land and building, semi permanent structure, motor vehicles and cloaks".

#### 2:2:2 Accounting Deficiencies :

The following accounting deficiencies were observed in audit:

- (a) The value of books and periodicals amounting to Rs. 1,845,672 and 87 items of journals and periodicals valued at Rs. 1,359,072 in respect of the years from 2005 to 2009 shown in the financial statements had not been received from the suppliers even up to 30th September, 2014. However, the depreciation for those books and periodicals amounting to Rs. 438,214 had been charged against the income of the year under review;
- (b) The building construction works and internal roads work to the value of Rs. 41,045,741 and Rs. 50,000,000 respectively had been completed and handed over to the University by the Northern Provincial Department of Buildings and Road Development Department during the Year 2012. However, it had not been capitalized and brought to accounts;
- (c) A balance of Rs. 364,569 had been shown in suspense account since 2012 without being taken action to clear this balance.

#### 2:2:3 Accounts Receivable and Payable :

The Following observations are made:-

- (*a*) No action had been taken to recover the outstanding balances of Rs. 146,703 which remained unrecovered for more than five years;
- (b) Trade payables amounting to Rs. 2,429,651 had been included in the outstanding balances remained unrecovered for more than six years. In this connection the Vice Chancellor had stated that action had been taken to transfer the payables of Rs. 861,137 to the revenue account with the approval of the Finance Committee and the Council. The balance of Rs. 1,701,265 is being used for the Running Courses;
- (c) Unpaid salaries to the staff of the University amounting to Rs. 48,306 remained as payables for the period ranging 01-02 years without being credited to the revenue;
- (d) Out of the advances aggregating Rs. 208,692,479 made to the various parties such as Department of Buildings (Central), Ceylon Electricity Board, staffs of the University and suppliers for importation of books and periodicals and payments made to staff as salary advance an amount of Rs. 163,555 had not been recovered for more than 10 years;
- (e) A sum of Rs. 41,250 receivable as rent from 52 staffs of the University during the year under review had not been recovered;
- (f) Loan instalments aggregating Rs. 430,272 to be recovered from 27 officers had not been deducted from the salaries of the respective officers in each month during the year under review;
- (g) Distress loan balance of Rs. 53,055, Motor Cycle loan balance of Rs. 10,802 and computer loan balance of Rs. 18,000 due from an officer (Vavuniya Campus) had been outstanding for over 12 years without being recovered;
- (h) Advances aggregating Rs. 10,980,784 had been made on 30th December, 2013 without having proper assessments for the possibility of purchase of books and periodicals. Hence, considerable period had been delayed to supply of the items ordered;
- (*i*) The balance of advances aggregating Rs. 650,886 paid to the Department of Buildings (Central) had not been remitted to the University even up to the date of audit inspection on 31st May, 2014;

(i) No action had been taken on unsettled advances of Rs. 1,121,194 paid to an officer in 2006 for the purchase of grocery items and stationeries.

#### 2:2:4 Lack of Evidence for Audit :

Following observations are made :

- (a) Annual verification report had not been made available for audit to prove the existence of seven inventory items aggregating Rs. 7,544,894,425 included in the accounts.
- (b) Accuracy of the information regarding the donations, rent payments, losses and damages, accidents, decisions taken by the faculty boards, research allowances paid and effective conduct of the academi programmes could not be confirmed in audit due to non-rendition of following evidence.
  - Detailed reports on donations received from foreign countries/embassies.
  - Valuation reports for the premises taken on rent.
  - Minutes of the University Senate.
  - Accident/Loss reports.
  - Details of academic programmes conducted by the Faculty of Management Studies and Commerce.
  - Details of research completed by the academic staff.

#### 2:2:5 Transactions not Supported by Adequate Authority :

According to the letter No. PE/01/174/119B dated 06th March, 1998 of the Director General of Public Enterprises and Establishment, Circular No. 8/2013 dated 23rd May, 2013 of the University Grants Commission, the allowances payable for language proficiency for government officers should not be extended to State Corporations and Statutory Boards. However, a sum of Rs. 397,807 had been paid to 57 non academic staff as language proficiency allowance during the year under review.

# 3. Financial and Operating Review

#### **3.1 Financial Results**

According to the financial Statements presented, the operations of the University during the year under review had resulted in a deficit of Rs. 1,157,048,668 before taking into account the Government Grant of Rs. 1,037,920,000

of 12 vehicles belonging to the University.

for recurrent expnediture as compared with the corresponding deficit of Rs. 969,943,982 for the preceding year before taking into account the Government Grant of Rs. 869,160,000 for that year, thus indicating a further deterioration of Rs. 16,793,288 in the financial results. The increase of personal emouluments in contractual services, depreciation charges and amortization expenses, and provision for gratuity for the year under review as compared with the previous year had been mainly attributed for this deterioration in the financial results.

#### 3.1.1 Uneconomic Transactions :

The Following observations are made.

- (*a*) Intercom facilities had been installed at the University in January, 2011 in order to reduce the offical telephone charges by reducing the use of existing direct telephone lines. However, the telecommunication charges for the year under review had been increased by Rs. 4,697,076 or 32 per cent when compared with the charges for the preceding year due to outgoing facilities had also been given through the intercom lines simultaneously.
- (b) Although the University had own a guest house at Jaffna, officers visited to the University are provided an accommodation facility at private hotels due to the occupation of University Register and Deputy Registrar (Capital works) in this guest house without paying any rent since April, 2009. In this connection a sum of Rs. 825,125 had been paid during the year under review by the University to provide accommodation to the officers visited to the University.

#### 4. Operating Review

#### 4.1 Performance :

The academic performance of the University during the year under review was as follows.

(a) Results of Examinations

Dates to hold the examinations for various courses conducted under each faculty of the University and target dates to release results of the examinations had not been determined. It was further observed that there were considerable period of delays in releasing the results of examinations ranging from 01 to 22 months from the date of examinations by the faculties of Agriculture, Arts, Management Studies and Commerce, Science and External Examination unit of the University during the years 2012 and 2013. According to the University Grants Commission Circular No. 636 of 14th July, 1995 the results of the examinations should be released within three months after the examination. But, results had been delayed by the significant period as mentioned above; thereby the students had been deprived to get their employment opportunities in time.

(b) Cost per Student

Total number of students registered at the University was 5,723 as at the end of the year under review and the total expenditure incurred during the year under review amounted to Rs. 815,147,732 and as such the average cost per student for the year was Rs. 142,434 as per details given below.

The highest cost per student amounting to Rs. 350,036 was reported at the Faculty of Agriculture whilst lower cost per student amounting to Rs. 18,738 was reported at the Faculty of Graduate Studies.

(c) Mahapola and Bursaries

Sums of Rs. 26,404,250 and Rs. 38,335,400 had been paid as "Mahapola" and Bursary to 1,950 students and 1,900 students respectively during the year under review. However, a sum of Rs. 1,282,400 had not been paid to 580 students as "Mahapola" up to the date of audit on 11th August, 2014.

- (d) Library Administration
  - (*a*) Seventeen books had been returned within the stipulated period by Thirteen lectures who had obtained books from the Library. In this regard no proper action had been taken to get back those books which were outstanding for periods ranging from 1 year to 28 years or to impose a fine for the delays.
  - (b) The University had not been taken action relating to 724 books, magazine and journals valued at Rs. 1,992,508 which were not receipt by the University since 2006.

#### 4.1.1 Visiting Lectures :

Stipulated period of lecture hours as mentioned in the letter of appointment had not been fully covered by the visiting lecturers, as a result the entire syllabus of the subjects were not covered by the visiting Lecturers.

#### 4.1.2 Payment of Research Grants and Research Allowances :

Research grants and research allowances amounting to Rs. 3,243,572 and Rs. 52,799,328 respectively had been paid during the year under review. In this connection the following observation are made.

- (i) A register for research grants had not been maintained.
- (ii) Offices were not submitted the research reports in stipulated time period.
- (iii) Terms and conditions and criteria for utilization of grants were not provided to the officers who were paid grants.
- (iv) Work, plan and Schedule for submission of research reports had not been given by the officers.

#### 4.2 Management Inefficiencies :

The Following observations are made.

- (a) One Hundred and Forty-eight Lecturers of the University who went on scholarship had not reported back for duty after completion of the scholarships. However, the University had not taken necessary action to recover sums aggregating Rs. 82,334,517 as at 31st December, 2013 from 148 lecturers for breached of agreements.
- (b) Twenty-two cheques valued at Rs. 8,593,446 drawn on 15th October, 2012 and issued to 14 organizations as advances for the purchase of equipment had been subsequently, cancelled after lapse of four months. In this connection the Vice Chancellor had stated that "The cheques were drawn as at 30.12.2012 in order to utilize the available funds. The cheques were drawn when the orders were placed. As the supplier did not supply the item within the stipulated period, the cheques were cancelled to reverse the advances."
- (c) Payments of Rs. 493,360 had been made to a private company on the service agreement of 23 photo copiers. However, as per the contract agreement, 12 services should have been carried out for the year under review at the rate of one per month for all photocopy machines within the contract period. However, services were made only at 4 to 07 occasions. As a result, a sum of Rs. 246,680 had been overpaid to that company.
- (*d*) A contract agreement had been entered on 18th November, 2013 for the service of preparation of fixed assets register of the University which had been outsourced at a cost of Rs. 3,150,000 from a Private Company. In this regard the following observation is made.

As per the contract agreement, the work should be completed on or before 18th February, 2014. Nevertheless, the work had not been completed even up to 30th October, 2014 after lapse of 08 months. As per the information made available for audit, 25 per cent of the works only had been completed up to June, 2014. Further, the prior approval for the extension had not been obtained.

(e) In terms of Section 11.1 of Chapter XXII of the Establishment Code for the University Grants Commission and Higher Educational Institutions, the inquiry officer should be completed the inquiries within the period of 03 months. Even though four inquiry boards had been appointed to conduct the inquires against the officers who had been interdicted due to disciplinary grounds and fraudulent activities, the inquiry board had not been completed its proceeding within the specified period of time. As a result, interdicted officers were paid full salaries without obtained prior approval/authority from the University Grants Commission.

Further, it was observed that interdiction given to a professor had been subsequently withdrawn and requested to report back for duties with full salary.

#### 4.3 Identified Losses :

The books and periodicals purchased during the period from December, 2012 to March, 2013 through Twenty paid vouchers aggregating Rs. 1,572,450 had been forged as payment had been made without receiving the above items. In this connection, the University had not been taken action to recover the payment from the parties responsible. Further, this payment had been transferred to loss on book and periodicals suspense account by a journal entry and the internal and external inquiry process are in progress in view of recover the losses.

#### 4.4 Human Resources Management :

The following observations are made.

- (a) Reasons for delay in recruitment of staff had not been furnished to audit.
- (b) There were 282 vacancies existed by 31st December, 2013 and out of that 130 vacancies were key academic posts such as post of Professors, Associate Professors of seven faculties of the University. However, the University had not taken prompt actions to fill these vacancies.
- (c) Direct confirmations with regard to the educational qualification of 1,142 officers appointed by the University had not been obtained from the respective institutions in terms of Section 21 of Chapter III of the Establishment Code for the University Grants Commission and Higher Educational Institutions.
- (d) The Council of the University had decided to reinstate the terminated staff by considering the appeals from various parties based on sympathetic grounds without considering the provision laid down in Paragraph 20:16 of Chapter III of the Establishments Code for the University Grants Commission and Higher Educational Institutions and the Letter No. UGC/HR/3/1/6 dated on 28th September, 2012 forwarded by the Chairman of the University Grants Commission.

#### 4.5 Contract Administration :

- (a) Bill of quantities (BOQ) had been increased by the work Engineer without proper authority. As a result a sum of Rs. 115,087 had been over paid to the contractor during the year under review on the work carried out at the student centre of the University.
- (b) Plumbing repairs, internal electrical repairs had not been executed by the contractor as agreed on the agreement made.
- (c) Extra Schedule of Rate and in due Schedule of Rate (ESR ISR) of the works to the value of Rs. 228,374 had been executed by the contractor without required authority in respect of construction of Garage.

#### 4.6 Matters in Contentious Nature :

The Following observations are made.

- (i) It was decided by the Senate of the University to conduct 4th year study programme for the L. L. B students in a rent out building at Colombo, Although the buildings, resource persons and all other facilities were made available at the University, the lectures had been conducted in a rental building obtained on the basis of Rs. 100,000 rent per month in Colombo and a sum of Rs. 6,630,000 had been paid as rental up to 31st December, 2013.
- (ii) Attendance register for the Academic staff had not been maintained for a long period. Therefore, the leave taken and accuracy of the salaries paid to the staff amounting to Rs. 697,024,683 for the year under review could not be satisfactorily vouched in audit.
- (iii) Even though it had been planned to install the finger print scanners in the year 2011, it had not been effectively installed for the intended purpose in terms of Establishments Circular No. 02/2010 dated 15th February, 2010 issued by the University Grants Commission.

#### 4.7 Irregular Transaction :

Valued Added Tax (VAT) aggregating Rs. 424,175 had been paid by the University for Civil Works carried out at the Engineering Faculty without examined the validity of VAT registration number and VAT invoice at the time of payments. Subsequently, it was found that VAT number indicated by the contractors were inactive.

#### 4.8 Weaknesses in Procurement Procedures :

A sum of Rs. 328,703,735 had been incurred for the procurement of office furniture and equipment, books and periodicals, cloaks, telephone exchanges and stationeries during the year under review. In this regard the following observations are made.

- (*a*) Target dates of completion for the items mentioned from No. 07 to No. 13 of the Master Procurement Plan had not been indicated.
- (b) Master Procurement Plan had not been approved by the Secretary to the Ministry of Higher Education.
- (c) According to the Procurement Guideline 4.2.2 a procurement time schedule should be prepared by describing in chronological order and steps of each individual procurement action from the point of commencement and until its completion. However, the time schedule and steps of each individual procurement action had not been prepared by the University.

#### 4.9 Assets Management :

The Following observations are made.

- (i) Supplies and maintenance items such as typing sheets, electricity goods, twin and fan aggregating Rs. 1,599,197 had remained idle for a period ranging from 01 to 15 years in the stores of the University. In this regard no action had been taken to utilize them.
- (ii) Out of 69 raincoats purchased during the year under review, 65 raincoats had not been collected by the employees. As a result raincoats were left to be idle at the stores without being utilized for the intended purposes.

#### 4.10 Vehicle Fleet Management :

- (a) Maintenance of Vehicle Running Charts
  - Fuel order number, dates and numbers of fuel bills had not been indicated in the running charts of vehicle.
  - According to the running charts, an over payment of Rs. 96,504 had been observed in audit relating to four vehicles used by the Vavuniya Campus of the University.
  - Purpose of the trips had not been indicated in running charts of the vehicle.
- (b) Hiring of Vehicles

A sum of Rs. 2,509,795 had been paid as vehicle hiring charges during the year under review. Although University had 12 vehicles in its fleet, several vehicles had been hired by the University. In this connection, the following observations are made:

- Procurement procedure had not been properly followed for hiring of vehicles;
- Rate per k.m. had been paid without consider economy/Government rate fixed by the District Secretary;
- Quotations were not called from the registered transport agencies to obtain transport services;
- Milo meter reading and duration of journey had not been authenticated by the officers used by the hired vehicles;
- Register for booking of vehicles had not been maintained.

#### 5. Accountability and Good Governance :

#### 5.1 Tabling of Annual Reports :

Annual Reports for the year 2011 and 2012 had not been tabled in Parliament even up to 30th September, 2014 in terms of Section 6.5.3 of the Public Enterprises Circular No. PED/12 of 02nd June, 2003.

#### 5.2 Action Plan :

According to the Circular letter No. PF/R/2/2/3/5(4) dated 10th March, 2010 of the Director General of Public Finance, the University had not prepared an Annual Action Plan and Annual Performance Report for the year under review.

#### 5.3 Internal Audit :

As per the internal audit programme for the year under review the following areas of transactions were not fully examined/covered by the internal audit unit.

#### (a) Post audit on Capital Projects and Contract Management.

In this connection the Vice Chancellor had stated that "post audit on capital projects and contract management was unable to covered fully due to non completion of the contract works in progress. Therefore, internal audit covered half of the contract management and balance works are being audited time to time".

#### (b) Procurement of the University

In this connection the Vice Chancellor had stated that "The procurement works was audited by the internal audit by verifying the payment vouchers related to the procurement of goods and services. Action will be taken to examine them fully in future".

#### 5.4 Un-unserved Audit Queries :

The University had not taken action to answer 09 audit queries issued from 2011 to 2013. Details are as follows.

#### 5.5 Budgetary Control:

Significant variations were observed between the budgeted and actual income and expenditure, thus indicating that the budget had not been made use of as an effective instrument of management control.

(*a*) Having considering the new trends in the field of communication technology and use those facilities to provide the public service delivery in an efficient and effective manner, telephone and internet facilities can be provided to the officers in the University System as per the Commission Circular 5/2012 related to Provision of Communication facilities (telephone, mobile and internet).

Expending Academic activities of two Faculties has located in killinochchi such Engineering and Agriculutre and other Departments and Units such as SDC, Clinical Departments etc. Until 2011 the adequate telecommunications facilities were not there in the Jaffna peninsula and from 2011 onward it was popular and cost was increased.

(*b*) The University was unable to refurbish the existing Guest house due to lack of fund allocation. We face difficulties in finding accommodation for guests who come for visiting lecturers/selection board etc. The Guest House with good facilities is a long felt need. The faiclities such as AC, toilets etc, in the Guest House are not satisfactory for the many guests who come on our request to attend important meetings and official functions. They specially insist on the above facilities and therefore lodging had to be obtained private hotels.

At present, the approval of Finance Committee and Council had been obtained to procure the service for accommodation facilities in the private hotels based on the procurement procedure.

4.1

- (a) Now it has been improved. Action is being taken to report to the Senate about the examiners who are not responding in time based on the circulars. Further these reminders will be filled in their personal files.
- (b) Information is noted.
- (c) We had informed the date of payment of Mahapola Scholarship payments for the students through the respective Deans of the faculties. Also we had displayed the date of payment schedule on Notice Boards at Student's Common Room and Welfare Branch. Response from the Students was limited. Since the Mahapola Trust Authorities requested us to refund the uncollected Mahapola fund after the date of payment, we have refunded it as per requirements sent by Mahapola Trust Authorities. However we try our best to reduce these in future.
- *(d)*
- (*a*) The reminders had been sent to the respective staff to return remaining Four Library books at present. The action is being taken to deduct the value of books from the salary of the respective staff who failed to return the books with the recommendation of Finance Committee and approval of Council.
- (b) Suppliers were requested on several occasions to issue the balance Journals and Periodicals. Action will be taken to obtain the confirmation for non received books, magazine and journals from the suppliers and rectify the issue.

### 4.1.1

All Visiting Lectures have completed the assigned lectures within the stipulated time and that no students were affected by adjusting the time tables given to visiting lectures.

### 4.1.2

Research Grants are being paid in accordance with the conditions stipulated in the respectives grants and the progress report submitted by the Supervisors are submitted to the granting Agency and it is monitored stage by stage and the grants are released by installments.

With regard to the Research allowance paid to the staff who are eligible in terms of the budget proposal 2011 and as per the Higher Education Circular No. 1/2011 of 20.04.2011 Senate of this University has appointed Faculty Research Committee consisting of Chairman, and other members for each faculty. It is the responsibility of each committee to study the proposal submitted by the staff to make recommendation for the particular year. Further evidence for publication/presentation, evidence for acceptance for publication/presentation for previous year are checked by the faculty Research Committee before recommending the allowance for the present year.

Once the Research proposal is recommended by the Faculty Research Committee individual Research Application are submitted to the Academic Establishments for getting approval from the Vice-Chancellor. After that it has been forwarded to the Finance Branch for making Research allowance.

Research proposal and evidence for publication is maintained in the personal files of academic staff.

### 4.2

- (*a*) Follow up action is taken on this issue and Rs. 28,848,577 was recovered from this Bond violation. The balance as at 31.12.2014 is Rs. 75,305,971. Out of these amount Rs. 12,698,940 is related to year 2013 and 2014.
- (b) The Cheques were drawn as at 30.12.2012 in order to utilise the available funds. The cheques were drawn when the orders were placed. As the supplier did not supply the item within the stipulated period, the cheques were cancelled to reverse the advance.

- (c) As per the service agreement the contractor had successfully completed their work. Due to an oversight the records were not entered properly in the respective department's register by the contractor. Relevant service documents are available with the contractor which they have obtained from the heads certifying it after servicing the machines. Action had been taken to inform the heads to keep a record of service properly.
- (*d*) The work of preparation of Fixed Asset Register is in progress. 3 stages out of 6 had been completed. Now stages 4 and 5 are being done. The University requested the contractor to complete before the end of December, 2014 and the approval also had been granted for extension. The action will be taken to regularize it.
- (e) One of the lecturer was issued charge sheet on the allegations leveled by the students against him on 23.07.2013. The Council at its meeting held on 28th September, 2013 did not accept the answer filed by the person concerned and decided to proceed with a formal inquiry and decided the followings.
  - 1. To interdict accused with effect from 01.10.2013
  - 2. Pay one half of emoluments
  - 3. Declared out of bound with effect from 07.10.2013

The 1st sitting of panel actually was commenced on 14.06.2014. The formal inquiry is not yet completed.

According to the Public Administration Circular No. 6/2004 dated 15.12.2004 and the No. 6/2004 (i) dated 30.12.2011, the Disciplinary Authority take steps to conduct the relevant inquiry and to issue the disciplinary order within a period of one year from the date of serving of charge sheet against an accused officer. Except where proceedings and the issue of disciplinary order are delayed for more than one year due to lapse of the part of the accused officer, He should, if under interdiction of the disciplinary authority, subject to the facts mentioned in the disciplinary inquiry.

Having considered the provisions of the Public Administration Circulars No. 6/2004 dated 15.12.2004 and the No. 6/2004 (i) dated 30.12.2011 and the on-going inquiry against Prof. Elancumaran for "Inappropriate behaviour towards female Students", University Council as its 396th meeting held on 27.12.2014 decided the followings:

- (i) To reinstate the person concerned to his position with effect from 01.10.2013 and to pay full salary with effect from 01.01.2015.
- (ii) To place him on compulsory leave with effect from 01.01.2015 and declared out of bounds.

The Inquiry panel is continuing its process.

4.3 The books and periodicals Account had already been transferred to loss on books and periodical suspense Account in 2013 by the journal entry number JE/104/13 and the internal and external inquiry process is going on to recover the loss.

### 4.4

(*a* & *b*) Seven advertisements were made to fill the academic positions in the Year 2013 University had made 22 permanent positions to the academic grades in the year 2013.

Hence, the above details reveal that the University has taken all the efforts to fill the existing cadre vacancies promptly. Even though the efforts taken by the University as indicated above to fill the vacancies, the University was unable to fill the positions of Professor Chair as there was no application received with required qualifications despite of repeated advertisements. Such situations are prevailed even for the position of Senior Lecturer/Lecturer in some discipline in all faculties.

In such circumstances University filled these vacant positions by temporary lecturers on temporary instructors or temporary demonstrators in order to carry out the academic programme without interruptions. Hence, 43 temporary positions were made against the vacancies for permanent positions.

- (c) It is the practice that qualifications obtained by the Academic staff at our University are confirmed at the time of preparation of Schedule for selection boards for permanent positions. Further Academic Transcripts are obtained from other Universities in addition to their statement of results at the time selection. Action will be taken to confirm their qualification in writing once the recruitment is made.
- (d) Letters of terminations were issued as per the UGC's ruling dated 28.09.2012 considering their long services, special training they have undergone, the urgency of work, their performance and their genuine claims strongly recommended by the respective Heads of Departments they were appointed on contract basis for a period of Six months. Subsequently based on the appeal, the UGC informed that it has no objection to reinstate them. The Council at its meeting held on 23.03.2013 reinstated them as approved by the UGC.

- (a) This contract is measure and pay contract. Payment was made for the actual quantity done by the contractor with the approval of the Vice Chancellor. As per the clause No. 9.2 of the conditions of the contract of ICTAD/SBD/3, the Engineer of the relevant project can instruct the quantity variation of any BOQ for the particular item up to 25% of the original BOQ item at the same rate and can decide new rates it the BOQ for the particular item more than 25% provided that the changes exceed 1% of the initial contract price.
- (b) This contract was terminated by the client since the contractor has not completed the work on time. Plumbing repairs and internal electrical repairs were not done by the contractor before terminating the contract. Hence, payments for those 2 items were not made to the contractor. Those works were attended by the Maintenance branch. 25% of the uncompleted work amount (25% of Rs. 504,850.00) was deducted from contractor's final bill as surcharge.
- (c) Work Engineer ordered extra works due to minor change in the scope of the work while the work was going on. According to the Procurement Guideline reference No. 8.13.4 no variation order on change of scope which involves the increase of contract price shall be issued without the prior approval obtained following the procedure indicated. However, any savings accumulated on the reduction of quantities and/or deletion of items in the procedure. In this contract there no increase in contract price. Hence, Work Engineer ordered the extra works to the contractor verbally not in writing. Any extra works will be ordered to the contrator in writing in future. Vice Chancellor's approval was obtained for the payment for variation due to extra words within the contract sum.
  - (i) It was decided by the University Senate to conduct the 4th year study programme for the LLB students in Colombo in consideration of the following to ensure the quality.
    - 1. The fourth year programme consist of six Course Units and Research Project having 30 Credit Value.
    - 2. Only one permanent Lecturer is available in the Department of Law. Final year research project has to be supervised by senior lectures; Hence students are sent to Colombo still as early programme is being continuing.
    - (ii) Academic Staff in the University system do not generally sign in the Attendane Register. However this matter was brought to the notice at its 372th Meeting of the Council dated 29.09.2012 and it was pointed out at the meeting that nowhere in the world academic staff are expected to sign in the Attendance Register and no action should be taken in this regard. Deans of Faculties endorsed this view. A decision is awaited to implement the finger scanner to record attendance of all the other staff. Moreover, Executive officers, staff recruited on temporary/contract/casual/assignment basis and trainees have now been using the finger scanner machine to record their attendance and it is emphasized to extend this to other non-academic Staff as well who will be appointed in near future.

- (iii) Finger Scanner Machines have been fixed at all the offices of the Dean, Teaching Hospitals, Library, Registrar's office, Security department, Ramanathan Academy of Fine Arts and Unit of Siddha Medicine to confirm the arrival and departure Administrative Officers. Trainees and other staff on assignment basis are using the machines. The new recruits and they who will obtain promotion have been issued Letters to use the details with finger scanner.
- 4.7 Contractor has renewed the VAT registration for the effect of the relevant contract at the next payment time.
- 4.8 The Master procurement plan was prepared in the format given by the Secretary, Ministry of Higher Education. The Master Procurement Plan will be prepared in detail in future.
- 4.9 (i) Items were put under repeated auction but due to lack of demand these were not sold. Then the approval from Finance Committee and Council had been obtained to dispose/donate these items as per the Establishment Circular 04/2013.
  - (ii) The raincoats were purchased from Branded Company based on the recommendation of TEC and the approval of Procurement Committee. Actions already have been taken to issue the raincoats.
- 4.10 (a) 1. This has been corrected and drivers were instructed to get the initials of the officers when the journey is completed.
  - 2. Without doing fuel test, we were unable to balance correctly. Now we have done fuel test and balancing correctly without any shortage. However action is being taken to do the fuel test once in six months for all vehicles and minimize this type of shortcomings.
  - 3. Action is being taken by instructing the respective drivers of the vehicle and the subject clerk to indicate the fuel order number and date or fuel bill number in the running charts.
  - (b) Information is noted and the action will be taken to rectify the issues in future.
- 5.1 The Annual Report 2011 has been tabled in the Parliament on 18th February, 2014 and the Cabinet approval for Annual Report 2012 is awaited. Action will be taken to publish the report.
- 5.2 Action plan had been submitted to the UGC as per UGC letter and format.
- 5.3 Internal Audit
  - (a) Post audit on capital projects and contract management.

Now the action has taken by Internal audit to conduct post audit on capital projects and contract management like as verification of handing over, taking over document, work completion certificate, copy of VAT, ICTAD registration, final bill and arithmetic calculation fo respective payment of contract work.

(b) Procurement of the University

Now the action has taken to examine the documentary evidence in related to Procurement procedure of goods and services in line with repective payment vouchers.
