By His Excellency Sir John Anderson, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

JOHN ANDERSON.

HEREAS by Our Proclamation of November 9, 1915, We did establish the building known as the "Old Jail Buildings" at Ratnapura as a prison at Ratnapura aforesaid for the reception of prisoners of every description committed or remanded under the authority of the several courts of the Island:

And whereas it is expedient to revoke the said Proclamation:

Now know Ye that We, the Governor of Ceylon, in exercise of the powers vested in Us by section 5 of the Prisons Ordinance, No. 16 of 1877, as amended by section 1 of Ordinance No. 24 of 1890, and with the advice of the Executive Council, do by this Our Proclamation revoke the said Proclamation as from and after July 15, 1916.

Given at Colombo, in the said Island of Ceylon, this Fifth day of July, in the year of our Lord One thousand Nine hundred and Sixteen.

NOW Ye that We, the Governor of Ceylon, in exercise of the powers vested in Us by section 3 of "The Town Schools Ordinance, 1906," and with the advice and consent of the Executive Council, do hereby bring the provisions of the said Ordinance, as from and after the date hereof, into operation within the town of Kandy, the limits whereof are set out and defined in the schedule hereto.

SCHEDULE.

Limits of the Kandy Municipality.

North, the Mahaweli-ganga; east, the Mahaweli-ganga to a point 52 chains below the Lewella ferry, and thence a straight line drawn to the south-east corner of the Hermitage estate, thence along the eastern boundaries of the Hermitage and Fairieland estates (title plans 43,322 and 42,285); south and south-west, the southern and western boundaries of the Fairieland estate, thence from the south-west corner of the Fairieland estate along the watershed of the basin of the Kandy waterworks reservoir to the eastern boundary of the land acquired for a conduit, thence along the eastern boundary of the said conduit to the Hal-oya, thence along the Hal-oya and a portion of the northern boundary of the Richmond Hill estate to the western boundary of the Borowadeniya or the Ambagahakumbura paddy fields, thence along the western boundary of the said fields to the railway bridge over the Meda-ela to the slaughter-house, thence along Meda-ela to the railway bridge over the Meda-ela at Getambe, thence along the southern boundary of the railway line to the Mahaweli-ganga; west, the Mahaweli-ganga.

IT is hereby notified that His Excellency the Governor in Executive Council, in exercise of the powers vested in him by section 31 (1) of "The Excise Ordinance, No. 8 of 1912," and section 11 (1) (a) of "The Interpretation Ordinance, 1901," has been pleased to revoke Chapter II., Distillery Rules, of Excise Notification No. 9, dated May 16, 1913, and to make the following rules for the establishment and working of distilleries, and for regulating the issue of spirit therefrom.

It is hereby further notified that the said rules having been confirmed by a resolution of the Legislative

Council on June 14, 1916, shall take effect from July 1, 1916.

DISTILLERY RULES.

Chapter 1.—Introductory.

- 1. Application of Rules.—These rules shall apply to all distilleries in so far as they are not inconsistent with the terms of any special license granted to the distiller.
 - 2. Definitions.—In these rules, unless the contrary appears from the context-
 - "To gauge" means to determine the quantity of spirit contained in or taken from any receptacle, or to determine the capacity of a cask or other recentacle.
 - "To prove" means to test the strength of spirits by a hydrometer or other recognized means.
 - "Tariff rate" means the rate of import duty for the time being in force.
 - "Distillery Officer" means the officer appointed by the Excise Commissioner to the charge of a distillery.

Chapter 2.—Distilleries.

- 3. Application for License.—Any person desirous of obtaining authority to establish or work a distillery shall apply to the Government Agent, who will forward his application for the order of the Excise Commissioner. With their applications applicants shall file descriptions and plans of the buildings in which they propose to establish or work their distilleries, and shall state the description and capacity of the stills and other permanent apparatus which they propose to use. Any person applying for a license to establish a distillery shall paysuch fee as may be required by the Excise Commissioner. It will be open to the Excise Commissioner to verify at any time the description and plans above mentioned, and on preof of error to require fresh ones to be submitted. Such verification may be made by any officer not below the rank of Inspector deputed for the purpose, and such officer shall be allowed full access to the premises. A duplicate of the distillery plan approved by the Excise Commissioner shall be provided by the distiller to be filed in the Office of the Distillery Officer or Superintendent of Excise, Distillery Circle, as the case may be, and the original shall be kept in the distillery, and shall be open at any time to the inspection of any Excise Officer.
- 4. Alteration to the Buildings.—No alteration or addition shall be made in or to such buildings, or in or to such stills and other permanent apparatus, without the permission of the Excise Commissioner.
- 5. Capacity of Stills.—No license shall be issued for any still of less than 150 gallons capacity.
- 6. Distillery Building.—The distillery shall be enclosed by an external wall not less than eight feet in height to be securely constructed of masonry, corrugated iron, or good wattle and daub, and no openings, except openings for the exit of spent wash or waste water, shall be made except with the permission in writing previously obtained of the Excise Commissioner. The openings in the external wall for the exit of spent wash or waste water must be provided with iron gratings securely fixed into the wall. All other openings shall be covered with wire netting of a square mesh not exceeding one-fourth of an inch firmly secured to the framework inside. The distillery premises shall have only one means of ingress and egress, which shall consist of a pair of gates of equal height with the external/wall, constructed of sound wood well secured and battened, and so hung that they cannot be lifted off their hinges. In distilleries in which toddy is used as a base, the gates shall be locked internally while distillation is proceeding.

The storehouse attached to the distillery shall be securely constructed within the distillery premises with a tiled or corrugated iron roof, and shall be provided with only one door opening on the inner side of the distillery premises, and if there are any windows, these shall be covered with wire netting of a square mesh not exceeding one-fourth of an inch. The door of the storehouse shall invariably

be kept locked, except when transactions are actually in progress.

All vessels in a distillery shall be numbered, and their capacities clearly and correctly marked on them in oil paint in English, by the licensee.

7. Renewal of Distillery License.—A distillery license shall remain in force from the date of issue till December 31 next following, and an application for a renewal of the license shall be made if it is desired to work the distillery thereafter. Whenever any alterations are made by permission of the Excise Commissioner in the buildings or plant, fresh descriptions and plans of the distillery building must be filed, together with a certificate from the Distillery Officer or the Superintendent of Excise, Distillery Circle, that they are correct. Application for renewal shall be submitted to the Excise Commissioner through the Government Agent.

- 8.* Arrangements of Stills, &c. Distillers shall so arrange every still in their distilleries that its worm shall discharge into closed and locked receivers, to be provided by them and to be approved by the Excise Commissioner, of such description that no spirits can be removed from them until they are unlocked. They shall also provide and maintain suitable and secure fastenings to all stills, spirit receivers, fermentation rooms, doors, &c., to the satisfaction of the Excise Commissioner, for the attachment of locks to be provided by Government. But when locks are attached to any of the fittings to a distillery for the convenience of the distillers, and to save them the expense of making alterations, the cost of such locks shall be borne by them. The keys of all such locks will be retained by the Government officers in charge of the distilleries, but distillers will be at liberty to affix their own locks also on all stills, receivers, &c., on which Government locks are placed, provided that they shall always, on the requisition of the Government Agent, of the officers in charge of the distilleries, or of other superior officers of the Excise Department, immediately remove their locks so as to allow the free inspection of the stills and receivers on which, and of the rooms on the doors of which, such locks are placed, and of all the contents of such stills, receivers, and rooms.
- 9.* Distillers shall, if the Excise Commissioner so direct, provide between the still and the spirit receiver a glass "safe" by which the quality and the strength of the spirits which are running will at any moment be visible to the operator, or a sampling appearatus so constructed that for every sample drawn off an exactly equal quantity shall be discharged into a closed and locked receptacle. If desired, both a "safe" and a sample appearatus may be used. The distillers shall also, if so required, provide branch pipes fitted with cocks by means of which spirits of different strengths and qualities may be diverted into separate receivers.
- 10.* (a) Two or more receivers shall be fitted to every still so that the distillers may be able to divide the spirits discharged from a still into different lots, according to their strength or quality, without requiring the presence of the officer to unlock cocks.

(No) But when there are two or more pot stills, any number may discharge into one weak spirit receiver, provided each still has a separate receiver for strong

spirit.

- 11.* Distillers shall so arrange their spirit receivers and store vats that the spirits may be conveyed through closed pipes from the former into the latter by gravitation, er, where this is not practicable, shall provide apparatus whereby the spirits can be pumped from the former to the latter through closed pipes.
- 12.* All receivers and vats in the distillery shall be so placed as to admit of the contents being accurately gauged or measured, and must be fitted to the satisfaction of the Excise Commissioner with proper dipping rods so adjusted to fixed dipping places that the contents may at any time be ascertainable. The receivers and vats shall also be gauged in such manner as the Excise Commissioner may from time to time direct; and no vessel shall be used as a receiver or store vat until it has been gauged, and the gauging has been checked by such officer as the Excise Commissioner may appoint.
- 13. Spirit to be kept in Store.—No spirit shall be allowed to remain in any part of the distillery premises other than the store, or in the case of distilleries using molasses or sugar as the base, the store and the receivers.
- 14. Supervision of Distilleries.—Distilleries shall be under the immediate supervision of the Distillery Officer or Superintendent of Excise, Distillery Circle, who will carry out the provisions of these rules either in person or through his subordinates, as the Excise Commissioner may from time to time direct. Provided that nothing herein contained shall be held to prevent Government Agents and other officers vested with the powers of Government Agents under the Excise Ordinance from inspecting distilleries, or to prevent Government Agents from issuing such orders relating thereto as they shall from time to time see fit, subject to the approval and confirmation of the Excise Commissioner.
- 15. The Excise Commissioner to appoint Officers to the charge of the Distillery.—The Excise Commissioner will appoint such officers of the Excise Department as he may see fit to the charge of the distilleries. Distillers shall provide such office furniture as may be required for the use of such officer within the distillery. If a distillery is established at any place where suitable quarters for such officer or officers as also for the required peons are not available or are not to be hired at reasonable rates, the distiller shall provide quarters for them to the satisfaction of the Excise Commissioner at rates not exceeding those quoted below. In case any question should arise as to whether the rent demanded by the owner of such quarters is just and reasonable, taking into consideration the nature and sufficiency of the accommodation, the question shall be referred to the Excise Commissioner, whose decision thereupon shall be final and binding on the distiller. The distiller shall be bound to keep the quarters and their appurtenances in proper repair, and not to interrupt or annoy any officer residing therein in his use or enjoyment thereof:—

16. Government not liable for loss, &c., of Spirits in Distilleries.—Government shall not be held responsible for the destruction or loss of, or damage to, any spirit stored in any distillery by fire or theft, or by gauging or proof, or by any other

cause whatever. In case of fire or other accident Distillery Officers shall immediately attend to open them at any hour by day or night.

- 17.* Preparation of Wash. Wash not to be removed.—No wash shall be prepared except within the distillery, nor shall any wash be on any account removed from the distillery, and all wash shall be kept, if so required, in such places as the Excise Commissioner may approve. Distillers must see that the saccharine materials used by them are thoroughly dissolved when they set up the wash, submit a declaration in writing in the prescribed form to the Distillery Officer giving the actual saccharometric gravity corrected for temperature before fermentation commenced and the total quantity of wash made, and must generally afford him all the information which he may require bearing on the question of the practicability of levying a charge based on the attenuation of wash.
- 18. Noxious Materials not to be used.—The materials to be used in distilling shall be toddy, or such other material as shall be specially permitted by the Excise Commissioner, and shall be of good quality, and no ingredients noxious to health shall be used in distillation, or be put into the spirits stored in a distillery or storehouse, or added to such spirit before issue elsewhere.
- 19.† Tapping of Palm Trees for Distilleries.—No toddy-producing palm shall be tapped for supplying a distillery until a license for the purpose has been issued by the Superintendent of Excise of the Circle in which the trees are situated, and the trees for this purpose marked in such manner as may be ordered by the Excise Commissioner. All toddy drawn under these licenses shall be transported under cover of special permits to be granted by the said Superintendent to the distillery for which the trees have been licensed, and no toddy shall on any account be removed from the distillery.
- 20. Distillers to give Security.—Any distiller shall, if required, make and keep a deposit of Rs. 500 with the Government Agent as security for the due observance of the conditions of the license.
- 21. Employment of Women and Children prohibited.—No child under the age of 16 years and no woman shall be employed in the distillery.
- 22. Admittance into Distilleries of Persons not having Business therein forbidden.— Except with the permission of the Distillery Officer or Superintendent of Excise, Distillery Circle, no one except officers of the Excise Department, the licensee and his servants registered as hereinafter provided, and licensed vendors or their servants or agents who have come to purchase spirit shall be allowed to enter the distillery premises on any pretext. A register in the form of A annexed shall be kept in the distillery by the licensee of the names of all servants employed in the distillery. Such servants shall at all times when within the distillery premises have with them passes signed by the Distillery Officer or Superintendent of Excise, Distillery Circle, and shall produce the same when called upon by an Excise Officer to do so.
- \$\notingsquare 23. Control over Persons entering Distilleries.—All persons entering a distillery shall be under the orders of the Distillery Officer or Superintendent of Excise, Distillery Circle, in respect of their conduct and proceedings within the distillery, and shall be liable to be searched, on their quitting the premises, at the discretion of the Distillery Officer or Superintendent of Excise, Distillery Circle.
- 24. Distillers bound to report Breaches of Law, &c., committed by their Servants.— If it comes to the knowledge of a distiller that any person employed by him has committed any breach of "The Excise Ordinance, No. 8 of 1912," he shall report the matter to the Distillery Officer or Superintendent of Excise, Distillery Circle, and shall comply with the directions of the said officer or Superintendent respecting the continued employment of such person.
- 25.* Distillers to furnish Inventory of Apparatus.—Distillers shall give to the Distillery Officer or Superintendent of Excise, Distillery Circle, an inventory of all the permanent apparatus which they may intend to take into use, and which was not entered in their original application, not less than two clear working days before they use any of them.
- 26. Cleanliness.—Strict cleanliness must be observed within the distillery premises. The ground must be kept bare, clear of grass, weeds, undergrowth, and rubbish. No stagnant water or muddy ground must be allowed to remain.
- 27.† Cleaning out the Worm, &c.—In the case of pot stills not less than once a week, and at any time when ordered by an Excise Officer not below the rank of Assistant Superintendent, the worm must be thoroughly cleaned out, and no copper salts must be allowed to accumulate in it. Part of the process of cleaning shall be emptying of the worm tub and the passing through the worm for not less than twenty minutes of steam obtained by boiling pure water in the still.
- 28. Accounts to be kept by Distillers.—(a) Distillers shall keep regular accounts in ink always up to date in the forms prescribed from time to time by the Excise Commissioner. The accounts shall in the case of distilleries using sugar or molasses as the base show the quantities and descriptions of the materials used each day, the quantities of wash and of spirits manufactured daily, the quantity of wash used daily, the quantity of spirits passed out, and the quantities of wash and of spirits in store. Such accounts shall be open at all times to the inspection of the Distillery Officer and of all superior officers of the Department.

N.B.—Spirits in distilleries shall at all times be open to gauging and proof by the Distillery Officer and of all superior officers of the Department.

^{*} These rules do not apply to distilleries using toddy as a base.

These rules apply only to distilleries using toddy as a base.

- (b) Distillers who use toddy as a base shall keep true and correct accounts in ink always up to date in the Forms B and C annexed, and shall on or before the 11th, 18th, 26th, and 3rd days of the month submit to the Superintendent of the Distillery Circle a true extract in Form C annexed of his transactions up to and including the 8th, 15th, 23rd, and last days of the month respectively. Such accounts shall be kept in the distillery, and always be open there to the inspection of and verification by all officers of the Excise Department not below the rank of Inspector.
- 29.* Pistillers to account for Deficiency in Stocks.—An account will be taken of the distillers' stocks at such intervals, not being greater than three months, and in such manner as the Excise Commissioner may direct. For wastage a quantity not exceeding 1½ per cent. shall be allowable, but on all spirit, in excess of such allowance, which may not be forthcoming, and for which the distillers shall be unable to account to the satisfaction of the Excise Commissioner, they shall pay to Government duty at the tariff rate. Wastage for the purpose of collection of duty on the excess as aforesaid shall be calculated annually, that is, at the end of the year for which the license is in force.
- 30.* Saving in case of Accident.—Provided that if it shall be proved to the satisfaction of the Excise Commissioner, or of such officer as he shall appoint, that such deficiency in excess of 1½ per cent. has been caused by accident or other unavoidable cause, the payment of duty at the above rate on such deficiency may be waived.
- 31.* Lights.—The use within the distillery of naked lights of any description is prohibited. Closed lanterns only shall be used.
- 32. Distillers to replace Deposits.—The Government Agent or Excise Commissioner may direct that the amount of any fine or penalty imposed by him, under the powers vested in him by Ordinance No. 8 of 1912 or by the rules framed thereunder, be deducted from the amount deposited by a distiller as security for the due observance of the conditions and rules, and any amount so deducted shall be replaced by the licensee within fifteen days from the date of receipt of a notice from the Government Agent or Excise Commissioner informing the distiller of such deduction having been made.
- J33. Removal of Spirits, &c., after Expiry of License.—On the expiry of his license (unless a fresh license shall have been granted him), or if his license shall be cancelled or suspended, every distiller shall be bound forthwith to pay the duty, if any, on, and to remove, all spirits remaining within the distillery; and if he shall fail to do so within ten days of the receipt of written notice from the Government Agent, the cost of any establishment which it may be necessary to employ at the distillery may be recovered from the defaulter. In the event of continued neglect the spirits shall be liable to be forfeited at the discretion of the Excise Commissioner.
- 34. Distillers bound to obey all Additional Rules.—Distillers shall be bound by all additional rules that may from time to time be framed for the management of distilleries, and shall cause all persons employed by them to obey all such rules.

Chapter 3.—Rules relating to issue of Spirits from Distilleries.

- 35. Spirits may be blended in Distilleries.—In order that they may be able to issue spirits at any required strength, distillers will be permitted to blend or reduce in the distillery spirits to the required strength.
- 36. Removal of Spirit from Distilleries and Payment of Duty.—Spirit may be removed from distilleries—
 - (a) For export.
 - (b) For transport to another distillery or to a warehouse.
 - (c) For local consumption:
 - (d) By officers of Government empowered to purchase or take possession of it on account of the Public Service.

Duty shall be paid before removal at the following rates on all spirits issued from distilleries, unless they are removed under bond or sold to officers of Government on account of the Public Service:—

- (1) If denatured, ad valorem at the rate of $5\frac{1}{2}$ per cent., or at such other rate as may be prescribed by any law for the time being in force.
- (2) If rectified, at the tariff rate.
- 37. Spirit not to be removed except under Pass.—No spirit shall be removed from any distillery save under cover of a pass issued by an officer duly authorized to issue passes for transport.
- 38.* Spirits to be gauged and proved before Removal.—No spirits shall be removed from any distillery until they have been gauged and proved by the officer appointed for the purpose. The gauging of spirits may be made either by actual measurement or by weighment.
- 39. Issue of Spirits.—The licensee, should be wish to send out spirit for export from Ceylon under bond, shall execute a bond for the payment of duty on such spirit at the tariff rate in case of his failure to account for such spirit to the satisfaction of the Excise Commissioner.

Unskilled labour required for gauging spirits (e.g., at the distillery or Customs) shall be supplied by the licensee as and when required.

^{*} These rules do not apply to distilleries using toddy as a base.

- 40. Minimum Quantity to be issued.—No smaller quantity of spirit shall be issued at any one time to any person under rule 36 than the following:—
 - (1) Spirit other than rectified or denatured:-

Under clause (a), 50 imperial gallons.

Under clause (b), 50 imperial gallons. Under clause (c), 35 imperial gallons.

To officers of Government for purposes mentioned in clause (d) supra, no limit.

(2) Rectified or denatured spirit:

Under clause (a), 50 imperial gallons.

Under clause (b), 50 imperial gallons.

Under clause (c) 5 gallons.

Under clause (d), no limit.

- 41. Samples of Spirit to be taken free of cost for Analytical purposes, &c.—Distillers shall allow samples of all spirit distilled in any licensed distillery to be taken free of cost at any time by any officer of the Excise Department not below the rank of Inspector.
- 42. Allowances for loss by Leakage, Evaporation, &c.—(i.) An allowance will be made for the loss in transit by leakage and evaporation of spirits transported under bond to Colombo, or for export, or issued duty free for Government purposes up to the maximum amounts shown below:—

For a journey of not greater duration than 2 days	 2
For a journey of duration exceeding 2 but not exceeding 5 days	 3
For a journey of duration exceeding 5 but not exceeding 10 days	 4
For a journey of duration exceeding 10 but not exceeding 15 days	 5
For a journey of duration exceeding 15 days	 7}

In calculating the allowance to be made, the day of issue, the time actually occupied in transit, and the day of receipt are to be taken into account.

(ii.) If the report of the officer by whom the consignment of spirits transported under bond or duty free has been gauged and proved on arrival at its destination should show that wastage to a greater extent than the above has occurred, the distiller shall pay duty at the tariff rate for the time being in force on so much of the deficiency as is in excess of the above allowances. Provided that if it shall be proved to the satisfaction of the Excise Commissioner that such deficiency has been caused by accident or other unavoidable cause, the duty levied on such deficiency shall be refunded. The Excise Commissioner's decision shall be final.

in each cask or receptacle comprised in the consignment.

.43. Appeal.—Except as otherwise provided, all orders passed under these rules by officers of the Excise Department shall be subject to appeal to the Excise Commissioner within fourteen days from the date on which the order passed was received. The decision of the Excise Commissioner on any such appeal shall be final.

Chapter 4.—Rules relating to Denatured Spirit.

- 44. Definition.—Denatured spirit is spirit rendered effectually and permanently unfit for human consumption by the admixture of such denaturants as may be from time to time approved by the Excise Commissioner.
- 45. Payment of Duty.—Denatured spirits when sold for consumption in Ceylon are liable to a duty of 5½ per cent. ad valorem, payable on the quantity issued from the distillery; the duty will be calculated on the declared issue price of such consignment at the distillery. Distillers should when applying for a permit declare the sale price of the spirit at the distillery for the purpose of calculating the ad valorem duty. They should also either produce a receipt for the payment of the duty into a Government Kacheheri, or should authorize the Distillery Officer to deduct the duty from their advance deposit at the Kacheheri, if any.
- 46. Conditions of Manufacture.—Denatured spirit may be manufactured by specially licensed holders of distillery licenses in the Island, provided (1) that only such denaturants as are first approved by the Excise Commissioner are used, (2) that such denaturants should be kept under lock and key by, and used under the supervision of, the Distillery Officer, (3) that the denaturants must be used in the proportion fixed by the Excise Commissioner, (4) that the spirit must not be of a less strength than 50 degrees over proof or such other strength as may be prescribed by the Excise Commissioner, and (5) that the Distillery Officer may send samples of the result for final test before issue.

The tenders are to be made upon forms which will be supplied upon application at the Office of the General Manager of the Railway, and no tender will be considered

- unless it is on the recognized form.

 6. A deposit of Rs. 10 will be required to be made either at the Treasury or Kachcheri, and a receipt produced for the same before any form of tender is issued. Should any person decline to enter into the contract and bond, or fail to furnish approved security, within ten days of receiving notice in writing from the Head of the Department, or his duly authorized representative, that his tender has been accepted, such deposit will be forfeited to the Crown, and the defaulter will render himself liable to be included in the list of defaulting contractors precluded from having any concern in a Government contract. All other deposits will be returned upon signature of a contract.
- 7. The amount of security required will be a month's rent in cash. All other necessary information can be ascertained upon application at the office referred to in section 5.
- 8. The security should be furnished within ten days of acceptance of tender being notified.

- 13. No tender will be considered unless in respect of it all the conditions above laid down have been strictly fulfilled, and any offers received containing conditions not mentioned herein will be rejected without question.

14. The Government reserves to itself the right, without question, of rejecting any or all tenders, and the right of

accepting any portion of a tender.

15. Before tender forms are supplied to persons wishing to tender, they will have to satisfy the General Manager or person delegated by him that they are in a position to execute the contract in a satisfactory manner, and for this purpose they must be prepared to produce documentary or other evidence if called for.

16. No structure of any kind will be allowed to be

erected on the platform.

17. A Government contractor must not issue a power of attorney to a person whose name is in the defaulting contractors' list authorizing him to carry on the contract.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended July 1, 1916.

Births.—The total births registered in the city of Colombo in the week were 78 (1 European, 9 Burghers, 38 Sinhalese, 6 Tamils, 19 Moors, 4 Malays, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1916, viz., 255,354) was 16.0, as against 20.7 in the preceding week, 16.4 in the corresponding week of last year, and 22.7 the weekly average for last year.

Deaths.—The total deaths registered were 145 (1 European, 5 Burghers, 71 Sinhalese, 30 Tamils, 27 Moors, 4 Malays, and 7 Others). The death-rate per 1,000 per annum was 29.7, as against 28.9 in the previous week, 25.3 in the corresponding week of last year, and 25.8 the weekly average for last year.

Infantile Deaths.—Of the 145 total deaths, 26 were of infants under one year of age, as against 14 in the preceding week, 29 in the corresponding week of the previous year, and 29 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 6.

Principal Causes of Death.—Twenty deaths from Phthisis were registered, as against 15 in the previous week and 15 the weekly average for last year. Of these, 9 were in Maradana (including 4 deaths of non-residents in hospitals), 3 in Kollupitiya, 2 in Kotahena, 2 in Slave Island, 1 in San Sebastian, 1 in St. Paul's, 1 in New Bazaar, and 1 in Wellawatta.

- 2. Sixteen deaths from *Pneumonia* were registered, as against 14 in the previous week and 11 the weekly average for last year. Of these, 5 were in Maradana (including 2 deaths of non-residents in hospitals), 4 in Slave Island, 2 in San Sebastian, 2 in Kotahena, 1 in Fort and Galle Face, 1 in St. Paul's, and 1 in New Bazaar. One death from *Bronchitis* was registered.
- 3. Eleven deaths from *Plague* were registered, as against 5 in the previous week and 2 the weekly average for last year. Of these, 4 were in Slave Island, 3 in San Sebastian, 3 in Maradana, and 1 in St. Paul's. Thirteen cases were reported, as against 12 in the previous week.
- 4. Four deaths from *Enteric Fever* were registered, as against 3 in the previous week and 3 the weekly average for last year. Of these, 2 were in Maradana (including a death of a non-resident in hospital), 1 in Kotahena, and 1 in New Bazaar.
- 5. Ten deaths from Enteritis were registered, 8 from Infantile Convulsions, 6 from Debility, 6 from Dysentery, 5 from Worms, 4 from Diarrhea, 1 from Tetanus, and 53 from Other Causes.
- 6. There were reported 52 cases of *Measles*, as against 25 in the previous week; and 30 cases of *Chickenpox*, as against 25 in the previous week. One case of *Cholera* was also reported.

State of the Weather.—The mean temperature of air was 81.0°, against 80.6° in the preceding week and 81.6° in the corresponding week of the previous year. The mean atmospheric pressure was 29.902 in., against 29.832 in. in the preceding week and 29.868 in. in the corresponding week of the previous year. The total rainfall in the week was 0.04 in., against 2.70 in. in the preceding week and 2.40 in. in the corresponding week of the previous year.
