NOTICE is hereby given that on Tuesday, October 17, 1916, at 1 P.M., the Government Agent, Southern Province, will put up to auction, at his office at the Galle Kachcheri, the right to dig for plumbago in the under-mentioned Crown land in the Galle District, and supposed to contain plumbago, for a period of five years on the following conditions:—

(a) The lease will include the right of mining for plumbago only, and will be for a period of five years only at the yearly ground rent of Rs. 10 per acre per annum, and subject to the covenants and conditions as sanctioned by Government, copy of which can be obtained at the Kachcheri. The highest bidder for the lease of the above-mentioned allotment shall be the purchaser, provided that the price offered by him amounts at least to the upset price as stated against the lot in column 4.
