MINUTE BY THE GOVERNOR.

HIS EXCELLENCY THE GOVERNOR has been pleased, with the approval of the Secretary of State for the Colonies, to direct the publication of the following Minutes in substitution for the Minutes dated November 7, 1913:—

Minute on the Ceylon Civil Service.

1. The Civil Service will in future consist of all officers who shall have been permanently appointed (and confirmed by the Secretary of State) to any of the classes enumerated in the annexed list:—

2. Officers will be appointed to a particular class instead of to a particular appointment, and all the officers are interchangeable within their respective classes.

3. The Governor will have power to interchange officers of the various classes *inter se*.

4. When an officer is gazetted to act in a higher class or grade than that to which he belongs, he may draw half the initial salary of the class or grade in which he is appointed to act, provided it is available, and half his substantive salary.

5. Salaries will be paid in Ceylon in rupees at a rate of exchange periodically fixed and proclaimed. Leave pay and pension will be calculated according to the sterling salaries fixed by this Minute.

6. Officers who have been permitted with the sanction of the Secretary of State to remain on a rupee salary, with the privilege of retaining their special rates of exchange for pension and leave purposes, will draw the following salaries :—

(No officer below Class III. remains on a rupee salary.)

7. When such officers as those mentioned in the preceding section are appointed to officiate in a higher class, they will draw half the initial rupee salary of the class and half their substantive salary.

8. The offices of Colonial Secretary, Treasurer, and Director of Education will not ordinarily be filled by promotion from the Civil Service.

9. Subject to the reservation of a certain number of posts for the Local Division of the Civil Service made in the accompanying Minute, all other vacancies will ordinarily be filled by promotion within the Civil Service, but in the event of there being no member of the Civil Service competent to fill any particular vacancy, or of peculiar circumstances requiring such a measure, the Secretary of State will give directions for filling the vacancy otherwise.

10. In no case will promotion from one class to another be merely by seniority, and in the case of promotion to or within the First Class, length of service will be accounted quite a secondary consideration.

Similarly, seniority will constitute no claim for selection to an appointment to officiate in a higher class.

11. Before a Civil Servant is recommended to the Secretary of State for promotion to Class II., he will be required to satisfy the Governor that he has kept up a colloquial knowledge of the vernaculars.

12. (i.) Government Agents will be exempted from paying rent for their official quarters.

(ii.) The Assistant Government Agent, Nuwara Eliya, will receive a station allowance of £100 per annum.

13. An officer of Class II. who remains for over three years on the maximum salary of that class will be eligible for an additional increment of £100 per annum, provided it is certified that he is fully qualified for promotion, and has only failed to receive it because no vacancies have occurred in Class I.

CADETSHIPS IN THE CIVIL SERVICE.

14. Cadets, who must be natural born British subjects of European or Asiatic descent, are selected by open competitive examination* held by the Civil Service Commissioners, to whom all inquiries on the subject should be addressed.

The examination for these appointments will, as a rule, be held in the month of August in those years in which vacancies have occurred, simultaneously with the examination for the Civil Service of India. Candidates must be between the ages of 22 and 24 on the 1st day of August in the year in which the examination is held.

15. The salary of a Cadet commences at the rate of £300 a year. A free passage is granted, and half salary is allowed from the date of embarkation, and full salary from that of arrival in the Colony. A bond must be entered into by each Cadet with the Crown Agents for the Colonies, to secure that—in case of his dismissal, or in case he shall within three years from the date of his arrival in Ceylon either quit the Colony without leave or relinquish his appointment (except on account of ill-health)—he shall, if required by the Governor, repay to the Colony the cost of his passage out.

EXAMINATIONS FOR CADETS AND BEFORE PROMOTION TO CLASS III.

First Examination.

16. Every Cadet will be required, before he can receive a substantive appointment, to pass an examination in the subjects hereinafter specified, and further to obtain a certificate from an officer approved by the Governor that he can ride well, and that he is able to perform journeys on horseback. If he pass at or before the examination occurring not later than 21 months from the date of his being attached to one of the Public Offices, his rank in the Service will count from the date of his appointment as Cadet. Otherwise his claim to count his service will be deferred; and should he fail to pass within three years from his being attached, his pay will be withdrawn, and the Secretary of State will be recommended to cancel his appointment.

Pundit Allowance.

17. In order to facilitate the study of the native languages all Cadets will, from the date of their being placed on the permanent staff, receive a pundit allowance of Rs. 30 a month during twenty-one months. Such allowance will be drawn by the Cadet only on his certificate that the teacher has been actually and *bona fide* employed. During these twenty-one months of study Cadets will be attached to one of the Public Offices, which they will be required to attend for a certain time each day, as may be directed by the Governor, in order to give them an opportunity of learning the details of public business without interfering with their reading. In the event of an officer passing all his examinations in the native languages before he has drawn the pundit allowance for twenty-one months, he will be allowed to draw, as a bonus, the difference between the amount already drawn by him as pundit allowance and the maximum prescribed, viz., Rs. 630.

18. Any Cadet who is of Sinhalese, Tamil, or Eurasian parentage will be required to take up for his first examination whichever of the native languages has not been spoken by, or familiar to, him as a child, and will only be allowed to draw pundit allowance during ten months.

Horse Allowance.

19. To assist Cadets in procuring horses and maintaining them, the Government will be prepared to make an advance for the purchase of a horse, repayable in monthly instalments, and will also grant to each Cadet a horse allowance of Rs. 45 per mensem for twenty-one months.

Promotion of Cadets to Class IV.

20. A Cadet who has passed the first examination (as described in paragraph 16 above), and who has completed three years' service dating from his assumption of duties in Ceylon, may be placed in Class IV., even if there are no vacancies in that class.

21. A Cadet who has been appointed subsequently to May 15, 1914, will not be promoted to Class IV. until he has served at least two years as a Cadet and has passed the prescribed examinations.

Second Examination.

22. Gentlemen in the Civil Service will be required, before they can be promoted to the Third Class, to pass a second examination of the character hereinafter described. The promotion from the Third Class will be deferred, in the case of gentlemen who fail to pass their second examination within six years from the date of their being attached to one of the Public Offices, to that of those who shall have passed within that period and have entered the Third Class before them.

Scheme of Examinations.

23. The subjects of examination will be the Native Languages (Sinhalese and Tamil), Law, and the System of Accounts employed in the Government Offices.

24. At their first examination candidates will be examined in Sinhalese or Tamil (whichever they may prefer), in Law, and in Accounts; at their second, in Law, Accounts, and both languages; and in this second examination candidates may take up the various subjects, if they so desire it, in four sections at four separate periods, section (a) consisting of Law; section (b) consisting of Accounts; section (c) consisting of the language taken up by them at their first examination; and section (d) consisting of their second language.

25. The subjects and scheme of both the first and second examinations will be as follows:—

I.—NATIVE LANGUAGES.

(i.) In the *first* examination the candidate is required to write an English translation of two short Sinhalese or Tamil letters or reports from headmen, written in different running hands. He is required to translate a short English judgment or other official paper into Sinhalese or Tamil; to dictate offhand the translation into Sinhalese or Tamil of an English report or other official paper to a native, who will take it down in writing; to read and translate an extract from a Sinhalese or Tamil newspaper and from the proceedings of a Gansabhawa case put into his hands for the first time; to answer a few plain grammatical questions on declensions, conjugations, and compound words; to read, construe, and parse in English any easy sentence in Sinhalese or Tamil that may be set by the examiner; and to be tested in conversation so as to satisfy the examiner as to his power of understanding natives of different classes, and of making himself understood by them, both in common conversation and in the usual course of official business.

(ii.) The marks required for a pass in this first examination will be 40 per cent. in conversation and in newspaper reading respectively, and a total of 33 per cent. in all subjects.

(iii.) The *second* examination will be similar in its nature to the first, but more difficult in degree. The candidate will be required to act as an interpreter between the examiner and natives perfectly ignorant of English; the interpretation to be on matters connected with some ordinary civil or criminal case.

(iv.) The marks required for a pass in this second examination will be 60 per cent. in conversation and in newspaper reading respectively, and a total of 50 per cent. in all subjects.

II.—LAW.

(i.) Candidates will be examined in the following subjects:—

For the First Examination.

- (1) Penal Code.
- (2) Criminal Procedure Code.
- (3) Contracts.
- (4) Evidence.
- (5) Civil Procedure Code—Part I., Chapters I. to XXIII. (First Paper), and Chapter LXVI. (Court of Requests).

For the Second Examination.

- (1) Evidence.
- (2) Law of Persons, Property, and Things.
- (3) Law of Contracts.
- (4) Law of Torts.
- (5) Civil Procedure, including Insolvency and Administration.

Note.—The papers on Evidence and Contracts in the second examination will be of a higher standard than those set in the first examination.

(ii.) Candidates will be required to obtain a minimum of 33 per cent. on each subject and 40 per cent. on the total marks in the first examination, and a minimum of 40 per cent. on each subject and of 50 per cent. on the total marks in the second examination.

III.—ACCOUNTS.

(i.) The subjects of examination will be, for both the First and Second Examination :—

(1) Ceylon Financial Orders, consisting of Part I., General Regulations for the Guidance of Financial and Accounting Officers in the Colonial Service. Part II., Local Financial Regulations.

(2) The Estimates of the current year, *e.g.*, their arrangement, the heads of revenue, &c.

(3) Any Ordinances relating to specific accounts.

(ii.) Candidates will be required to obtain 40 per cent. of the total marks for a pass in the first examination, and 75 per cent. in the second examination.

IV.—RIDING EXAMINATION.

(i.) Candidates will be required to satisfy the examiners—

(a) That they can perform a journey of about 8 miles on horseback at the rate of 6 miles an hour; *i.e.*, trotting 2 miles and walking 1 mile alternately, without unduly distressing themselves or their horses.

(b) That they can saddle and bridle a horse correctly and promptly, and that they can arrange the various parts of saddle and bridle (Civilian pattern) after they have been disarranged.

Note.—Candidates will be allowed the use of stirrups, and will not be tested in jumping.

(ii.) The examination will take place on the morning of one of the days fixed for the quarterly Civil Service examination.

(iii.) Due notice of the exact day and hour for holding the examination will be given to candidates after their applications have been received.

Minute on the Local Division of the Ceylon Civil Service.

1. The Local Division of the Ceylon Civil Service will be recruited by competitive examination open only to candidates nominated by the Governor. Candidates must be British subjects born in Ceylon and belonging to families permanently resident in the Island.

2. Nominations will be limited to candidates who have passed the Senior Standard of the Cambridge Local Examination, London Matriculation, or any other public examination which may be deemed to be of an equally high standard.

3. (i.) Except as provided in the following sub-section of this paragraph, every candidate must satisfy the examiners that he was not less than 19 and not more than 23 years of age on the first day of January in the year in which the examination is held, and also that he is duly qualified in respect of health and character.

(ii.) A candidate who is in Government service may be allowed to deduct from his actual age any time spent in such service up to a maximum of seven years. Every such candidate must therefore furnish satisfactory proof that he was not less than 19 and not more than 30 years of age on the first day of January in the year in which the examination is held, and that his service under Government is not less than the period by which his age on that first day of January exceeds 23 years.

(iii.) Candidates must be of sound constitution, possessed of good sight, and otherwise physically qualified for service, and they will be called upon to undergo a medical examination to test these points.

4. The examinations (with the exception of those in the vernacular languages) will be conducted by the Civil Service Commissioners.

5. The fees required from candidates are Rs. 25 for the competitive examination and Rs. 10.50 for the medical examination.

6. Members of the Local Division will be eligible for appointment to the following offices in the Ceylon Civil Service, *viz.*, 3 in Classes I. and II. conjointly (the Governor deciding as occasion arises how many shall be in Class I. and how many in Class II.), 6 in Class III., 10 in Class IV., and 6 Cadetships.

7. All officers appointed to the Local Division will serve for the first two years on probation, irrespective of such term as they may serve as Cadets. The 10 appointments in Class IV. and the 6 Cadetships referred to in section 6 above will be reserved for members of the Local Division. Their promotion to the other posts referred to in that section will be in accordance with the general regulations governing such promotion as laid down in this Minute, but so that the number of Local Division officers holding posts in any class at any one time does not exceed

the total number as stated in section 6 of the present Minute. No member of the Local Division will be promoted unless he shows special fitness for promotion. Should there be no member of the Local Division showing special fitness for promotion, the vacancy will be filled from the Higher Division or otherwise as directed by the Secretary of State.

8. Members of the Local Division will be graded for purposes of promotion with the members of the Higher Division in one list, and will take seniority according to the date of their entrance into existing classes, the letters L. D. being attached to their names.

9. Cadets and officers of Class IV. in the Local Division will be required to pass the examinations specified in paragraphs 16-25 of the Minute on the Civil Service in order to qualify for promotion.

Minute on Class V. of the Ceylon Civil Service.

1. The Governor will have the power, subject to the approval of the Secretary of State, of appointing occasionally to a Fifth Class of the Civil Service, without examination, members of the Government service possessing aptitude for public business. In appointing such men regard will be had to their ability, social standing, high reputation, and long experience. After appointment they may be required to pass whatever examination in Law, Accounts, and Native Languages may be prescribed for each by the Governor, and within such period as may be prescribed.

2. The Fifth Class will comprise the following offices:—

Office Assistant to the Colonial Secretary.
First Deputy Registrar, Supreme Court.
Assistant Registrar-General.
Secretary and Librarian, Colombo Museum.
Office Assistant to the Director of Education.
Third Landing Surveyor, Colombo Customs.
Two Office Assistants in Provincial or District Kachcheries.
Chief Appraiser, Colombo Customs.

3. The salary of the class will be £300 to £400 per annum by annual increments of £25.

4. An officer in Class V. will be eligible for promotion to a vacancy in a higher class, provided (a) that he passes the prescribed examinations, (b) that he is specially qualified for the vacant post, and (c) that no Cadet of the Higher or Local Division is at the time of the occurrence of the vacancy equally well fitted.

BY-LAWS REFERRED TO.

1. Every laundry situated within Local Board limits must be registered by the Chairman of the Board, each subsequent change of address to be notified to him within one week.
2. No soiled linen shall be stored in any living apartment. The Chairman shall, when he considers it necessary in the interest and for the preservation of the public health, allocate special sites for the washing of clothes. Such sites will be indicated by a notice board.
3. When any washerman or any member of his family or household shall suffer from any infectious disease, he shall within 24 hours report the same to the proper authority, either through the Sanitary Inspector or the Police Headman.
4. No laundryman shall receive soiled linen from any house in which he is aware that a member thereof is suffering from an infectious disease.
5. Every laundryman shall when called upon by proper authority give a list of his customers.
6. Contravention of any of the foregoing by-laws shall be a punishable offence in a court of law.

NOTICE TO IMPORTERS.

Certificates of Interest and Origin.

THE *Government Gazette* notices dated February 5, 1915, March 12, 1915, March 31, 1915, August 20, 1915, March 28, 1916, May 19, 1916, and May 30, 1916, relating to Certificates of Origin, are hereby cancelled.

With reference to section 3 of Ordinance No. 2 of 1916, the attention of all importers is called to the following amended regulations, which will be enforced on and after November 1 next :—

1. Certificates of *Interest and Origin* will be required for all goods (subject to the exceptions noted in paragraph 12 below) imported from Norway, Sweden, Denmark, Holland, and Switzerland.

2. Certificates of *Interest* will be required for all goods, without exception, imported from any other foreign country, except France, Italy, Russia, Portugal, Roumania, Japan, China, Siam, United States of America, and Hayti.

3. There is no limitation of value. Certificates will be required for all consignments, however small they may be, subject to the exception referred to in paragraph 1. Goods sent by parcel post will require certificates in the same way as other consignments.

4. Certificates should be in the form of the annexed specimens.

5. Certificates in accordance with the above regulations will be required in respect of goods consigned to a port in this Colony—

(a) Which have passed through a port in the United Kingdom on a direct Bill of Lading, or have been transhipped at a port in the United Kingdom on a through Bill of Lading.

(b) Which have been shipped to a port in the United Kingdom on a Bill of Lading and have been entered for transhipment to a port in this Colony.

(c) Which, on arrival at a port in this Colony, are entered for transhipment to a foreign port, or to a port in Egypt, Canada, or Newfoundland.

6. In the case of goods which have been imported into the United Kingdom and subsequently exported Certificates of Interest or of Interest and Origin will not be required, but importers must produce with the relative entries for such goods a copy of the "Specification for Foreign and Colonial Merchandise" (Form 30) or Shipping Bill (Form 64), as the case requires, duly stamped and signed by the United Kingdom Customs Authorities. This document will not be required in the case of goods exported from the United Kingdom by parcel post. This regulation applies, *mutatis mutandis*, to goods re-exported to Ceylon from British Possessions.

7. In the case of goods falling under paragraph 5 (c) above, the work of transhipment shall not be commenced until the required certificates, together with the necessary deposit, shipment or direct transhipment applications, as the case may be, have been produced before the proper Customs Officer, and permission for transhipment has been specifically granted.

8. In the absence of the required document, goods arriving at a port in this Colony are liable to be detained by the Principal Collector of Customs until the requisite document is produced. The Principal Collector of Customs is, however, authorized in such cases, and at his discretion, to allow delivery of the goods on the security of a deposit, or of a bond to the amount of three times the value of the goods, to be forfeited if the necessary document is not produced within the period prescribed by him.

9. Statutory *Declarations of Origin* will not be accepted in place of the documents required by these regulations.

10. No goods of enemy origin may be imported into Ceylon, except under license, until the Customs Authorities have been satisfied by the importer that such goods left enemy territory before the outbreak of war.

11. The importation of Belgian goods will continue to be governed by the notice of February 23, 1916, published in the *Government Gazette* of March 3, 1916.

NOTICE TO EXPORTERS.

THE attention of exporters is directed to the various Ordinances and Proclamations relating to the prohibition and restriction of exportation and to trading with the enemy.

2. With a view to preventing breaches of the law, the Principal Collector of Customs, under section 2 of Ordinance of 1916, will require declarations of ultimate destination to be presented in respect of all goods, wares, or merchandise (without regard to the value of consignments) exported from Ceylon in trade with any foreign place in Europe, or on the Mediterranean or Black Seas (with the exception of those situated in Russia and France), or to any place in China and Siam.

3. The declarations must be in the form prescribed by the schedule hereto. A single declaration of ultimate destination may be used to cover any number of consignments by the same exporter from the same port by the same ship at the same time.

4. Attention is invited to the fact that where a declaration of ultimate destination is signed or a license is granted for the export of prohibited or restricted goods, the declaration or license do not relieve the owner of the goods or the consignor from any responsibility to which he may be liable for any breach of law or regulations, e.g., the law relating to trading with the enemy. It is therefore incumbent on persons before signing declarations

or applying for licenses to take all reasonable steps to satisfy themselves that the ultimate destination and intended use of the goods are unobjectionable. Failure to do so may involve serious consequences, and will certainly entail most careful consideration of any further applications for export licenses.

5. The Notifications of February 5, March 12, and December 28, 1915, and March 28, 1916, relating to declarations of ultimate destination, are hereby cancelled.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended September 30, 1916.

Births.—The total births registered in the city of Colombo in the week were 93 (7 Burghers, 53 Sinhalese, 15 Tamils, 7 Moors, 8 Malays, and 3 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1916, viz., 259,451) was 18·7, as against 22·6 in the preceding week, 20·3 in the corresponding week of last year, and 22·7 the weekly average for last year.

Deaths.—The total deaths registered were 146 (2 Europeans, 11 Burghers, 54 Sinhalese, 30 Tamils, 38 Moors, 1 Malay, and 10 Others). The death-rate per 1,000 per annum was 29·4, as against 26·0 in the previous week, 27·0 in the corresponding week of last year, and 25·8 the weekly average for last year.

Infantile Deaths.—Of the 146 total deaths, 31 were of infants under one year of age, as against 22 in the preceding week, 19 in the corresponding week of the previous year, and 29 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 8.

Principal Causes of Death.—Nineteen deaths from *Pneumonia* were registered, as against 13 in the previous week and 11 the weekly average for last year. Of these, 7 were in Maradana, 4 in San Sebastian, 2 in Kotahena, 2 in New Bazaar, 2 in Slave Island, 1 in St. Paul's, and 1 in Kollupitiya. One death from *Bronchitis* was registered.

2. Fourteen deaths from *Phthisis* were registered, same as in the previous week, against 15 the weekly average for last year. Of these, 5 were in Maradana (including 2 deaths of non-residents in hospitals), 3 in St. Paul's, 2 in New Bazaar, 1 in San Sebastian, 1 in Kotahena, 1 in Slave Island, and 1 in Wellawatte.

3. Eight deaths from *Plague* were registered, as against 6 in the previous week and 2 the weekly average for last year. Of these, 3 were in San Sebastian, 3 in St. Paul's, 1 in Kotahena, and 1 in New Bazaar. Eight cases were reported; as against 4 in the previous week.

4. Five deaths from *Enteric Fever* were registered, same as in the previous week, against 3 the weekly average for last year. Of these, 2 were in Kotahena, 2 in Maradana (including 1 death of a non-resident in hospital), and 1 in Slave Island.

5. One death from *Measles* was registered in New Bazaar. None were registered in the previous week. There were reported 23 cases of *Measles*, as against 25 in the previous week; and 4 cases of *Chickenpox*, as against 9 in the previous week.

6. Fifteen deaths from *Infantile Convulsions* were registered, 9 from *Debility*, 8 from *Enteritis*, 5 from *Dysentery*, 3 from *Diarrhoea*, 3 from *Worms*, 1 from *Tetanus*, and 54 from *Other Causes*.

State of the Weather.—The mean temperature of air was 80·7°, against 81·3° in the preceding week and 80·2° in the corresponding week of the previous year. The mean atmospheric pressure was 29·871 in., against 29·861 in. in the preceding week and 29·855 in. in the corresponding week of the previous year. The total rainfall in the week was 1·20 in., against nil in the preceding week and 2·12 in. in the corresponding week of the previous year.
