**THE LAND ACQUISITION (AMENDMENT) ACT,

I hereby give notice under Sub-section (1) of Section 7, of Land Acquisition Act, No. 28 of 1964 (Amendment) that the Government intends to acquire the following land which is required for a public purpose.

*Description of the land to be acquired :*
