WESTERN PROVINCE.

COLOMBO DISTRICT.

Yala season : nil.

Maha season : in some divisions paddy is being reaped, and in some places the cultivation is thriving well.

Other products : flowering and prospects of coconuts are fairly good. The estimated crop for the month is 21,138,505 nuts. Fruits and vegetables are to be had in fair quantity.
