SEASON REPORTS FOR THE MONTH OF FEBRUARY, 1917.

SOUTHERN PROVINCE.

GALE DISTRICT.

The maha crop was being reaped and harvested.

Dry grain is not cultivated in the district to any appreciable extent.

Coconut, tea, rubber, cinnamon, citronella, and vegetables are the general products. The estimated coconut crop for the month was 11,655,628. Vegetables produced in some parts of the district were in excess of the local demand.

Coast rice varied from Rs. 3 to Rs. 7 per bushel; paddy varied from Rs. 2 to Rs. 2.50 per bushel; fine grain varied from Rs. 2 to Rs. 2.50 per bushel; coconuts, Rs. 25 to Rs. 40 per 1,000.

The weather was generally dry during the month.

Harvest prospects were good, but some damage was caused by wild animals to the crop in the interior of Talpe pattu.

The health of the people was on the whole satisfactory.

PROVINCE OF SABARAGAMUWA.

KEGALA DISTRICT.

Paddy: maha fields have been harvested; the yield is very satisfactory.

Dry grain: hill paddy, iringu, and amu have been reaped; the yield is good.

Prices: paddy, Re. 1.50 to Rs. 2 per bushel; hill paddy, Re. 1.50 per bushel; kurakkan, Re. 1 per bushel; amu, 75 cents per bushel.

Health of people: fever and chickenpox are prevailing in some parts of the district.

Health of cattle: satisfactory.
