NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 15th day of September, 1903, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Acting Government Agent of the North-Western Province at the Kurunegala Kachcheri and make claim to the said lands or any of them or to some interest therein :

Such Acting Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, as amended by Ordinances Nos. 1 of 1899 and 5 of 1900, will declare by writing under his hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.


