PROCLAMATIONS BY THE GOVERNOR.

In the Name of His Majesty GEORGE THE FIFTH, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, King, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir JOHN ANDERSON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

JOHN ANDERSON.

WHEREAS it is by section 35 (1) of "The Volunteer Ordinance, 1910," as amended by "The Volunteer (Amendment) Ordinance, No. 42 of 1916," provided that within one month of such date as shall be fixed by the Governor by Proclamation in that behalf it shall be obligatory on every European of the male sex resident in the Colony who is a British subject, and is between the ages of eighteen and fifty and is not a Volunteer—

- (a) If he has attained the age of 18 and has not yet attained the age of 41, to enroll himself in a Volunteer Corps formed under this Ordinance. Provided that for the purposes of this paragraph a Volunteer Corps shall not be deemed to include a Town Guard other than the Colombo Town Guard:
- (b) If he has attained the age of 41 and has not yet attained that of 50, to enroll himself in a Town Guard which shall have been constituted a Volunteer Corps under this Ordinance, or as a member of the reserve of any Volunteer Corps:

Now know Ye that We, the Governor, do by this Our Proclamation fix April 30, 1917, as the date from which the said period of one month shall begin to run.

Given at Nuwara Eliya, in the said Island of Ceylon, this Twentieth day of April, in the year of our Lord One thousand Nine hundred and Seventeen.

" THE VOLUNTEER ORDINANCE, 1910."

IT is hereby notified that His Excellency the Governor in Executive Council has, under section 40 (a) of "The Volunteer Ordinance, 1910," as amended by "The Volunteer (Amendment) Ordinance, No. 42 of 1916," been pleased to make the following rules for regulating the procedure to be followed by the Committees* who have been appointed under section 38, and the exercise of their powers under that section.

RULES.

1. Within one week from the date fixed in the Proclamation under section 35 of "The Volunteer Ordinance, 1910," as amended by "The Volunteer (Amendment) Ordinance, No. 42 of 1916," and published in *Government Gazette* No. 6,867 of this date, or in the case of persons to whom Part IV. of the Ordinance shall become applicable subsequently to that date within one week of the date on which it becomes applicable, any person who desires to claim exemption must forward his claim in writing to the Chairman of the Local Committee. If he claims exemption on the ground of ill-health or infirmity, he must forward a certificate by a registered medical practitioner in support of his claim.
2. Where the claim is based on the ground (a) of ill-health or infirmity, or (b) of the applicant being a minister of religion, the Chairman may forward the claim to the other members of the Committee, and if they agree that exemption should be granted, he may at once grant a certificate of exemption under his hand.
3. Where the claim is not dealt with under rule 2, the Chairman shall summon the claimant to appear before the Committee, and if the Committee or the majority of it considers that the claim should be allowed, he shall grant a certificate of exemption under his hand.
4. The grant of every certificate of exemption shall be reported without delay to the Colonial Secretary by the Chairman granting the same.
5. That a person is a minister of any religion shall entitle him to exemption, but no exemption shall be granted, without previous reference to the Governor in Executive Council, on the ground that the place of residence of the person claiming exemption renders compliance with the provisions of Part IV. of the Ordinance impracticable.

" THE VOLUNTEER ORDINANCE, 1910."

IT is hereby notified for general information that His Excellency the Governor has prescribed that the time within which any person aggrieved may, under section 38 (2) of "The Volunteer Ordinance, 1910," as amended by "The Volunteer (Amendment) Ordinance, No. 42 of 1916," appeal to the Governor in Executive Council against the order of any Committee appointed under section 38 (1) of the said Ordinance refusing him exemption from obligatory enlistment shall be fourteen days, and that such appeal shall be by petition posted within fourteen days of the date of the communication to him of such order.

" THE VOLUNTEER ORDINANCE, 1910."

THE following regulations made by the General Officer Commanding the Troops under section 36 (1) of "The Volunteer Ordinance, 1910," as amended by "The Volunteer (Amendment) Ordinance, No. 42 of 1916," and approved by His Excellency the Governor, after consultation with the Commandant, are hereby published for general information.

REGULATIONS.

1. Every recruit between the ages of 18 and 41 when posted to a unit shall undergo a course of training for twenty-eight consecutive days in the first year of his joining, when called upon to do so. After completion of such course he shall attend at the rate of two parades a month.
2. Every efficient Volunteer between the ages of 18 and 41, except those serving with the Town Guard Artillery or Ceylon Engineer Volunteers, shall undergo a course of training for twenty-eight days in a camp of exercise in each year of his service. Such training shall be divided into two periods during the year of fourteen days' duration for each period. In addition to the above, he shall attend at the rate of two drills a month for the period during which he is not in a camp of exercise.
3. A Volunteer over the age of 41 and not over 50 shall attend at the rate of two parades a month, and shall further attend, where and when ordered, to carry out a modified course of musketry in each year of his service.
4. Every efficient Volunteer between the ages of 18 and 41 belonging to the Town Guard Artillery shall undergo twenty-eight days' training in Colombo, divided into two periods of fourteen days' duration during each year of his service, under the orders of the Officer Commanding Royal Artillery. In addition to the above, he shall attend at the rate of two drills a month.
5. Every efficient Volunteer belonging to the Ceylon Engineer Volunteers shall undergo twenty-eight days' training, divided into two periods of fourteen days' duration during each year of his service, under the orders of the Commanding Royal Engineer. Such training shall take place as follows:—Fourteen days in Colombo; fourteen days in a camp of exercise other than Colombo. In addition to above, he shall attend at the rate of two drills a month during such periods as he is not in a camp of exercise.

IT is hereby notified for general information that His Excellency the Governor has prescribed that the time within which a person enrolled as a Volunteer who has been transferred to any other Volunteer Corps or company by order of the General Officer Commanding the Troops under section 35 (2) of "The Volunteer Ordinance, 1910," as amended by "The Volunteer (Amendment) Ordinance, No. 42 of 1916," may, under the proviso to the said section, appeal to the Governor in Executive Council shall be fourteen days, and that such appeal shall be lodged within fourteen days of the date on which the order of transfer is published.

WHEREAS in pursuance of the said "The Trading with the Enemy (Amendment No. 2) Ordinance, No. 13 of 1916," We did by Our Proclamation, published in the *Government Gazette* of August 25, 1916, publish the Royal Proclamations and Orders of the Lords in Council issued under "The Trading with the Enemy (Extension of Powers) Act, 1915":

And whereas by Our Proclamations, published in the *Government Gazettes* of September 8, 15, and 29, October 20, November 10, and December 8, 1916, and January 12 and 26, February 16, and March 16 and 23, 1917, We did publish subsequent Orders of the Lords in Council:

And whereas the Lords in Council have issued a further Order dated February 16, 1917:

Know Ye that We, the Governor of Ceylon, in pursuance of "The Trading with the Enemy (Amendment No. 2) Ordinance, No. 13 of 1916," aforesaid, do hereby publish for general information the aforesaid Order in Council dated February 16, 1917, appearing in the schedule hereto.

SCHEDULE.

Trading with the Enemy (Neutral Countries) Order (No. 27), 1916.

At the Council Chamber, Whitehall, February 16, 1917.

By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by section 1, sub-section 1, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated May 23, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom, from trading with any of the persons or bodies of persons mentioned in the list contained in the last mentioned Proclamation:

And whereas by section 1, sub-section 2, of the said Act, it is provided that any list of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such list as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List":

And whereas the list contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further amended by the variation and addition of the names set forth in the schedule hereto:

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having any dealings with any of the persons or firms mentioned in this list, or in any list issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3. A list (the Consolidating List No. 19a) consolidating all previous lists revised to date and including the amendments in the schedule annexed hereto is issued concurrently with this Order. This Consolidating List contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these lists will be published at intervals approximately of two weeks.

The lists are published in the *London Gazette* and reproduced in the Board of Trade Journal, and separate copies of all lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

NOTE (2).—Where a person or firm mentioned in the list has more than one address in the same country, all dealings in that country with such person or firm are prohibited, even in cases where one only of the addresses is specifically mentioned.

NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of June 25 and November 10, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (4).—In order to minimize as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph, he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the list. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the list as they appear. GEORGE R.I.

WHEREAS by section 43 of the Customs Consolidation Act, 1876, it is provided that the importation of arms, ammunition, gunpowder, or any other goods may be prohibited by Proclamation:

And whereas by various Proclamations entitled Prohibition of Import Proclamations the importation of certain goods has been prohibited accordingly:

And whereas it is expedient that the importation into the United Kingdom of certain other goods should be prohibited, and the existing prohibition imposed on the importation of certain goods removed:

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct, and ordain as follows:—

(1) As from and after the date hereof, subject as hereinafter provided, the importation into the United Kingdom of the following goods is hereby prohibited, viz:—

Provided always, and it is hereby declared, that this prohibition shall not apply to any such goods which are imported under license given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such license.

(2) As from and after the date hereof the prohibition imposed by the Prohibition of Import (Paper, Tobacco, Furniture Woods, and Stones) Proclamation, 1916, on the importation of the following goods shall be removed, and the said Proclamation amended accordingly, viz. :—

All periodical publications exceeding 16 pages in length imported otherwise than in single copies through the post.

This Proclamation may be cited as the Prohibition of Import (No. 14) Proclamation, 1917.

THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEREAS by an Order in Council dated the 11th day of March, 1915, His Majesty was pleased to direct certain measures to be taken against the commerce of the enemy :

And whereas the German Government has now issued a memorandum declaring that from the 1st February, 1917, all sea traffic will be prevented in certain zones therein described adjacent to Great Britain and France and Italy, and that neutral ships will navigate the said zones at their own risk :

And whereas similar directions have been given by other enemy Powers :

And whereas the orders embodied in the said memorandum are in flagrant contradiction with the rules of international law, the dictates of humanity, and the treaty obligations of the enemy :

And whereas such proceedings on the part of the enemy render it necessary for His Majesty to adopt further measures in order to maintain the efficiency of those previously taken to prevent commodities of any kind from reaching or leaving the enemy countries, and for this purpose to subject to capture and condemnation vessels carrying goods with an enemy destination or of enemy origin unless they afford unto the forces of His Majesty and His Allies ample opportunities of examining their cargoes, and also to subject such goods to condemnation :

His Majesty is therefore pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following directions shall be observed in respect of all vessels which sail from their port of departure after the date of this Order :—

1. A vessel which is encountered at sea on her way to or from a port in any neutral country affording means of access to the enemy territory without calling at a port in British or Allied territory shall, until the contrary is established, be deemed to be carrying goods with an enemy destination, or of enemy origin, and shall be brought in for examination, and, if necessary, for adjudication before the Prize Court.

2. Any vessel carrying goods with an enemy destination, or of enemy origin, shall be liable to capture and condemnation in respect of the carriage of such goods ; provided that, in the case of any vessel which calls at an appointed British or Allied port for the examination of her cargo, no sentence of condemnation shall be pronounced in respect only of the carriage of goods of enemy origin or destination, and no such presumption as is laid down in Article 1 shall arise.

3. Goods which are found on the examination of any vessel to be goods of enemy origin or of enemy destination shall be liable to condemnation.

4. Nothing in this Order shall be deemed to affect the liability of any vessel or goods to capture or condemnation independently of this Order.

5. This Order is supplemental to the Orders in Council of the 11th day of March, 1915, and the 10th day of January, 1917, for restricting the commerce of the enemy.

Present :

THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEREAS by section 670 of the Merchant Shipping Act, 1894, it is enacted that when any lighthouse, buoy, or beacon has either before or after passing of that Act been erected or placed on or near the coast of any British Possession by or with the consent of the Legislature of that Possession, His Majesty may, by Order in Council, fix such dues (in that Act referred to as Colonial Light Dues) to be paid in respect of that lighthouse, buoy, or beacon by the owner or master of every ship which passes the same and derives benefit therefrom as His Majesty may deem reasonable, and may by like Order increase, diminish, or repeal such dues, and those dues shall from the time mentioned in the Order be leviable throughout His Majesty's Dominions, and further that Colonial Light Dues shall not be levied in any British Possession unless the Legislature of that Possession has, by address to the Crown or by Act or Ordinance duly passed, signified its opinion that the dues ought to be levied :

And whereas the Great Basses Lighthouse, the Little Basses Lighthouse, and the Minicoy Lighthouse are lighthouses which have been duly erected under and pursuant to the said section :

And whereas by Orders in Council dated respectively the 22nd day of May, 1883, the 9th day of May, 1892, the 29th day of June, 1896, and the 10th day of August, 1903, the dues leviable in respect of the said lighthouses for the classes of ships therein respectively mentioned were duly fixed :

And whereas by Order in Council dated the 21st day of October, 1912, His Majesty directed that, as from the 1st day of April, 1913, or from the time of the receipt of notice of that Order, if that be later, by the officers authorized to collect light dues, the dues thenceforth to be levied should be as follows, that is to say, in respect of the Great Basses Lighthouse and the Little Basses Lighthouse three-sixteenths of one penny per ton, and in respect of the Minicoy Lighthouse one-sixteenth of one penny per ton, of the burden of every ship on every voyage in which she passes or derives benefit from the said lights respectively, subject in each case to a reduction of 25 per cent. :

And whereas it has been made to appear to His Majesty that the said dues should be altered in manner hereinafter appearing :

Now, therefore, His Majesty, in exercise of the powers so vested in Him by the above-recited provisions, and by and with the advice of His Privy Council, doth by this Order in Council order, and it is hereby ordered, that, as from the 1st day of April, 1917, or from the time of the receipt of this Order, if that be later, by the officers authorized to collect light dues, the dues thenceforth to be levied shall be as follows, that is to say, in respect of the Great Basses Lighthouse and the Little Basses Lighthouse three-eighths of one penny per ton, and in respect of the Minicoy Lighthouse one-eighth of one penny per ton, of the burden of every ship on every voyage in which she passes or derives benefit from the said lights respectively.

BY-LAW REFERRED TO.

Fee for Removal of Night Soil.—Every person employing a Local Board Officer for the removal of night soil shall pay to the Board such sum as shall be determined by the Chairman not exceeding Rs. 2 per mensem for each bucket in which such night soil is deposited on his premises for removal by such officer. Such sum shall be paid to the Secretary of the Local Board on or before the 10th day of the month immediately following that for which the same is due.

IT is hereby notified that the Government have decided to entertain the application of Charles Seneviratna of Hiniduma and Pedu uhewa Janis de Silva of Batapola for a grant of lots Nos. 54 and 56K1 in final village plan No. 488, in extent 0A. 1R. 30P. and 23A. 0R. 28P. respectively, on exceptional terms, as provided for in paragraph 38 of the rules and regulations concerning land sales, on the following grounds:—

The lots were purchased by the applicants at a Government auction sale on April 4, 1910. The sale was subsequently cancelled with the consent of the purchasers, as it was proposed to constitute the lots a portion of a reserved forest. This intention having been abandoned, the lots are available for sale, and will be transferred to the applicants, who have re-deposited the original purchase amount (which had been refunded to them) and the assessed value of timber and mining rights. The land is required to plant tea and rubber.

SINHALESE CLASS (MEN).

CANDIDATES for the Training College Vernacular Scholarships are informed that these Scholarships will be awarded in order of merit, subject to the following conditions:—

- (a) The candidate must satisfy the Principal, Training College, that he is in every way suited for special training at the Training College.
- (b) The candidate must be physically fit to serve in any part of the Island, and must suffer from no physical defect.
- (c) The candidate must be prepared to serve in the district to which he may be appointed.

As regards (c), candidates must write *at the top of the application form* the names of the districts in which they are prepared to serve in order of preference; if they have no choice, and are prepared to serve in any part of the Island, they should write *in any district*; if they have a preference for any one district, *e.g.*, Colombo, but are prepared to go to any part of the Island, they should write *Colombo* (or the name of the district preferred) *and any other district*; if they wish only to be considered for certain districts, they should write the names of these districts in order of preference, *e.g.*, Colombo, Ratnapura, Kandy, &c.

Candidates are notified that their choices of districts will receive consideration in their order of merit, but that a candidate who is only prepared to go to one district, should all the vacancies in that district have already been allotted to others above him in the list, will *not* be eligible for a scholarship which will be awarded to the next candidate in the list who is prepared to take a post *in the district* in which there is a vacancy. A candidate's selection of districts will be regarded as final, and he will be required to sign a bond to serve in that district to which he is allotted.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended April 7, 1917.

Births.—The total births registered in the city of Colombo in the week were 101 (6 Burghers, 69 Sinhalese, 7 Tamils, 14 Moors, 4 Malays, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1917, viz., 263,629) was 20·0, as against 20·6 in the preceding week, 18·4 in the corresponding week of last year, and 21·6 the weekly average for last year.

Deaths.—The total deaths registered were 135 (2 Europeans, 9 Burghers, 66 Sinhalese, 26 Tamils, 23 Moors, 6 Malays, and 3 Others). The death-rate per 1,000 per annum was 26·7, as against 22·2 in the previous week, 24·8 in the corresponding week of last year, and 27·1 the weekly average for last year.

Infantile Deaths.—Of the 135 total deaths, 32 were of infants under one year of age, as against 35 in the preceding week, 24 in the corresponding week of the previous year, and 25 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 9.

Principal Causes of Death.—Seventeen deaths from *Pneumonia* were registered, as against 11 in the previous week and 15 the weekly average for last year. Of these, 4 were in Kotahena, 4 in Maradana (including 2 deaths of non-residents in hospitals), 4 in Wellawatta, 2 in St. Paul's, 1 in Pettah, 1 in New Bazaar, and 1 in Kollupitiya. Two deaths from *Bronchitis* were registered.

2. Sixteen deaths from *Phthisis* were registered, as against 3 in the previous week and 16 the weekly average for last year. Of these, 5 were in St. Paul's, 5 in Maradana (including 2 deaths of non-residents in hospitals), 4 in Kotahena, 1 in New Bazaar, and 1 in Kollupitiya.

3. Four deaths from *Enteric Fever* were registered, as against 3 in the previous week and 3 the weekly average for last year. Of these, 2 were in Kotahena, 1 in Maradana (of a non-resident in hospital), and 1 in Wellawatta.

4. Two deaths from *Plague* were registered, as against 4 in the previous week and 4 the weekly average for last year. Of these, 1 was in St. Paul's and the other in New Bazaar. Two cases were reported, as against 10 in the previous week.

5. One death from *Measles* was registered in Kotahena, as in the previous week. Fifteen cases were reported, as against 30 in the previous week.

6. No deaths from *Chickenpox* were registered. One death was registered in the previous week. Thirty-one cases were reported, as against 58 in the previous week.

7. Thirteen deaths from *Debility* were registered, 8 from *Infantile Convulsions*, 7 from *Enteritis*, 4 from *Worms*, 3 from *Diarrhoea*, 3 from *Dysentery*, 1 from *Tetanus*, and 54 from *Other Causes*.

State of the Weather.—The mean temperature of air was 81·6°, against 79·9° in the preceding week and 81·8° in the corresponding week of the previous year. The mean atmospheric pressure was 29·868 in., against 29·940 in. in the preceding week and 29·839 in. in the corresponding week of the previous year. The total rainfall in the week was 1·77 in., against 5·92 in. in the preceding week and 2·64 in. in the corresponding week of the previous year.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended April 14, 1917.

Births.—The total births registered in the city of Colombo in the week were 112 (1 European, 10 Burghers, 62 Sinhalese, 11 Tamils, 18 Moors, 6 Malays, and 4 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1917, viz., 263,629) was 22·2, as against 20·0 in the preceding week, 14·5 in the corresponding week of last year, and 21·6 the weekly average for last year.

Deaths.—The total deaths registered were 143 (1 European, 4 Burghers, 68 Sinhalese, 32 Tamils, 23 Moors, 7 Malays, and 8 Others). The death-rate per 1,000 per annum was 28·3, as against 26·7 in the previous week, 22·9 in the corresponding week of last year, and 27·1 the weekly average for last year.

Infantile Deaths.—Of the 143 total deaths, 30 were of infants under one year of age, as against 32 in the preceding week, 24 in the corresponding week of the previous year, and 25 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 7.

Principal Causes of Death.—Twenty deaths from *Pneumonia* were registered, as against 17 in the previous week, and 15 the weekly average for last year. Of these, 6 were in Kotahena, 6 in Maradana (including 2 deaths of non-residents in hospitals), 3 in Kollupitiya, 2 in Slave Island, 2 in Wellawatta, and 1 in New Bazaar. Four deaths from *Bronchitis* were registered.

2. Nineteen deaths were registered, as due to *Plague* and probably *Plague*, against 2 in the previous week and 4 the weekly average for last year. Of these, 7 were in Kotahena, 3 in St. Paul's, 3 in New Bazaar, 3 in Maradana, (including 1 death of a non-resident in hospital), 1 in Pettah, 1 in San Sebastian, and 1 in Slave Island. Nineteen cases were reported, as against 2 in the previous week.

3. Fourteen deaths from *Phthisis* were registered, as against 16 in the previous week and 16 the weekly average for last year. Of these, 4 were in Kotahena, 3 in St. Paul's, 3 in Maradana (including 1 death of a non-resident in hospital), 1 in Fort and Galle Face, 1 in Slave Island, 1 in Kollupitiya, and 1 in Wellawatta.

4. Two deaths from *Enteric Fever* were registered, as against 4 in the previous week and 3 the weekly average for last year. Of these, 1 was in Kotahena, and the other in New Bazaar.

5. One death from *Measles* was registered (in Kollupitiya), same as in the previous week. Twenty-three cases were reported, as against 15 in the previous week.

6. Eleven deaths from *Debility* were registered, 8 from *Enteritis*, 7 from *Infantile Convulsions*, 3 from *Diarrhoea*, 2 from *Worms*, 1 from *Dysentery*, 1 from *Tetanus*, and 50 from *Other Causes*.

7. There were reported 55 cases of *Chickenpox*, as against 31 in the previous week.

State of the Weather.—The mean temperature of air was 81·8°, against 81·6° in the preceding week and 82·7° in the corresponding week of the previous year. The mean atmospheric pressure was 29·854 in., against 29·868 in. in the preceding week and 29·810 in. in the corresponding week of the previous year. The total rainfall in the week was 0·15 in., against 1·77 in. in the preceding week, and 1·61 in. in the corresponding week of the previous year.
