HEREAS a building has been erected by the Local Board of Moratuwa on the land called Pairugahawatta at Digarolla, within the Local Board limits of Moratuwa, in the District of Colombo of the Western Province, for the purposes of a public slaughter-house, and such building has been certified to the Governor by the "proper authority," to wit, the Chairman of the Local Board of Moratuwa, as sufficient for the said purposes:

Now know Ye that We, the Governor, in exercise of the powers vested in Us by section 22 of "The Butchers Ordinance, 1893," do hereby declare and proclaim the said building to be a public slaughter-house as from and after the date hereof.

Trading with the Enemy (Neutral Countries) Order (No. 32).

At the Council Chamber, Whitehall, April 13, 1917.

By the Lords of His Majesty's Most Honourable Privy Council.

Whereas His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by section 1, sub-section 1, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated May 23, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom, from trading with any of the persons or bodies of persons mentioned in the list contained in the last-mentioned Proclamation:

And whereas by section 1, sub-section 2, of the said Act, it is provided that any list of persons and bodies of persons incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied, or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such list as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List.":

And whereas the list contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further amended by the variation and addition of the names set forth in the schedule hereto:

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having any dealings with any of the persons or firms mentioned in this list, or in any list issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3. A list (the Consolidating List No. 24A) consolidating all previous lists revised to date, and including the amendments in the schedule annexed hereto, is issued concurrently with this Order. This Consolidating List contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these lists will be published at intervals approximately of two weeks.

The lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2). -Where a person or firm mentioned in the list has more than one address in the same country, all dealings in that country with such person or firm are prohibited, even in cases where one only of the addresses is specifically mentioned.

*Note (3).—Trading is prohibited under the Trading with the Enemy Proclamations of June 25 and November 10, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (4).—In order to minimize as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph, he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required.

Note (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative, in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the list. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the list as they appear. The list for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H. M. "THE TOWN SCHOOLS ORDINANCE, 1906."

T is hereby notified that the following by-laws made by the Local Board of Kurunegala, in exercise of the powers vested in it by sub-sections (1) of sections 7 and 8 of Ordinance No. 5 of 1906, have been confirmed by His Excellency the Governor, with the advice of the Executive Council.

By His Excellency's command,

By-laws made under Sections 7 and 8 of "The Town Schools Ordinance, 1906," for the Area described in the Schedule hereto by the Local Board of Kurunegala.

1. Definitions.—In these by-laws—

The terms "boy," "girl," and "child" mean respectively a boy, or a girl, or a child residing in the area described in the Schedule A hereto.

The term "parent" includes a guardian and any person who has the actual custody of the child.

The term "Code" means the Code for Aided Schools for the time being sanctioned by His Excellency the Governor in Executive Council.

The term "attendance" means an attendance for the period defined by the Code as constituting a full attendance recorded in an attendance register in the manner prescribed by the Code.

The term "local authority" means the Local Board of Kurunegala.

The term "school" means a school specified in the Schedule B hereto.

The terms "adequate and suitable provision for the education of a child" and "reasonable excuse" shall bear the meaning defined in section 8, sub-section (1) (b), of "The Town Schools Ordinance, 1906."

The term "Inspector of Schools" means an Inspector of Schools appointed by His Excellency the Governor.

- 2. Children to attend school.—The parent of every boy of not less than 6 nor more than 12 years of age, and the parent of every girl of not less than 6 nor more than 12 years of age, or, in the case of Muhammadan and Tamil girls, the parent of every girl of not less than 6 nor more than 10 years of age, shall cause such boy or girl to attend one of the schools specified in Schedule B, unless he has made other adequate and suitable provision for the education of such boy or girl, or unless there is a reasonable excuse for non-attendance.
- 3. Time of attendance.—The time during which every boy or girl shall attend school shall be the whole time for which the school shall be open for the instruction of children of similar age.
 - 4. Religion.—Provided always that nothing in these by-laws—
 - (a) Shall prevent the presence of children being excused during the hours when religious instruction is given, as provided by section 9, sub-section (2) (d), of "The Town Schools Ordinance, 1906."
 - (b) Shall require any child to attend school on any day exclusively set apart for religious observance by the religious body to which its parents belong.
- 5. And provided always that when a child between 10 and 12 years of age, being beneficially employed to the satisfaction of the Police Magistrate of Kurunegala, has received a certificate from an Inspector of Schools that it has passed in Reading, Writing, and Arithmetic, the Fourth Standard prescribed by the Code for the time being, it shall not be required to attend school.
- 6. Penalties for offences.—Every parent who shall not observe, or shall neglect or violate, these by-laws or any of them shall upon conviction be liable to a penalty not exceeding Rs. 20 for each offence, and an additional fine not exceeding Rs. 10 per day in the case of a continuing offence.

Note.—The following are the portions of the Town Schools Ordinance referred to in sections 1 and 4 of these by-laws:—

Section 8, sub-section (1) (b).—A parent shall be deemed to have made adequate and suitable provision for the education of his child, if he proves that his child is in regular attendance at a school registered by the Director of Public Instruction for the receipt of a grant in aid, or at a school with regard to which an application for a grant in aid is under consideration, or at a school certified by the Director of Public Instruction to provide adequate and suitable instruction; or if he proves that he has made such other provision for his child's education as the Director of Public Instruction shall certify to be adequate and suitable, or if he produces a certificate from the Director of Public Instruction recommending that the child shall be exempted from compulsory attendance. Provided that no parent shall be convicted for not causing his child to attend such school, if he proves to the satisfaction of the Magistrate that he has reasonable excuse for not causing such child to attend. A parent shall be deemed to have a reasonable excuse for not causing his child to attend school, if he proves that the child is prevented from attending by sickness or other unavoidable cause.

Section 9, sub-section (2).—No school in which religious instruction is given shall be named in any by-law made under clause (a) of the last preceding section as a school

in which efficient provision is made for vernacular education, unless the local authority is satisfied—

- (a) That religious instruction is given only during the times specified in the school time table;
- (b) That religious instruction is not given to pupils of other denominations than that to which the school belongs if the parents object;
- (c) That pupils who do not attend religious instruction are employed in other studies during the hours allotted to religious instruction.
- (d) That such pupils if their parents object to their being present in the room where religious instruction is given are either allowed to study in some other part of the school premises during the hours when such instructions is given, or their presence in the school during such hours is excused; and
- (e) That a copy of sub-section (2) of this section in the English, Sinhalese, and Tamil languages is conspicuously posted up in the school.

Schedule A.

On the west by a line drawn from a point on the Puttalam road and 2 chains on the north-west of its junction with the Circular road, parallel with the Circular road and at a distance of 2 chains from it up to the Wilgoda-ela, thence directly to a point on the Negombo road 2 chains to the west of its junction with the old Negombo road, otherwise called the Malkaduwawa circular, and thence to a point 2 chains due south of the Negombo road; on the south by a line drawn from the southern end of the western boundary parallel with the said old Negombo road or Malkaduwawa circular, and 2 chains distance from it as for as the Colombo road, thence straight to a point 6 chains south of the $1\frac{1}{2}$ milepost on the Kandy road, and from this point to the ela; on the east along this ela to a point where the ela crosses the Kandy road, and from a line drawn from this point to the $1\frac{1}{2}$ milepost on the Dambulla road, and thence to a point $\frac{1}{2}$ mile due north; on the north by a line drawn from the northern extremity of the eastern boundary to the northernmost point of the western boundary.

SIR,—I HAVE the honour to acknowledge the receipt of your circular despatch (a) of the 7th September, 1916, intimating that the Army Council have recently addressed a circular letter to all commands abroad in which they express their appreciation of the services rendered by local forces in localities in which no actual fighting with the enemy has taken place, and have requested that the names both of units and of individuals whose services have been such as to deserve special recognition should be submitted for consideration.

2. I enclose a copy of a letter, dated the 25th October, 1916, which I have received from the Brigadier-General Commanding the Troops with regard to the services rendered by local corps and individuals in Ceylon. I

concur in the views expressed by the Brigadier-General.

YOUR EXCELLENCY,—WITH reference to Your Excellency's letter of 18th October, 1916, and enclosure from the Secretary of State for the Colonies dated 7th September, 1916, and referring further to War Office letter 0137/2741 (M. O. 1) of the 31st July, 1916, directing me to submit the names of individuals and units of local forces whose services during the war have been such as to deserve special recognition, I have now the honour to submit to the War Office, through Your Excellency, the following report:-

Ceylon Artillery Volunteers; Ceylon Engineer Volunteers; Town Guard Artillery; Ceylon Volunteer Medical Corps.

All these units have been mobilized since the beginning of the war, though they attend to their civil employment between 9 A.M. and 5 P.M. The Ceylon Artillery Volunteers and Town Guard Artillery have been employed by reliefs in manning the various works, and have undergone strenuous training. They made efficient artillerymen and consequently allowed of many regular Royal Artillery proceeding home for duty.

The Ceylon Engineer Volunteers have nightly manned the defence lights under Royal Engineer supervision. For a year they maintained the running nightly all night, and have since then kept the lights ready for action at short notice. Their assistance has been very valuable. A section of this corps have also rendered themselves efficient

wireless telegraph operators, able in emergency to replace native employes at the local station.

The Ceylon Volunteer Medical Corps in August, 1914, opened a field hospital at Colombo, where they attended to the sick of the mobilized units of the Ceylon Volunteer Force; and since the departure for home of the Royal Army Medical Corps in January, 1916, they have found detachments for duty at the Military Hospital, where their work has been reported on as being useful and zealous.

2.—Individuals.

(i.) Lieutenant-Colonel E. J. Hayward, of the Ceylon Artillery Volunteers, has on many occasions acted as Fire Commander, and carried out the duties with zeal and efficiency. He is also Acting Commandant, Cevlon Volunteer Force, and in this capacity as well has done excellent work.

(ii.) Lieutenant-Colonel Hayward mentions Sergeant-Major (Sergeant, Royal Artillery) G. H. Stevens, attached to the Ceylon Artillery Volunteers, and Sergeant-Major E. Fulcher, 1st Middlesex Regiment, on the Ceylon Volunteer

Force Staff, as having performed energetic and meritorious services.

(iii.) Lieutenant B. R. Lewis, Ceylon Artillery Volunteers, has been attached to the Army Ordnance Department since February, 1915, and his services are reported as having been of great value. This officer, who is also a qualified signaller, is, in addition, frequently on night duty at the Fire Commander's post.

(iv.) Major T. H. Chapman—in civilian life Director of Public Works, Ceylon—originally raised and com-

mands the Ceylon Engineer Volunteers. He has been indefatigable in keeping up, by his own example, the keenness and efficiency of his men. As Director of Public Works he rendered valuable assistance on mobilization, in providing coolies for labour on local defence works and in encouraging engineers to join the corps. In this latter duty he has been ably assisted by Captain J. O. D. Ingram, and by Captain McCloskey, Chief Telegraph Engineer to the Post Office, who also superintended the instruction in wireless telegraphy.

(v.) Major D. Rockwood, M.R.C.S., Ceylon Volunteer Medical Corps, has been employed continuously at the

Military Hospital since January, 1916, and his services have been of much assistance.

- (vi.) Major A. E. Andrews, of the Hampshire Regiment, has been the only regular officer left on the staff of the Ceylon Volunteer Force. He has carried out in an eminently efficient manner the combined duties of Adjutant to the Ceylon Mounted Rifles, the Ceylon Planters' Rifle Corps, the Ceylon Light Infantry, and the local Town Guards. He has put all these corps through several training camps to my entire satisfaction.
- 2. It will be observed that I have interpreted the War Office letter under reply to refer only to the Volunteer Forces of the Island and those immediately connected with them. Owing to the reduction of the regular garrison, and the consequent extra work thrown on to those left here, I hope to be permitted later on to submit the names of some officers and men of His Majesty's Regular Forces, who have performed particularly useful work.

SIR,—I have the honour to acknowledge the receipt of your despatch No. 668 of 7th November, 1916, forwarding copy of a letter from the Brigadier-General Commanding the Troops in Ceylon with regard to those local military units, individual officers, and non-commissioned officers whose services to the Empire it is desired to bring to notice for recognition in connection with defence measures taken in Ceylon and the military situation arising out of the war.

2. All these recommendations were laid before the Army Council, who decided to make a special notification of the names of officers and others throughout the Empire deemed to be worthy of some recognition, although their services may not have been sufficient to merit the form of recognition known as a "mention in despatches," or other or higher reward, judged by the standard applied in cases where officers and soldiers have participated in actual military operations in the field.

3. The publication of names was made by a War Office notice through the Press Bureau on the 26th and 27th February, copy enclosed*; the officers and non-commissioned officers specified therein are granted the reward of an honourable entry in their record of service. I suggest that the list, as far as concerns Ceylon, should be published in the Official Gazette, together with your despatch of the 7th November and this reply, in which I gladly recognize the services of the units of the local forces.

4. You will also be good enough to cause a note to be made on the record of service of any Colonial Government Officials whose names were included in the recommendations put forward in this connection.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended June 16, 1917.

Births.—The total births registered in the city of Colombo in the week were 89 (1 European, 5 Burghers, 43 Sinhalese, 16 Tamils, 13 Moors, 7 Malays, and 4 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1917, viz., 263,629) was 17.6, as against 16.0 in the preceding week, 20.9 in the corresponding week of last year, and 21.6 the weekly average for last year.

Deaths.—The total deaths registered were 87 (2 Europeans, 6 Burghers, 40 Sinhalese, 23 Tamils, 11 Moors, and 5 Others). The death-rate per 1,000 per annum was 17.2, as against 19.4 in the previous week, 28.7 in the corresponding week of last year, and 27.1 the weekly average for last year.

Infantile Deaths.—Of the 87 total deaths, 17 were of infants under one year of age, as against 27 in the preceding week, 31 in the corresponding week of the previous year, and 25 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 7.

Principal Causes of Death.—Ten deaths from Pneumonia were registered, as in the previous week, against 15 the weekly average for last year. Of these, 3 were in Maradana (including 1 death of a non-resident in hospital), 2 in Kotahena, 2 in Wellawatta, 1 in Pettah, 1 in New Bazaar, and 1 in Kollupitiya. One death from Bronchitis was registered.

- 2. Seven deaths from *Phthisis* were registered, as against 15 in the previous week and 16 the weekly average for last year. Of these, 3 were in Maradana (including 2 deaths of non-residents in hospitals), 2 in St. Paul's, and 2 in Slave Island.
- 3. Five deaths from *Enteric Fever* were registered, as against 3 in the previous week and 3 the weekly average for last year. Of these, 2 were in St. Paul's, 2 in Maradana, and 1 in Pettah.
- 4. No death from *Plague* was registered during the week. There was I in the previous week. One case was reported, as in the previous week.
- 5. One death from Measles was registered in Slave Island, as in the previous week. Eight cases of Measles were reported, as against 20 in the previous week; and 4 cases of Chickenpox, as in the previous week.
- 6. Eight deaths from Debility were registered, 7 from Infantile Convulsions, 4 from Enteritis, 3 from Diarrhoea, and 41 from Other Causes.

State of the Weather.—The mean temperature of air was 80·3°, against 81·6° in the preceding week and 80·1° in the corresponding week of the previous year. The mean atmospheric pressure was 29·835 in., against 29·822 in. in the preceding week and 29·803 in. in the corresponding week of the previous year. The total rainfall in the week was 1·66 in., against 1·27 in. in the preceding week and 2·35 in. in the corresponding week of the previous year.
