Conditions of Lease.

- (a) That the land be leased for a term of 50 years at the upset price of Rs. 71 as premium subject to a rental of Rs. 2 per acre per annum.
 - (b) That the land shall be used for vegetable cultivation only.
 - (c) That no building shall be erected without the permission of the Government Agent.
- (d) That any building or buildings erected without the permission of the Government Agent shall be the property of the Crown.
- (e) That in the event of any building or buildings erected with the permission of the Government Agent, the lessee shall be allowed at the expiration of the lease to remove the materials of the buildings; the lessor has the option of retaining the buildings upon payment to the lessee of the estimated value of the materials of such buildings as at the expiration of the lease.
 - (f) No compensation will be paid for the plantations at the termination of the lease.

- (g) The rent will not be subject to re-assessment during the period of the lease.
- (h) That the lessee will not assign the lease or transfer any right or interest thereon, or subject the whole or any portion of the premises hereby demised without the previous consent in writing of the lessor.
 - (i) Government reserves to itself the right, without question, to reject the highest tender or bid.
