### SEASON REPORTS FOR THE MONTH OF MARCH, 1917.

#### SOUTHERN PROVINCE.

##### GALLE DISTRICT.

Cultivation for the yala has begun.

Dry grain is cultivated in the district only on a small scale.

Coconut, tea, cinnamon, rubber, and vegetables were the general products. The estimated coconut crop was over 12,063,886.

Coast rice varied from Rs. 3 to Rs. 7 per bushel; paddy varied from Rs. 2 to Rs. 2.50 per bushel; fine grain varied from Rs. 2 to Rs. 2.50 per bushel; coconut, Rs. 25 to Rs. 55 per 1,000.

The weather was wet during the latter part of the month.

The health of the people was on the whole satisfactory, but in some villages of Talpe pattu dysentery, chickenpox, and measles prevailed to a considerable extent.

##### HAMBANTOTA DISTRICT.
