### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Residential Purpose, Mr. Dematallalage Jayantha Munasinghe has requested on lease a state land containing in extent about 0.140 Hec. marked Lots 541 as depicted in the tracing No. F. C.
