NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 31st day of July, 1903, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, make claim in person or in writing to the said lands or any of them or to some interest therein to the Government Agent of the North-Central Province at the Anuradhapura Kuchcheri :

Such Government Agent, in pursuance of the powers in him vested by "The Waste Lands Ordinances, 1897, 1899, and 1900," will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.
