NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 14th day of August, 1903, the persons, if any, who claim any interest in the lands hereinafter mentioned, appear before the Assistant Government Agent of the Puttalam District and make claim to the said lands or to some interest therein :

Arsududuhami and another), Puliyankulama Kamatagava Pillawahena (Appuhami and another), Mahawewa <sup>2,193</sup> M 1,091; Kudawewa <sup>2,193</sup> M 1,091; Timbirigahawatta (Kapuruhami and others), and Kongahakotuwa (Sundarahami); on the west by Potuwila Puliyankulama Vihara and Kahatagahahena (Mudalihami, ex-Arachchi) <sup>2,316</sup> 10,879; on the south-west and south by Walpotukele Crown forest, Bogahamulahenyaya (Mudalihami Korale Arachchi and others), Walpotukele Crown jungle, Mini-kukula Ebbagawa, Atanduwakele (I. Appu Heratham and another), Kongahamulahena (Iampulle Appu), and Punchi mukalana Crown jungle; on the east by the Deduru-oya.


N.B. - Lot 11 appears in the tracing, and is omitted in the notice, being a paddy field.
