THE URBAN DEVELOPMENT PROJECTS (SPECIAL PROVISIONS) ACT, No. 2 OF 1980

Order under Section 2

Boundaries of Lot A and B depicted in sketch No. 0006/2016 dated 17.03.2016 prepared by Mrs. R. C. Liyanaarachchi, Land Officer (UDA) for the land in extent of 43 Hectares (106A., 00R., 34P.) situated in “Olaboduwawaththa”, “Nayagodawaththa” and “Minehenawaththa” in Koralaïma and Olaboduwa North Grama Niladhari Divisions within Horana Divisional Secretary’s Division in Kalutara District, Western Province
