**UVA PROVINCIAL COUNCIL (PAYMENTS OF SALARIES AND ALLOWANCES) AMENDED STATUTE
No. 02 OF 2016**

A Statute to provide for amending the Sub Section No. 2(a) and 2(b) of amended Statute, No. 09th of 2010 to make payments of Salaries and Allowances for the Chairman and members of the Public Service Commission of Uva Provincial Council.

Be it enacted by the Uva Provincial Council of the Democratic Socialist Republic of Sri Lanka as follows :

01. This amended Statute may be cited as the Uva Provincial Council Public Service Commission (Payments of Salaries and Allowances for the Chairman and the Members) amended Statute No. 02 of 2016 and shall come into operation on such day as approved by the Governor of Uva Province.

02. With effect from 1st January 2016

a. A sum of Rupees Thirty Five Thousand (Rs. 35,000/-) has to be paid to the Chairman of the Public Service Commission as a monthly Allowances,

Amended sub
section No. 2(b)

b. A sum of Rupees Twenty Thousand (Rs. 20,000/-) has to be paid to a Member of the Public Service Commission of the Uva Provincial Council as a monthly Allowances.

03. The Allowances paid for the Chairman and the Members of the Public Service Commission of the Uva Provincial Council and be a debit to the Provincial Council fund under this Statute.
