NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 11th day of September, 1903, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, make claim in person or in writing to the said lands or any of them or to some interest therein to the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Hill House, Mutwal, Colombo :

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.


