Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands here by declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.
