



A piece of land situated at Chenanvadi, in Tamblegam pattu, Trincomalee, being lot 8821, preliminary plan 711 (T. P. 103,574); bounded on the west by land said to belong to the Crown and tona, and on all other sides by tona; extent 3 acres 1 rood and 2 perches. This land was granted to Kader Meydin Sinnatampi in 1876.
