FINAL ORDERS.

Hambantota S. O. No. 1,416.

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Lands to be Crown Property.

In the matter of the lands commonly called or known as Ihalawewa (tank and bund), Pinwewa (tank and bund), &c., situate in the village of Nalagama, in the West Giruwa pattu of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."



Achchige Nonohamy, (4C) ditto Pincinahamy, (4D) ditto Selpinahamy, (4E) ditto Juwan Appu (minor), (4F) ditto Dionis (minor), (4G) ditto Cornelis Appu (minor), (4H) ditto Jane Nona (minor), and (4I) ditto Siyoris (minor) were substituted as claimants in their stead ; and whereas the said 1st claimant by an agreement dated the 6th day of October, 1916, the said 2B, 2C, 5th, 6th, 7th, and 8th claimants, and 2A claimant for horself and as duly appointed representative of the seid 2D claimant (minor) by an agreement dated the 25th day of September, 1916, the said 3A, 3B, 3E, 3H, 3I, 4C, and 4D claimants by an agreement dated the 26th day of September, 1916, the said 3F claimant as duly appointed representative of the said 3C, 3D, and 3J claimants (minors) by an agreement dated the 26th day of September, 1916, the said 4B claimant by an agreement dated the 2nd day of October, 1916, and the said 9th claimant by an agreement dated the 25th day of September, 1916, in consideration of the Settlement Officer settling as private property otherwise than under the Waster Lands Ordinances lots 101 I, 101N, 101 O, 101P, 101M, 101Q, 101R, 101S, 156, 138, 139, 136A, 135, 136F, 136, 140, 141. 141B, 141B1, 141B2, 134H, 134I, 159, 158, 158A, 153, 160A, 1604, 165, 162, 161, 160, 163H, 163 f, 163K, 164, 168A, 172, 173, 174, 163G, 181A, 180, 179, 181, 181B, 182, 185, 178, 177, 176, 175, 256, 256A, 257, 188, 187, 183, and 250, all of the block survey preliminary plan 290, withdrew their claims to the above-mentioned lots 186, 157, 101, 101E, 101F, 101J, 101K, 101L, 101U, 101U, 101H, and 137 of this order; and whereas the said 3F and 3G claimants and 4A claimant on behalf of herself and as duly appointed representative of the said 4E, 4F, 4G, 4H, and 41 claimants (minors) by an across ment dated the 25th day of September, 1916, in consideration of the Settlement Officer settling as private property otherwise than under the Waste Lands Ordinances lots 101G, 101 I, 101N, 101O, 101P, 101M, 101Q, 101R, 101S, 156, 92B, 92C, 138, 139, 136A, 135, 136F, 136, 140, 141, 141B, 141B1, 141B2, 134H, 134 f, 159, 158, 158A, 153, 160A, 1604, 165, 162, 161, 160, 163H, 163 I, 163K, 164, 168A, 172, 173, 174, 163G, 181A, 180, 179, 181, 181B, 182, 185, 178, 177, 176, 175, 256, 256A, 257, 188, 187, 183, and 250, all of the block survey preliminary plan 290, withdrew their claims to the above-mentioned lots 186, 157, 101, 101E, 101F, 101J, 101K, 101L, 101V, 101V, 101H, and 137 of this order; I.
