PROCLAMATION.

In the Name of His Majesty GEORGE THE FIFTH, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, King, Defender of the Faith.

PROCLAMATION.

By His Excellency REGINALD EDWARD STUBBS, Esquire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Officer Administering the Government of the Island of Ceylon, with the Dependencies thereof.

HEREAS in pursuance of the powers vested in Us by "The Necessaries of War Exportation Ordinance, No. 9 of 1914," We did by Our Proclamation given at Kandy on the Tenth day of November, 1917, and published in Government Gazette No. 6,908 of November 10, 1917, prohibit the exportation from Ceylon of any of the goods enumerated in the schedule thereto except under license of the Principal Collector of Customs:

And whereas by Our subsequent Proclamations published in the Government Gazette from time to time We

did amend the schedule to the aforesaid Proclamation of the Tenth day of November, 1917:

Now know Ye that We, the Officer Administering the Government of Ceylon, in pursuance of the powers vested in Us as aforesaid, do hereby further amend the schedule aforesaid by adding to the goods enumerated therein the goods set forth in the schedule hereto.

Given at Colombo, in the said Island of Ceylon, this Twenty-fourth day of June, in the year of our Lord One thousand Nine hundred and Eighteen. By His Excellency's command,

Apparel, wearing, made up, cotton, linen, flannel, tweed, and woollen. Manufactures, cotton, linen, flannel, tweed, and woollen. Thread, cotton and linen.

GOVERNMENT NOTIFICATION.

ORDINANCE No. 13 of 1896.

NHE following regulations made by His Excellency the Officer Administering the Government, with the advice

of the Executive Council, in pursuance of the powers in that behalf vested in him by the Ordinance No. 13 of 1896, intituled "An Ordinance relating to Pilgrimages," are hereby notified for general information:

1. No person presently residing in the island of Manuar shall proceed to Madu from and after the 23rd day of June and up to and inclusive of the 2nd day of July, 1918, without having previously obtained permission to do so under the hand of the Assistant Government Agent of Mannar.

2. The Assistant Government Agent of Mannar, and such persons as he may by writing under his hand appoint for that purpose, shall be the officers appointed to enforce the above regulation.
