DRAFT ORDINANCE.

MINUTE.

The following Draft of a proposed Ordinance is published for general information:-

An Ordinance further to amend " The Road Ordinance, 1861."

Preamble.

HEREAS it is expedient further to amend "The Road Ordinance, 1861": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Short title and commencement.

1 This Ordinance may be cited as "The Road (Amendment) Ordinance, No. of 1918," and shall come into operation on such date as the Governor shall, by Proclamation in the "Government Gazette," appoint.

Amendment of section 94 of principal Ordinance.

- In section 94 of the principal Ordinance—
- I.—For the clause beginning "(1) Whosoever shall turn or suffer to be turned loose" in line 4, and ending "unloading of any cart or boat to which it may belong" in line 11, there shall be substituted the following (1 A) The owner of any ox, horse, sheep, or goat found—

 - (a) Straying upon any thoroughfare;
 - (b) Tethered without lawful right upon any thoroughfare;
 - (c) So tethered that such animal can make its way into any thoroughfare;
 - shall be guilty of an offence, unless he prove-
 - (i.) That he kept such animal effectually enclosed or securely tethered elsewhere; and
 - (ii.) That the animal so strayed or was so tethered through the malicious act of some person, for whose acts the owner is not responsible.
 - (1 B) Whenever any such animal shall be found so straying or so tethered, and it is proved that such animal so strayed or was so tethered by reason of the malicious act of some person, for whose acts the owner of the animal is not responsible, such person shall be guilty of an offence.

(1 c) This section shall only apply to such thoroughfares and within such limits as shall be notified by the Governor

by Proclamation in that behalf.

(I D) Provided that an animal belonging to a cart and tethered in a public thoroughfare while such cart is being loaded or unloaded shall not be deemed to be tethered without lawful right within the meaning of this section.

II.—Immediately after the words "two shillings," wherever they occur, insert the words "or such other sum as the Governor in Executive Council, by notification in the 'Government Gazette,' may fix from time to time."

Statement of Objects and Reasons.

To obtain a conviction under section 94 (1) of the principal Ordinance as it now stands against a person, it is necessary to prove a definite act, namely, that he either turned or suffered to be turned loose on any road or canal any of the animals named therein, or tied or tethered any such animal so that it could or should make its way into any road or canal. As the straying of cattle and other like animals is a grave nuisance and hindrance to the public, and as in most cases it is extremely difficult or almost impossible to prove such a definite act, this Ordinance constitutes the mere fact of any such animal being found straying or tethered upon any thoroughfare, or so tethered that it could make its way into any thoroughfare, an offence for which the owner is liable, unless he exculpates himself by proof that the animal was found straying or was so tethered through the malicious act of some person, for whose acts the owner is not responsible. This Ordinance also provides that if the owner succeeds in exculpating himself, the person whose act led to the animal straying or being tethered is guilty of an offence.

2. It is also provided that the Governor in Executive Council may from time to time prescribe what remuneration should be paid for the seizure of animals straying upon thoroughfares, because it has been felt that the sum of "two shillings" fixed by the principal Ordinance is not adequate

remuneration in some districts.

WHEREAS it is expedient to repeal "The Anglo-Portuguese Commercial Treaty Ordinance, No. 15 of 1917," which has ceased to be necessary: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Date of coming into operation of Ordinance.

Repeal.

- 1 This Ordinance shall come into operation on the date of the passing thereof.
- 2 "The Anglo-Portuguese Commercial Treaty Ordinance, No. 15 of 1917," is hereby repealed.

No. 16 of 1918.

An Ordinance to amend the Law regulating the Punishment for Thefts of Prædial Products.

Presmble.

WHEREAS it is expedient to amend the law regulating the punishment for thefts of prædial products in this Colony: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Short title and commencement.

- 1 This Ordinance may be cited as "The Regulation of Whipping for Thefts of Prædial Products Ordinance, No. 16 of 1918," and shall come into operation on such date as the Governor shall, by Proclamation in the Government Gazette, appoint.
- 2 For section 368 of the Ceylon Penal Code, the following section shall be substituted:

Substitution of new section for section 368 of the Ceylon Penal Code.

368. Whoever commits theft—

(a) Of any bull, cow, steer, buffalo, heifer, or calf; or

(b) Of any fruit, vegetable, or other prædial production, or any cultivated root or plant used or capable of being used for the food of man or beast, or for medicine, distilling, or dyeing, or in the course of any manufacture,

may, in addition to any other punishment for theft, be punished with whipping.

Amendment of section 4 of Ordinance No. 4 of 1891.

- 8 In paragraph (c) of section 4 of Ordinance No. 4 of 1891, intituled "An Ordinance to empower Police Magistrates to inflict Whipping for Theft of Prædial Products"—
 - (a) For the word "lashes" substitute the word "strokes";(b) For the words "by sections 55 and 56 of the Ceylon Penal Code" substitute the words "for the carrying out of sentences of whipping."

Amendment of section 315 of "The following paragraph shall be added at the end and in continuation of section 315 of "The Criminal Procedure Code, 1898":

Provided that in the case of any sentences of whipping

Provided that in the case of any sentences of whipping inflicted under paragraph (b) of section 368 of the Ceylon Penal Code, such whipping shall be inflicted with a cane or rattan, or other like implement, and in such manner as the Governor shall at any time or from time to time direct.

Ordinance enacted by the Governor of Ceylon, with the advice and consent of the Legislative Council thereof.

No. 17 of 1918.

An Ordinance for making provision for the Contingent Services for the Financial Year October, 1918, to September, 1919.

Preamble.

WHEREAS the contingent expenditure required for the service of the Government of this Island for the financial year October, 1918, to September, 1919, and not otherwise provided for, has been estimated at the sum of Fifty-eight million Nine hundred and Fifty thousand Eight hundred and Ninety-two rupees: It is enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Rs. 58,960,892 to be charged upon the revenue of this Island for the Contingent Services for the financial year October, 1918, to September, 1919.

Amount of labour to be supplied under the Ordinance No. 31 of 1884.

- 1 A sum not exceeding Fifty-eight million Nine hundred and Fifty thousand Eight hundred and Ninety-two rupees shall be and the same is hereby charged upon the revenue and other funds of this Island for the Contingent Services for the financial year October, 1918, to September, 1919, and the said expenditure shall be in conformity with the Heads of Expenditure specified in the schedule hereunto annexed.
- 2 And whereas by the 31st section of the Ordinance No. 31 of the year 1884, entitled "An Ordinance to amend Ordinance No. 10 of 1861, entitled 'An Ordinance to consolidate and amend the Laws relating to Public Thoroughfares in this Colony," it is enacted that it shall be lawful for the Governor to propose the estimates prepared in pursuance thereof, or such of them as to him may appear expedient, in the Ordinance for making provision for the contingent expenditure of the Colony for the ensuing year, to be dealt with in like manner as any other estimate to be so proposed: And it is thereby also provided that the amount of labour to be supplied under the provisions of the said Ordinance No. 31 of 1884, for the performance of any work or works for which an estimate or estimates may have been so proposed by the Governor, and approved of by the Legislative Council, shall be distinctly stated in the Ordinance enacted for the same, and that the same shall not exceed two-thirds of the whole amount of labour due from the district or districts within which it may be required to be performed: It is enacted that the amount of labour to be supplied under the provisions of the said Ordinance shall be in conformity with the estimates detailed under Head No. 40, "Public Works Annually Recurrent."

Treasurer to pay the above at such times as the Governor by warrant shall order. 3 The Treasurer of the said Island shall issue and pay the said several sums to such persons, for the purposes hereinbefore mentioned, upon such days and in such proportions as the Governor for the time being, by any warrant or order in writing to be signed by him, shall from time to time order and direct; and the payments so to be made shall be charged upon and payable out of the revenues and other funds of the said Island.

And to receive credit to his accounts for the payments made in pursuance hereof. 4 The said Treasurer shall in his accounts from time to time be allowed credit for any sum or sums of money paid by him in pursuance of such warrant or order in writing as aforesaid; and the receipt or receipts of the respective persons to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said accounts for any such sum or sums as shall be herein mentioned; and he shall and may receive credit for the same accordingly.
