##### THE LAND ACQUISITION ACT (CHAPTER 460)

###### Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that servitude over the land, described in the following Paragraph No.1 is needed for a public purpose and will be acquired under the provisions of that Act. It describes in Paragraph No. 2, from which land that the servitude will be acquired.

1. **Description of the Servitude.**—Acquisition of servitude over the land, for laying of distribution lines, from Kotikapola intake well and pump house of Mawathagama water supply scheme.
