DRAFT ORDINANCE.

MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

An Ordinance to amend "The Births and Deaths Registration Ordinance, 1895."

Preamble.

WHEREAS it is expedient to amend "The Births and Deaths Registration Ordinance, 1895": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Short title.

1 This Ordinance may be cited as "The Births and Deaths Registration (Amendment) Ordinance, No. of 1918."

Insertion of new section 48 A.

2 After section 48 of the principal Ordinance the following section shall be added, and shall be numbered 48 A :

Removal of names of medical practitioners from register in certain cases.

48 A. (1) If any medical practitioner shall be convicted of any offence against sub-sections (3), (4), or (5) of the preceding section, or, if any medical practitioner acting as registrar under the provisions of this Ordinance, shall be found guilty of dishonestly aiding or abetting the registration of a false cause of death, it shall be the duty of the court before whom such medical practitioner has been convicted to report the same in writing to the Colonial Secretary, and the Colonial Secretary shall thereupon cause the name of such practitioner to be struck off the register of medical practitioners qualified to practise medicine and surgery in Ceylon.

(2) A medical practitioner shall during his employment as a medical registrar be deemed to be a "public servant" within the meaning of section 19 of the Ceylon Penal Code.

Statement of Objects and Reasons.

THE object of this Bill is to give effect to certain suggestions made by a Commission appointed to inquire into and report on the law relating to the registration of deaths.

2. Section 2 provides that any medical practitioner found guilty of an offence against sub-sections (3), (4), or (5) of section 48 of the principal Ordinance shall, as an inevitable consequence, have his name erased from the medical register, and that any medical registrar found guilty of dishonestly aiding or abetting the registration of a false cause of death shall have his name erased from the medical register. This section also provides that a medical practitioner during his employment as a medical registrar shall be deemed to be a public servant within the meaning of section 19 of the Ceylon Penal Code.

3. By section 3 Form I in Schedule II. to the principal Ordinance has been amended, so that a certificate as to the cause of death required by section 28 shall contain the period during which the patient was under treatment, and the name of the disease or disorder which was the probable cause of death. A medical practitioner is sometimes unable to certify as required by the existing form that he attended on the patient during his last illness and till the patient's death.
