- 4.1 Candidates possessing qualifications relevant to Technical Service Class II "B" Category (Grade III) will be recruited to the Technical Service Class II "B" Category (Grade III)
- 4.2 The post in Technical Service Class II "B" category Grade III is permanent and pensionable, and should contribute to the widows and Orphans Pentsion Fund/Widowers and Orphans Pension Fund.
- 4.3 The appointees to this post will be subject to a 03 years probation period.
