MINUTE BY THE GOVERNOR.

HIS EXCELLENCY THE GOVERNOR desires to express his deep regret at the loss which the Public Service has suffered by the untimely death, on November 15, 1918, of Mr. ARTHUR CHARLES ALLNUTT. Mr. Allnutt, who was within a few days of completing his 44th year, entered the Ceylon Civil Service by the examination of 1898, and served with credit to himself and satisfaction to the Government in a number of important offices. He was appointed to act as Excise Commissioner in April, 1914, and continued to discharge the duties of that post until December, 1917, acting for some months as Colonial Treasurer, in addition to his own duties.

In December, 1917, the introduction of the system of purchase of tea by the Ministry of Food necessitated the appointment of a local Tea Commissioner, and Mr. Allnutt was seconded for the purpose. The marked success with which he discharged the duties of a difficult and arduous post is well known to the Commercial Community of Ceylon.

By the death of Mr. Allnutt the Government of Ceylon has lost a trusted officer, who could be relied upon to discharge with zeal and ability any duties that were entrusted to him. His loss will be mourned, not only by his colleagues in the Public Service, but by a wide circle of friends, to whom his attractive personality and sterling character had endeared him.

WHEREAS in pursuance of section 13 of the Defence Force Ordinance, No. 8 of 1910, We did by Our Proclamations dated August 2, 1914, August 5, 1914, and December 31, 1914, published in the Government Gazettes of August 3, 1914, August 5, 1914, and January 5, 1915, call out for active service the following Corps of the Ceylon Defence Force, viz., the Ceylon Engineer Volunteers and the Ceylon Garrison Artillery (A and B Companies):
